



#### NORTH CAROLINA

#### THE McCUBBINS COLLECTION

To the uninitiated the McCubbins collection may appear unimposing and not likely to give him the answer he needs, unless, he supposes, he lived within throwing distance of the Rowan Public Library where the original manuscripts are housed.

The Rowan Public Library is located in Salisbury, North Carolina, where in 1956 the Genealogical Society of the Church of Jesus Christ of Latter-Day Saints filmed this collection. It is a large collection and is comprised of some 76 rolls of microfilm. Since collections such as this are not cataloged in detail, it is necessary to do a little exploring on your own to get the full use of the materials. Not every item in such a collection can be listed in the card catalog. As an example, there is no mention of some very good maps on Part 61. There is one map in particular that is entitled "Maps of German Settlers." On Part 76 there are a number of church records, histories, etc., and indexes to graveyards.

Although the originals are physically confined within the bounds of Rowan county, they contain information on people who lived in various places throughout the state of North Carolina with a small amount of information about persons who lived in other states.

The information was originally collected and compiled by Mrs. Mamie McCubbins. The collection is arranged for the most part by family surnames. This arrangement was effected under the direction of the Rowan Public Library.

Each grouping of materials by surname also contains data about other inter-married families. This situation is aided by the presence of a cross-reference guide. For example, a cross-reference entry may read, Reid - see Brown. No page numbers are given but at least it is known that the surname Reid is involved by inter-marriage among the records of Brown families.

Not only does this collection serve as a general finding aid, or surname index leading to various localities, but it also contains various church records, tombstone inscriptions and maps, court minutes, etc.

If you have North Carolina ancestry, it is recommended that this collection be explored. (If you do not have access to it, your Editor will be glad to search the microfilmed copy for you.)


- 1541 Hernando de Soto, of Spain, explores the Arkansas region. He was intrigued with hot springs.
- 1673 Father Jacques Marquette and Louis Joliet, of France, explore the Mississippi River as far south as the mouth of the Arkansas River.
- 1682 Mississippi Valley, including Arkansas, claimed by LaSalle for France.
- 1686 Henry de Tonti, a friend of LaSalle, establishes a camp at mouth of Arkansas River, which becomes the settlement of Arkansas Post (at the junction of Arkansas & Mississippi Rivers).
- 1763 The region is ceded to Spain by France. Spanish governors make land grants along west bank of Mississippi River, to U.S. Settlers.
- 1800 Spain returns the region to France.

  The Indians had almost full control until about this time.
- 1803 United States acquires Arkansas as part of the Louisiana Purchase.
- 1812 Creation of Missouri Territory, including Arkansas.
- 1817 Ft. Smith established. Trails passed westward there.
- 1819 The Arkansas Territory is formed from Missouri Territory.
- 1836 Arkansas becomes the 25th State (15 June), with Little Rock as capitol.
- 1837 Depression. Settlers came in from the East and North because of it.
- 1861 Arkansas secedes from the Union and joins Confederacy.
- 1862 Battle of Pea Ridge.
- 1863 Union troops capture Little Rock. The confederates establish a new state capitol at Washington. (During War there were two capitols.)
- 1864 A group of Arkansans form a Union government in Little Rock, drawing up a constitution abolishing slavery.
- 1868 Arkansas is readmitted to the Union. Reconstruction period. The people suffered many hardships.
- 1872 Opening of Arkansas Industrial University, now the University of Arkansas.
- 1874 Reconstruction ends. The state adopts its present constitution.
- 1878 Railroad came bringing with it many Austrian, German & Polish emigrants.
- 1888 Natural gas discovered at Ft. Smith.

When the first two volumes of the series, GENEALOGICAL RECORDS OF NORTHEAST ARKANSAS, covering the periods 1816-1830 and 1830-1838, were compiled, Lawrence County officials reported that the early will and probate records were lost. However, the record of wills and letters of administration, bound as PROBATE AND WILL 1817-1834, has since been located.

This volume contains abstracts of the records found in this volume. It has been entitled WILLS AND ADMINISTRATIONS OF LAWRENCE COUNTY, ARKANSAS, 1816-1817, because of the entry in the volume in 1819 of wills which had been proven in 1816, 1817, and 1818. Internal evidence indicates that the volume was originally designated PROBATE BOOK B. The early Settlement Record, containing copies of the settlements and inventories reported by administrators, has not been found.

A surname index is found at the back of the abstracts. Page numbers refer to pages in the original document, placed on the left hand side in the text. Entries are made in the name of the decedent, with his last name capitalized.
