Public Service Corporations, 1931 – one volume, not particularly useful for genealogy research.

Certified Claims Allowed by Board of Supervisors

This collection includes 19 old journal books beginning in July 1883 and ending in January 1910. The entries are in order by claim entered and are divided by funds such as "Current Expense Fund" and "Hall of Records Fund". Some entries may be in alphabetical order, but there is no index. Information on individual claims may include the name of the claimant, the nature of the service provided, and the amount and date of the claim.

Supervisors Allowance Books

These 6 volumes appear to complement the "Certified Claims" records mentioned above. Each volume lists claimants in alphabetical order and then under each letter entries are made chronologically. Entries may include the name of the claimant, nature of service performed, amount of claim, claim number, fund charged, and date claim was allowed. The earliest records are from January 1873 and the latest, July 1896.

Superior Court Criminal Cases

This collection is 2 boxes of criminal cases heard by the Santa Clara County Superior Court. The earliest record is from 1893, with most of the cases dated between 1895 and 1932. There is an index for these files at the Superior Court, but none at the Archives.

If you are interested in information from any of these collections, you may use the SCCHGS Application for Research in the back of this publication. Make certain you note on the form that you are looking for information from the Santa Clara County Archives and note the particular collection from the list above.

There is an ongoing indexing project underway for the 27 boxes of Wills, but the Wills are in alphabetical order, so if you suspect there is a will in this collection for one of your ancestors, it would be fairly easy to access even without the index. The other collections are a little more difficult to explore.

You must make an appointment to access this collection in person, or use the resources of the SCCHGS by completing an Application for Research.

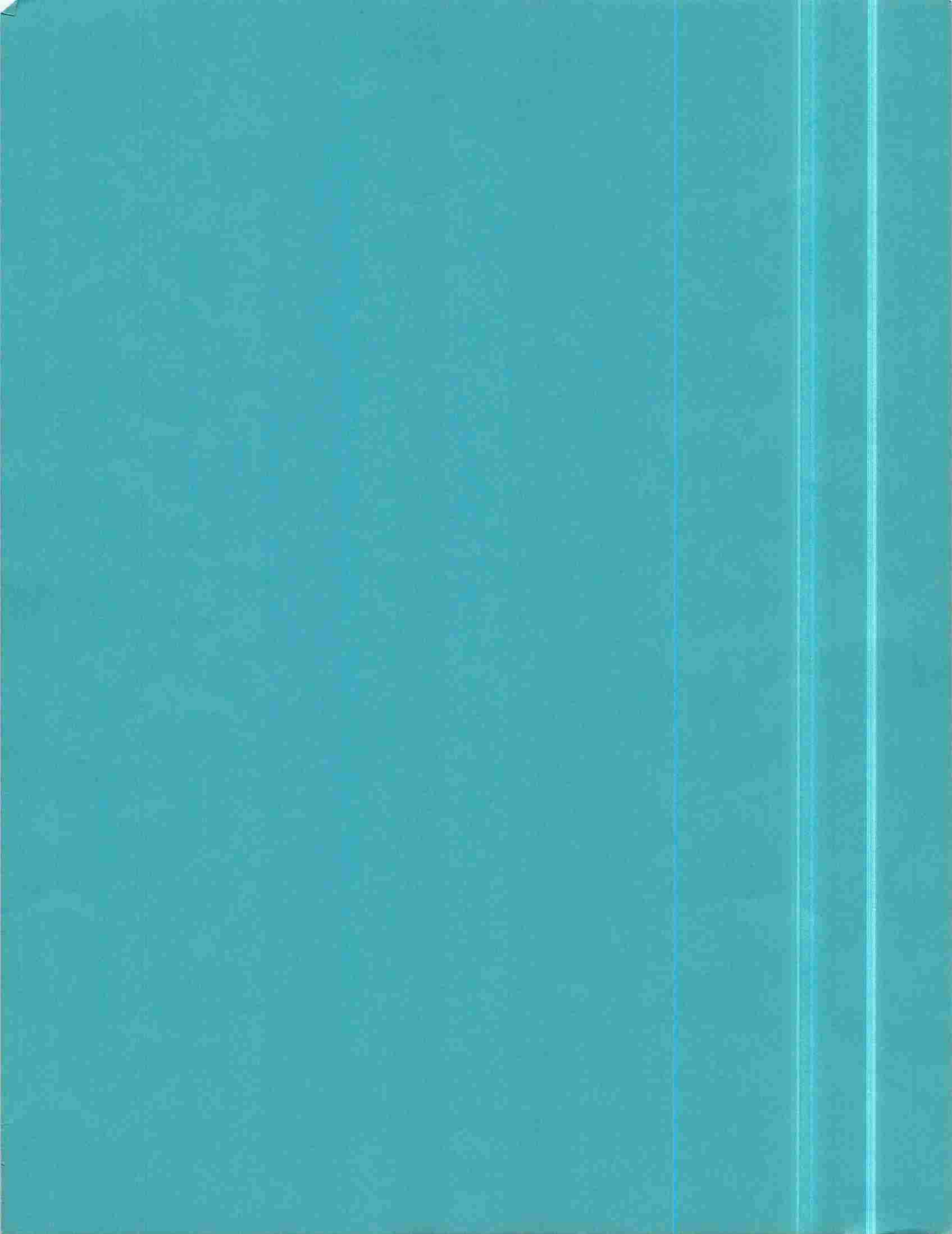
