The petition of JOHN WALPOLE repeated much of the information pertaining to the promissory note and mortgage from BRYAN F. LANE that is shown previously. He stated that payments made on same had reduced his principal to \$780.43¼ and \$66.12 interest and requested the space of six months to satisfy the balance.

WILLIAM W. JORDON vs ASA V. MANN, Guardian for DEBORAH A.F. WILLIAMS

Rule Nisi from Court of Ordinary &

Guardianship Envoled. Court on hearing arguments ...ordered and adjudged that the decisions of the Justices of the Inferior Court, setting for Ordinary purposes ...be affirmed that letters of Guardianship of ASA V. MANN of the personal property of DEBRAH A.F. WILLIAMS stand revoked and that the appointment of WILLIAM W. JORDON as Guardian of said person and property be confirmed...

ABLE O. VAILE vs JAMES C. PEMBURTON

Rule Nisi:

...at the August Term 1837 judgement was entered against the defendant JAMES C. PEMBURTON and execution was issued thereon and placed in hands of WILLIAM CAMPBELL, then Sheriff...failed to execute the money... The petition of WILLIAM H. DEARING, of Bibb County, sheweth that he has been engaged for some time in the study of law with a ... to be admitted to plead and practice in the several courts ...in this state. That he is 21 years of age and prays that a committee be appointed to find him qualified ... and licensed in said profession.

HENRY G. LAMAR, certified that said applicant Mr. WILLIAM H. DEARING had studied law in his office, was of moral character and qualified to be appointed... Court appointed CHARLES J. McDONALD, HENRY G. LAMAR and JAMES H. STARK as a committee to review his knowledge on the common and state laws of England, Constitution of the United States and State of Georgia. The oath of office followed by ANGUS M.D. KING, Judge.

JOHN WOODS of this county, and THOMAS M. WOODS of Harris County came before PATRICK M. CALHOUN, J.P. and acknowledged themselves to owe to his Excellency, the Governor of this State...\$500 current money. The condition...one WILLIAM SMITH, late of Knoxville was brought before the said Justice at the instance of JOHN WOODS and was by him charged with the offense of -rindling (?) and therefore committed to the common jail. They promised to provide evidence at the trial of said WILLIAM SMITH.
