Franklin Co. Sa. Weed Book C (Vol 39) gan 1786 – Sept 1790

Abstracted By: Mrs. Martha Walters Acker, Birmingham, Alabama

As stated in a previous issue of the GGM, your editor would soon be re-printing newly reabstracted Deeds from Franklin County, Georgia. Franklin County as it appears on the map adjoins the South Carolina line and was an original county, having been created on Feb. 25,1784 from the Creek and Cherokee Cessions of 1783. Into this county came many early settlers from North and South Carolina and Virginia.

When these Franklin County Deeds originally appeared in the GGM starting in 1965, they were referred to as "selected" deeds. By this, the former editor wished to have deeds from this area which "seemed" to contain specific genealogical data, rather than to print all of the Franklin County Deeds book by book and deed by deed. Hence, for those who own these back issues of the GGM, it will be noticed that only a very brief number of deeds per deed book appear. For those who did not carefully read that these were "selected" deeds, it could have and probably for some did seem as if these deed books were brief and lacking in comparison to the number of people known to have settled this early county., viz. in Deed Book C which begins in this issue there are to be found 201 deeds, while the first printing of "selected" deeds contained only 95 deeds.

Mrs. Acker abstracted these deeds from the Microfilm copies of the originals, rather than from the originals and hence there would seem to be a discrepancy in page numbering. In her abstracts, the number to the left represents the original page number, if visible in the inner corner of the original page, while the second number in parenthesis are those new numbers which appear at the top center of each page, having it would seem been re-numbered at some later date or when re-binding the original deed books. By providing both sets of numbers, a person can be more specific if he should wish to order a photocopy of a given deed from the State Archives, so that Archives personnel can have a means of double checking for the proper deed.

Book C of the Franklin County Deeds will continue into the next issue and when it is completed, Book H the next book in sequence will begin. At this time it is not certain that all the Deed Books up through 1832 will be reprinted in the GGM since there is some discussion at this time about reprinting several in the GGM with these plus the others being printed in book form. More information on a possible book will be forthcoming in a later issue.
