Early Members of the First Congregational Church QUINCY, ILLINOIS Part 1 of 3

This article by Jane Neu lists early members of the First Congregational Church (1830-1849) It was taken from Family History Library microfilm no. 960869 Church Book No 1 (1830-1840) and No 2 (1840-1866). Some information about dismissals and deaths were with lists of members. Other information was taken from minutes of meetings and register of births & deaths and added after the individual's name. The list is as accurate as possible for some of the print was difficult to read. The Church was organized Dec 4 1830 as a Presbyterian Church, reorganized and changed into a Congregational Church Oct 10 1833. The Church split in 1847 into the First Congregational Church and the Center Congregational Church. The date is the day the person was admitted to the Church.

note: removed means left the Church without being dismissed to another Church. readmitted means rejoined the First Congregational Church.



UNNATURAL DEATHS

In Quincy in the Past Twelve Years--Murders in Which the Guilty Have Never Been Brought to Justice

Deaths by Accident and Suicide--The Many Different Methods Used by the Latter

In going back twelve years, to the time of the birth of the Journal, we must not overlook our crimes, suicides and deaths from unnatural causes. We find, by running over the coroner's records, that at least seventeen known murders have been committed in Adams County in the past twelve years. Some of the perpetrators have been captured and punished, among them Dan Porter and Wm. Jamison, who suffered the death penalty, and others are still at large.

In giving the inquests held in the past twelve years in chronological order, we have divided them into classes, placing them under sub-headings of "murders," "deaths by suicide," "deaths by accident" and "unknowns." Inquests held in cases where persons died suddenly of heart failure or other natural causes, are not included in this report.

The propriety of recalling the murders, suicides and fatal accidents may be questioned. It is true that the names of many will be read by friends and relatives with a feeling of sorrow and regret, but the good expected from the publication of this report may out-weigh the harm it will do.

The publication of the large list of accidents should make us more careful and should induce those in charge of the railroad yards and other dangerous places to take some steps to decrease the chances for accidents.

The publication of the list of murders should cause our city and county officials to be more vigilant in ferreting out past murders and cause them to use their efforts toward diminishing the opportunities for murder.

It is hard to see just what good or bad can come from publishing the list of suicides. In a news way the list is all right, as it is interesting to note the many different methods used by the deceased in ending their days.

It should be added here that the dates given, as a rule, refer to the time of the holding of the inquests.

Murders

Under this head is classed the murders which have occurred in this county in the past twelve years. Two of the perpetrators, Dan Porter and Wm. Jimison, paid the death penalty, and Simon Johnson was sentenced to Joliet for life. Others have received shorter sentences, and still others have never been brought to justice. This list is as follows:

HENRY PAUL'S SUDDEN DEATH

The following was extracted from the March 24, 1852 Quincy Whig.

"Coroner's Inquest—On Tuesday an Inquest was held by Coroner Munroe on the body of Mr. Henry Paul, who died very suddenly at his residence, near the old City Cemetery. The verdict of the jury was that the deceased died of apoplexy. The inquest would not have been held, but for reports that had became generally circulated that the deceased had been bleed to death. These rumors originated in slight, but painful incidents connected with his death. During the time that the Physician was bleeding him, one of his assistants fainted, and in the confusion some blood was spilt on the floor. From this in some manner the report alluded to arose. Mr. Paul was 27 years of age."


