"Deed Record McLean County", Book A. is indexed; but a comparison of the index with the body of the book by Jeanne Fisher showed some discrepancy in names and spellings and much genealogical material that is not included in the index. The following data is composed of actual extractions from the records and covers "A" through "D". We plan to continue with "E" in the next issue.

"X" indicates individual signed by mark rather than signature. C.C.C. indicates Clerk of Court of County Commissioners who were selling some of the land. Person in left column is the one making the purchase and since joint tenancy was not as common then, the wife does not appear but since she is presumed to have a dower right she does sign when a sale is made most of the time. The witnesses are sometimes of interest as they can often show family relationships. "W" = witness. J.P. = Justice of the Peace.





SUICIDES REPORTED IN BLOOMINGTON NEWSPAPERS Part I. 1857-1899

Compiled By Bill Steinbacher-Kemp and Sara Cushing

[Bill Steinbacher-Kemp is Librarian/Archivist for the McLean County Museum of History. Sara Cushing is Vice President of MCGS.

Steinbacher-Kemp and Museum volunteer Sara Cushing have collected local newspaper accounts of suicides by McLean County residents. More often than not, Bill and Sara stumble across these articles while researching unrelated topics on *Pantagraph* and *Bulletin* microfilm. These articles are then collected in a vertical file labeled "Suicides" held in the Museum Archives.

Below is a list of such articles collected as of March 18, 2007. Given that there is no index or other systematic method available to locate suicides on microfilm, this list is a work-in-progress. Bill and Sara continue to come across additional articles as they spend part of each week winding their way through reels of microfilm.

The first suicide in the file comes from the September 30, 1857 Weekly Pantagraph. That article details the suicide by hanging of John Houseman, a German "who had been deranged for some months." Houseman took his own life at the McLean County Jail.

Today, newspapers treat suicides with much more sensitivity than was the norm in the nineteenth century. In fact, it was not unusual for both *The Pantagraph* and *Bulletin* to treat suicides of local residents—be they prominent businessmen or "inmates" of the Poor Farm—with a fair amount of salaciousness.

Although newspaper coverage is less sensationalistic today, the cold, hard facts of suicide remain sadly unchanged over the past 150 years. The reasons these individuals listed below took their own lives include illness, both physical and mental; financial trouble; and spurned love. The methods they selected included hanging, poison, and firearms.

In an era before modern medicine, when physicians were frequently unable to treat chronic pain, suicide was oftentimes the preferred route for those bedridden or suffering from some untreatable condition. For instance, on February 14, 1882, *The Bulletin* reported the suicide of longtime Bloomington resident Peter Greenwaldt, an "old, wealthy and respected gentlemen." According to the newspaper, "Mr. Greenwaldt had been an invalid for a number of years, and this had caused him to become weary of life to the extent that he was willing to make use of the pistol to put an end to his own existence."

Henry Mayer Is Taken By Death Veteran Fire Fighter Was In Service Here for Forty-Two Years Was Chief for 28 Years

Henry Mayer, former fire marshal of Bloomington passed away last night at 8:30 o'clock at his home 306 East Jefferson street. He has been in failing health for some time and has been confined to his bed during the past two weeks. His condition yesterday was apparently somewhat improved, and his death last night came as a shock to his family and friends.


He was born in Belleville, Ill., April 7, 1858. He received his education from the Belleville public schools and also from a business college there. He came to Bloomington in 1874 and learned the blacksmith and carriage making trade under Lyman Ferre, in a shop at the corner of Center and Front streets, where the Newmarket is now located.

Mr. Mayer was in the fire service for forty-two years and during that time served as chief for twenty-eight years. He went thru all the hardships of the service. He saw the force change from a hand brigade to horse-drawn equipment, and then to the present motorized department. He is largely responsible for the high efficiency of the department at present.

He joined the fire department as a call man in 1881. At that time he received only \$10 a month and a place to sleep. He was made chief fire marshal and city electrician on May 6, 1896. In 1900, he was re-appointed chief fire marshal and put in charge of all the department of safety. Later the office of electrical inspector was created by ordinance, and since then, until his retirement last May, he acted as fire chief and superintendent of buildings. His father was a captain in the fire department in Belleville and he always felt that the love of the fire service was born in him.

Mr. Mayer was married in this city on Oct. 6, 1880 to Elizabeth K. Zier, who with two children, Mrs. Lela Mayer Long and a son Raymond, survive. There are also two sisters, Mary Elgle and Mrs. Kate Wilhelm, both of St. Louis. Mr. Mayer attended the First Church of Christ Scientist. He was a member of Mozart lodge, 656 A. F. & A. M., Knights of Pythias, Loyal Order of Moose and Improved Order of Red Men. He was also a member of the International Association of Fire Engineers and the Illinois Fireman's association. The funeral announcement will be made later.

ORRIN LOOMIS

ORRIN LOOMIS, died December-9-1876, aged 85 years. Married to Mary Ann Eyles and emigrated from Connecticut to Illinois and engaged in farming east of Bloomington. There were six boys and one girl born, all of whom are dead. He was of English extraction, was independent in religious matters and in politics a Democrat.

An appropriate monument marks his resting place.

9.

W. D. HARRISON.

W. D. HARRISON, died Sept-29-1867, aged 51 years. He emigrated from one of the New England states to Illinois about the year 1855.

He farmed for a while near Bloomington, and then retired and resided on or near North Main St. in this City, where he died. He raised a small family all of whom are dead. He was of English extraction, but nothing is known of his religion or politics. A suitable monument commemorates his memory.

EARNEST G. REIMAN.

EARNEST G. REIMAN, died December-28-1868, aged 67 years. He was born in Germany and came to this Country when a small boy. He was the father of a number of children, all of whom are now dead. He was a member of the Lutheran Church, and independent in politics. A neat monument marks his resting place.

11.

BENJAMIN L. LUCAS.

BENJAMIN L. LUCAS, was born at Washington Court House, Ohio on November-11-1835. He was married to Miss Mary Wilson, daughter of Robert Wilson in January-1852, and raised a family of children, all of whom are supposed to be dead. He was a well known Dry Goods clerk in different stores in this City for over fifty years, and everybody knew Ben Lucas. He died in St. Paul.

12.

ROBERT WILSON.

ROBERT WILSON, died November-3-1881, aged 87 years. He came to Bloomington from Ohio, and engaged in the harness business here for a number of years. He was married and had a family of children, the above named Mrs. Lucas being a daughter.

He was an old line Whig, and afterwards a Democrat. He had also two sons, Thepholus and Fletcher, both now deceased. He resided on the corner of Main and Clay Sts. for many years.

A simple slab monument marks his grave.

13.

H. W. PIKE.

H. W. PIKE, born August-19-1804, at Cornish, Maine, and was one of 24 children. He came to Bloomington in 1854 with his wife and family of seven children. He was married October-1-1838, and was the father of the following children: Edward M., Noah H., Sue Pike Sanders, Ivory H., Alpheus H., Anna M. and May A. Pike. He engaged in the land and live stock business, and owned a large tract of land near Saybrook. He was of English descent, and was an old line Whig and afterwards a Republican, and was a member of the Unitarian Church. He bought the half block facing Madison St., between Chestnut and Walnut, which was called "Niggers Hill", where he raised his family and died.

A nice monument stands at the head of his grave.

14.

REV. HENRY PEARIS

REV. HENRY PEARIS, was born April-4-1825, and died December-22-1895. He was a native of Pennsylvania. He died leaving his widow and the following children, Mary J., George M., Harry J. and Ralph P. Pearis, the latter a Physician at Normal. He preached for nine years in Heyworth and

for three years in Normal and for a time in Springfield and Iowa. He was a Presbyterian and was an old line Whig and afterwards a Republican and was of English descent. A suitable monument was erected to his memory.

15.

JOHN B. ROUNDS.

JOHN B. ROUNDS, died December-13-1884, aged 43 years. Was a soldier of the Civil War, and belonged to Co. I. 139 Illinois, Vol. Infantry. He was married and had two sons Enoch and Charles. He was a brick mason by trade. The son Enoch married a daughter of Isaac Strain. A neat monument was erected to his memory. He was a Republican in politics and a Methodist in Religion.

FREDERICK PRAHM.

FREDERICK PRAHM, was born March-23-1829 in Germany, and died October-20-1905 on a farm east of this City. He was married and had a family of eight children, only one of whom survive, Herman Prahm, a farmer east of Bloomington. He worked for many years as a car repairer at the C. and A. shops before engaging in farming. He was a successful farmer and a reputable citizen and a man of many good qualities. He was a member of the Lutheran Church and was a Republican.

A fine monument marks his resting place.

His home for many years was on West Market St., where he died, and which was later the residence of the late William G. Boyce. He was a Democrat and a Methodist, and was of English descent. A splendid monument marks his resting place.

18.

ALONZO L. BUSHNELL

ALONZO L. BUSHNELL, was born December-3-1811 in Ohio and died in this City June-7-1885. He was the father of Mrs. I. R. Crum and Mrs. Steere. He was engaged in the furniture business here for many years, and the writer of this sketch bought his first furniture of Mr. Bushnell, nearly fifty years ago. He was a Republican and a member of the Presbyterian Church.

A splendid monument stands at the head of his grave.







(Continued from Fayette Facts, Vol. 29 No. 3)

Nearly 30 years ago, the Circuit Clerk, James CARTER copied the first 370 pages of the County Commissioner Records for the years 1821 to March, 1832 and presented a copy to the then-Editor Alenia McCORD for publication. Upon the death of Miss McCORD, this Editor "inherited" these copies.

This record of the early transactions of our county is invaluable - roads were surveyed and declared public roads, voting districts were set, jurors were selected for the Grand and Petit Juries, wards of the county were cared for. For a genealogist this is a true gem because it helps to place our ancestors here at a certain date.

Over the years we have published excerpts of these records through the pages of *Fayette Facts*. In this issue, with the printing of the County Commissioner Records to March, 1832, we have now published 11 years of transactions of Fayette County Commissioners - the first 370 pages of county business.

Page 344. January 2, 1832. Commissioners Samuel HOUSTON and John WATWOOD. Thomas C. KIRKMAN, acting justice presented the court with a list of fines he had assessed. James WHITLOCK, acting justice presented his assessment.

Ordered that John CHARTER be licensed to keep a tavern in Vandalia for 1 year ending 15 Nov 1832. He entered a Bond with security and paid \$12 into the Treasury. Ebenezer CAPPS was licensed to keep a Grocery and to vend goods and merchandize in Vandalia for 1 year - he paid \$20 license fee, likewise for SLOVER and HAWKINS who also paid \$20.

Zela F. WATWOOD was allowed \$50 for his services in taking lists of taxable property for the year 1831 - 5 days. Thomas REDMOND was allowed fifty cents for wood furnished the Circuit Court at October term, 1831 and E.C. BERRY was allowed seventy-five cents for candles. C.B. BERRY, jailor was allowed the same amount for keeping Jno. GORDON 2 days.

Akin EVANS, S.R. POWELL and A.P.H. DOYLE were each paid \$1 per day for 3 days constable service to the Circuit Court. C.B. BERRY was allowed \$3 for services as Sheriff. Commissioners HOUSTON and WATWOOD were each paid \$1.50 for their services and James W. BERRY was paid the same for acting as Clerk.

Page 347. March 5, 1832. Commissioners, Samuel HOUSTON, John WATWOOD and John HALEY. Judge James HALL moved the court to suppress the licenses of Ebenezer CAPPS and Frederick REMANN for permitting drunkenness, riots and disorder in their respective houses. After examining diverse witnesses and the argument of counsel this was done.

March 6, 1832. C.B. BERRY presented his delinquent list for 1831. William Lee D. EWING made motion to amend the several Revenue Laws Of The State approved 12 Feb 1831.

Zela WATWOOD, Treasurer for Fayette Co. and made his report and paid into the Treasury the following:

6th District - To commence at the western boundary of Fayette Co. where the township line between townships 6 and 7 strikes the said western boundary running north with the western boundary line then southeast until it strikes a due north/south line from the lone tree in the prairie near the Sangamon Road then south with said due north/south line to the line between twps. 6 and 7 then west to the western boundary. Simon LANDERS was appointed Supervisor.

7th District - Commence at the corner of Gallatin and Fourth Streets running south with Fourth street to Johnson then west to Fifth Street then south until you strike the Carlyle Road running by B. THOMPSON's the southwardly with said road to the northern line of College Twp. then west with said northern line to the western boundary of Fayette Co. then north to the line bteween sections 18 & 19 in Twp. 6 North then east to the middle of the prairie then north along the middle of the prairie to a due east and west line running out of Gallatin Street. Robert BOWLES was appointed Supervisor.

9th District - To be continued same as March term, 1831. Paines TERRILL was appointed Supervisor.

10th District - Commence at the western boundary of the county between sections 18 and 19 in township 6 North until it strikes said western boundary then east to the center of the prairie then due north along the middle of the prairie to the line between twps. 6 and 7 then west to the western boundary of the county. Dempsey YARBROUGH was appointed Supervisor of the roads in said District.



13th District - Ordered that Thomas BROCKET be appointed Supervisor of the road leading from the county line of Clay Co. to the County line of Shelby County and that all the hands living in Effingham now attached to Fayette work on said road.

Page 358. Ordered that Joseph HINDS be appointed Treasurer of the county through next March Term and until his successor be appointed and qualified. He was to enter in a bond for \$2000. Ordered that the fine imposed on Samuel CARSON by Guy BECK, Esqr. for peddling goods without a license be remitted upon his taking out license. J.T. ECCLES, Justice of the peace returned to court a list of all fines assessed by him since the last regular term of court amounting to \$40. Constable EVANS charged with the collection of \$4; Constable WILLIAMS charged with the collection of \$3. Thomas C. KIRKMAN, Justice of the Peace returned to the court of list of fines assessed by him amounting to \$14; William J. HANKINS, Justice returned a list of fines amounting to \$3; Justice Demsey YARBROUGH assessed \$3.

Page 363. A.P.H. DOYLE paid \$6 dollars, the amount collected by him in fines.

Ebenezer CAPPS and Frederick REMANN by their counsel, William Lee D. EWING asked the commissioners to reverse the ruling made by earlier court suppressing their licenses. After argument being heard on both sides, the motion was overuled. Whereupon said CAPPS and REMANN by their attorney filed their bill of exceptions and appeal to the Supreme Court.

Order that the sum of \$20 be allowed the county court for rents for the year 1831.

Ordered that James BLACK, Robert BLACKWELL, SLOVER and HAWKINS and William McCONNELL be licensed to vend goods and merchandize for one year ending 8 Mar 1833. They each paid licensing fees into the treasury. Samuel CARSON paid \$5 his license to end Dec. 1832.

John DEPEW was allowed \$1.50 for bearing election returns form the Northern Dist. of the county at the August, 1831 election. Josiah STEWART was allowed \$2.30 for bringing polls from the eastern district.

Abraham STARNES, Coleman NORRIS and James BRAZLE were allowed \$2 each for their services in attending upon the circuit court, May term 1831 as were Samuel HOUSTON, John HALEY and John WATWOOD for their services as county commissioners. Jailor C.B. BERRY was allowed money for guarding A.O.J. HELM 3 days, Henry WILEY, 5 days and Daniel TROXELL, 2 days.

Ordered that Fayette County be laid off into the following Districts for general Election:

- 1st Commencing at the western boundary of the county where the twp line between townships 7 and 8 N crosses the same, then east with said twp. line to the Eastern Boundary of the county then north with said eastern boundary to the northern boundary of said county, then west to the western boundary, south to the place of beginning to be called Nichols Precinct. Elections to be held in the home of John WATWOOD with William NICHOLS, Sr., Paul BECK, Jr. and Jeremiah GOODWIN be appointed judges.
- 2nd To be called Vandalia Precinct commencing at the western boundary of Fayette Co. where the twp. line between twps. 7 and 8 N cross then east to the eastern boundary, then south with said eastern boundary to the southern boundary then west and north to the place of beginning. Elections to be held at the State House in Vandalia and Joseph CHAFFIN, Joel THOMAS and Winslow PILCHER be appointed judges of the election.
- 3rd That all of Effingham County now attached to Fayette Co. shall pompose a Precinct to be called Wabash Precinct and that the election therein be held at the house of Thomas J. BROCKETT. William BROCKETT, Jacob STOVER and William STEPHENS be appointed judges therein.

Page 369. James W. BERRY was allowed \$30 for ex-officio services as clerk of the Circuit Court up to the 1st day of June, 1832. He was also allowed \$15 for stationery furnished for the use of the clerk's office and county commissioners court up to the ninth of March, 1832.

Samuel HOUSTON and John WATWOOD were each allowed \$1.50 for acting as commissioners; C.B. BERRY allowed \$1 for services as Sheriff.


1892 McLean County Old Settlers' Association Membership and List of Deceased Members

In the matter of appointing teachers for the high school, the whole matter was postponed until the next meeting. It is understood that three changes will be made then, as it is said that Mrs. Anderson and Prof. Seibel have resigned and Miss Pollock will go to Europe. There were fifteen applications for the vacant principalship of No. 4. Mr. Tavenner who was finally selected taught last year at Leroy and has also been principal of the Williamsville schools. He formerly resided in Normal with his parents.

It was decided to celebrate Columbus day on October 12 next, by a general union exercise of all the city schools.

The board decided to drop the names of all married ladies from the list of teachers who have husbands able to support them. This was done, as was explained, so as to give the young and capable lay teachers a better chance, and with no other idea. The next school year is to consist of nine months of twenty days each, with a fourteen week term before the holidays, beginning September 12, 1892, and the winter term is to begin with January 2, 1893.

Special commendatory reports were made in reference to the work of Miss Josie Munholland, Miss Ida Niergarth and Miss Marie Gmehlin.

Orendorff, Mrs. Melinda Blunt, Mr. and Mrs. David Simmons, Hiram Halbert, William Lindly, Johnathan Maxon, Mrs. Isaac Lash, John Bishop, James Goodheart.

Most of these were young, some of them babies, in 1830, and the oldest were not over thirty-five or thirty-six. Several of these people are now octogenarians, and all must, in the natural course of human life, soon pass away. The entire list of the county will be published in book form when completed.



THE MILLER CEMETERY The Lives And Times of Randolph Township Pioneers By Jack Keefe

[Jack Keefe is a Bloomington native, and a long time MCGS member. Photos for this article were taken by him.]



Miller Cemetery began in the 1830's on Amos Miller's land in Section 26, Randolph Township. Burials ended in the 1880's, and the cemetery fell into disrepair for almost 90 years thereafter. Heyworth veterans restored it in the 1970's, and in 2000 there was another burial, following the previous one by 115 years. The Miller is maintained today by Randolph Township.

Philip was a Revolutionary War veteran, and the oldest person believed to be buried here. He is the father of Barbara Crose Hand, and the grandfather of Lucinda and Melissa Hand, all of whom are buried here.

Priscilla Becks dates unknown

She was the wife of Philip Crose. Actually, there is little hard evidence that either Crose is really buried here. Records do show that Philip was buried here, but these are not government records. No gravestone was visible for him until after Miller Cemetery's

HAND

1787-1870 Barbara Crose

Barbara (sometimes spelled "Barbary") was the wife of George C. Hand, and the daughter of Philip Crose. She was the mother of Melissa and Cynthia Hand, and was the second last burial in the Miller Cemetery before it fell into disuse.

1829-1845 Cynthia

Daughter of George and Barbara Hand and the granddaughter of Philip and Priscilla Becks Crose

1830-1856 Melissa

Melissa was the daughter of George and Barbara Hand, and the granddaughter of Philip and Priscilla Becks Crose. According to the 1850 Census, she was mentally retarded (noted as "idiot" on the census sheet), and is the only known burial in the Miller with any such designation.

1789-1845 George Callahan

George was a veteran of the War of 1812, and is the only veteran of that war known to be buried in the Miller Cemetery. His military records show he rode with Captain Renick's outfit from Ross County (Chillicothe), Ohio.

JOHNSTON

1912-2000 Lillian Ruth

The Johnston burial was the last in Miller Cemetery, 115 years after the previous one. Mrs. Johnston is not known to be related to anyone else buried here, and it is not known why Miller Cemetery was chosen as her final resting place.

MILLER

1868-1869 Albert H.

Son of W.C. and S.L. Miller

Son of A.K. and N.M. Miller

Although this is not the first known burial in the cemetery, it begs the question as to whether the cemetery was begun for burial of an earlier Miller child, records of whom did not survive.

Son of Thomas O. and Cynthia Rutledge

These Rutledges are distant relatives of Ann Rutledge, famed lady friend of Abraham Lincoln before his marriage to Mary Todd. Ann died in the 1830's, and her name has been perpetuated as a poem in Edgar Lee Masters' *Spoon River Anthology*, and as the name of a passenger train on the Gulf, Mobile and Ohio Railroad.

STRINGFIELD

Andrew J.

1827-1862

Andrew was a Civil War Veteran who died from illness taken at Camp Butler, where his outfit (70th Illinois Infantry) had been assigned to guard Confederate prisoners. The camp was filthy with disease, and Andrew was just one of its many sad casualties.



His commanding officer in the 70th Illinois Infantry was Owen T. Reeves, a Bloomington attorney who was later elected to the position of Judge. Colonel Reeves was also a founder of the law school (now defunct) at Illinois Wesleyan University.

The best sources say Andrew was the son of James and Minerva Orr Stringfield. He was the husband of Charlotte Bishop Stringfield, who lies buried in the Shilo Cemetery probably because the Miller was no longer in use when she died about 1916. Andrew Jackson Stringfield lies buried beside two of his children.

After the cemetery restoration, his new government grave marker spells his last name as "Springfield." But Stringfield is the correct name.

WEEDMAN

1774-1836

Charlotte Hume was the first wife of George Weedman, who is also buried here. Her burial is the first known in the Miller Cemetery. The year, 1836, was the birth date of the last person to be buried here before the cemetery fell into disuse.

George

1773-1848

After his first wife Charlotte died, he remarried to Phoebe Halsey (some records say Holsey). She is not buried here. A Methodist minister, George is the only preacher known to be buried here.

The name Weedman is still common in southeastern McLean County and into DeWitt County. A whistle stop on the railroad between Farmer City and Bellflower is named Weedman, and is marked today on Illinois Route 54 and various highway maps. George Weedman was a part of that same Weedman clan.

WHITELAKE

Fred K.

1836-1885

No family information on Fred Whitelake has turned up, but his was the last 19th Century burial in the Miller Cemetery. The year of his birth, 1836, was the year of the first burial that is known, or possibly 1828, according to another source.

He was a Civil War Veteran (20th Illinois Infantry), fought at numerous battles, and was even taken prisoner by the Confederates. He served time in the South's notorious Andersonville prison.

Fred Whitelake was a farm hand by trade, and an accomplished fiddle player. He died at home one morning, but a group of young people awaited his appearance to play at a dance in Heyworth that night. The *Pantagraph* reported they had not learned of his death, and that the dancing portion of the party was omitted.

This is another case of questionable spelling, and perhaps a good illustration of the use of phonetics during the Civil War years, when literacy was at a lower level than today. His military records from the National Archives give several different spellings to the name Whitelake.

These three children of Jacob and Nancy Wright were brothers to Susannah Bishop, who is also buried in the Miller Cemetery with a child of her own. Their parents are not known to be buried here.

To visit the Miller Cemetery: Take Route 136 east from Heyworth to county road 1700E. Turn north and go to county road 325N. It is more of a lane than a road. You'll see a sign marking the cemetery. Turn left and go 1/4 mile to the end of the road. The Miller Cemetery is fenced off just to the left. Parking is sparse, and be careful not to block the road, which serves as access to properties next to the cemetery. Reflect, enjoy, but please leave it as you found it.

The primary sources for this information were my own research, plus an inventory of tombstones in the Miller Cemetery as read by the DAR in 1948, and records supplied by William North of the MCGS in 1982.

The National Archives supplied military and pension records where possible for the soldiers buried here. Further information came from public records on file at the McLean County Law and Justice Center in Bloomington, plus U.S. Census records 1830-1880. Various histories of McLean County, most notably by Duis, Bateman, Merriman and Hasbrouck, were also used in preparing files on the individuals buried here.

"MILLER TIME" Other Historic Events in the Lives of Miller Cemetery Pioneers By Jack Keefe

The selected events chronicled below give some idea of social, literary, and technological advances of the times. An observer might conclude this was an exciting time to be alive, and for many it must have been. But it is doubtful most of those buried in the Miller Cemetery even took note, as they battled hard times every day just to eke out a living on the Illinois prairie.

- 1757 Earliest known birth of anyone buried in Miller Cemetery (Philip Crose) French build Fort Ascension, later known as Fort Massac, on Ohio River near Metropolis, Whale oil street lamps, designed by Benjamin Franklin, installed on a few streets in Philadelphia.
- 1773 Boston Tea Party
- 1774 England closes port of Boston, places further burdens and restrictions on the Colonies.

- 1825 Completion of the Erie Canal Illinois General Assembly enacts first tax for public schools in the state. First experimental steam locomotive in the U.S. runs in New Jersey.
- 1827 First African-American newspaper in the U.S. published in New York City (Freedom's
 - John James Audubon publishes the first of his drawings of the colorful birds of North
 - Ludwig van Beethoven dies of pneumonia; age 56, in Vienna, Austria.
- 1829 Baltimore & Ohio Railroad carries its first passengers on an excursion train drawn by
- 1836 Texans defeated at the Alamo by Mexican army Construction begins on the Illinois and Michigan Canal. Joseph Smith organizes the Mormon church in Fayetteville, New York.

SHERIFFS OF MCLEAN COUNTY Continuing Series by Sara Cushing, MCGS Member

16th Sheriff Richard Osborn

Richard Osborn was born in McLean County December 25, 1845, the son of Wallingford and Nancy (Brown) Osborn.

In 1856 he and his father went to Missouri where he worked on a farm and continued his education. He enlisted at age 16 in the 23rd Missouri Infantry. He was captured by guerrillas in 1862 and robbed, but then released. He was with Sherman during the Atlanta campaign and was seriously wounded. He was discharged in November 1864.

He finished his education in Iowa and for a time, taught school there. In 1866 he returned to McLean County and began teaching in Randolph Township. He continued his education in various places, and in the fall of 1870 was elected sheriff. After his term, he entered the first class of The Wesleyan Law School and was admitted to practice January 8, 1875. He formed a partnership with John Lillard in Bloomington, and continued until 1880 or 1881, which was the last entry for him in the Bloomington city Directory.

Mr. Osborn married Miss Kate, daughter of Samuel and Rachel (Baldwick) Popple in McLean County off August 30, 1871. They had three children listed in the 1880 census: Lotta, Walter and Frank.

In 1900 Mr. Osborn was living in a boarding house in Seattle, Washington. He was married, but Kate was not living with him.

17th Sheriff Henry Honscheidt

Henry Honscheidt was born in 1835 in cologne, on the Rhine River in Germany. He received a fair education there and learned the trade of cabinet maker. He came to the United States in 1854 to seek his fortune. In 1856, he married in New York to Miss Katherine Ortloff of Millery-stadt, Bavaria. Mr. Honscheidt worked three years in New York and then they moved westward to La Porte, Indiana. They came to Bloomington in 1859.

In 1862, Henry enlisted in the 94th Illinois volunteer Infantry as a private. He served in many battles, including Vicksburg, and at the time of mustering out was a lieutenant, then brevetted captain. He returned to Bloomington and resumed his trade after the war, for a time working at

the C&A railroad shops. In 1868 he was appointed assistant assessor and in November of 1872 he was elected sheriff.

Henry and Katherine had eight children, only one of whom was living at the time of Henry's death on Wednesday, December 16, 1874. Mr. Honscheidt had finished out his term of office only a few days before his death. He is buried in Evergreen Cemetery.

18th Sheriff James Goodheart

James Goodheart was born in Dawson Township, McLean county, March 30, 1830, a son of William R. and Sarah Ann (Clouse) Goodheart. His parents moved to Bloomington when he was quite young, and he attended school there until he was about 12. When he was 17 he went to Meridosia to work with his brother as a blacksmith. One year later he returned to Bloomington and learned the mason's trade with Adam Guthrie and began contracting the building on his own.

He served in Company a, 94th Illinois during his Civil war service, acting as a civil engineer, laying brick at Fort Brown. After a bout of scurvy, he was reassigned to the ambulance corps at Pascagoula, later serving in Texas and Louisana, where he was mustered out in July of 1866.

He returned to Bloomington, working at the building trade for several years. He had the contract for the Soldier's Orphans' Home, and was a successful contractor until 1874, when he was elected sheriff. He later served two years as United States Deputy Marshall and then returned to the building trade.

Mr. Goodheart married Miss Catherine O., daughter of Daniel and Elizabeth (Lucas) Fordice on August 26, 1852. Twelve children were born to them, of whom seven survived [1913]: Mrs. Irene Fundle, of Pekin, IL; Luke and James of Denver, CO; Palmer Lincoln, of Chicago; Dr. J. W. Goodheart of Bellingham, Washington; and Jesse M. and Ben L., both of Bloomington. He also leaves one sister, Mrs. Elizabeth Rankin of Cheney, Kansas, his oldest sister, aged 97.

Mr. Goodheart died December 20, 1913. He was a member of the First Methodist Episcopal Church and Lodge #33, A.F.&A.M., but was not active in that fraternity. He was a member of Wm. T. Sherman Post G.A.R., having served as past commander. Mrs. Goodheart died in 1915. They are buried in Evergreen Cemetery, Bloomington.

19th Sheriff Joseph Ator

Joseph Ator was born at Dayton, Ohio, November 9, 1839, a son of William and Isabel (Dodds), Harry Ator. His father died when he was three and his mother a short time later. He spent his boyhood with an uncle, Thomas G. Ewing. At the age of 15, he moved to Perrinsville, Ohio, where he learned the cooper's trade. He spent several years traveling to Louisville, St. Louis, and he also made a wagon trip to Santa Fe, New Mexico.

Mr. Ator returned to Dayton and was married on February 14, 1856 to Miss Margaretta Waltz, a daughter of Elias and Rachel (Reeder) Waltz. In 1857 the Ators came to McLean County, settling at Towanda, where he opened a cooper shop. He joined the 145th Illinois volunteer Infantry at the start of the Civil War and served in the state of Missouri throughout the war.

In 1875, they moved to Bloomington and he opened a cooperage on West Market Street, near the old distillery, and later another shop near the Eagle Roller Mills on the east side of Robinson Street.

An active Republican, he was appointed deputy under Mr. Honscheidt. He sold his cooperage shops and remained a deputy under both Mr. Honscheidt and Mr. Goodheart until November of 1878, when he was elected sheriff, serving two terms. For eighteen years he was assessor of Bloomington Township.

Mr. and Mrs. Ator celebrated their golden wedding anniversary on February 14, 1906. Mrs. Ator died March 3, 1912, and since then Mr. Ator has lived with his children, principally, his son, Harry at Waukegan.

Joseph Ator died in Waukegan on August 4, 1917 at the home of his son, Harry. He is also survived by Mrs. Dr. Ernest Ready of Alaska, and Mrs. A. L. Cox of Kansas City. His only brother was killed in an unknown location during the Civil War, and a grandfather on his mother's side was killed in the War of 1812.

He was a member of William T. Sherman Post G.A.R. and the Odd Fellows. He devoted much time to charitable works and was for many years president of the Bloomington Benevolent society.



HENRY H. SWAIM 20th Sheriff Of Mclean County

William Henry Harrison Swaim, or Henry H., as he preferred, was born December 18, 1840 at Brownsburg, Hendricks County, Indiana, a son of Manoah and Eliza Jane (Moore) Swaim. Henry was my great-great uncle, and the reason I became interested in the history of the sheriffs of McLean County.

When he was 15, his grandfather, Anthony, died, and Henry's father took his share of the estate and bought land in the Platte Purchase in Missouri. The family, consisting of Mary Jane, Henry, Anthony, James and Zachary, moved to the vicinity of Maryville, Nodaway County.

When the war broke out, Henry enlisted in Company 8, 13th Missouri volunteers. He was later captured at Lexington, and then paroled to St. Joseph, Missouri, where he soon joined up again, this time in the 25th Missouri, under Capt. Dill and remained with this unit through the Battle of Shiloh. Henry claimed to have fired the first Union shot at that battle. The 25th was subsequently merged with the 1st Missouri Engineers and he remained with this unit until his discharge in 1864.

Immediately after the war, the family, except Eliza, who I believe died in Missouri, moved to Normal, Illinois. On March 3, 1871, Henry married Miss Pauline Stewart. They had two children, Hal M., who died in 1918 and Leota P. (Mrs. William) Frink.

Henry was a charter member of the William T. Sherman GAR post and was largely responsible for naming the local post after General Sherman. He was actively interested in politics and was deputy from 1878-1883 under Sheriff Joseph Ator. He was elected sheriff for one term 1883-1884, after which he was a contractor and builder.

Henry died February 24, 1983, aged 91. He and Pauline are buried in Evergreen Cemetery, Bloomington.

LABOR vs. CAPITAL: The 1885 Coal Miner Strike

The second half of the nineteenth century was a time of major transition for America. The industrial revolution was transforming the country, in concert with the burgeoning railroad industry. Key to this dramatic change was the rapidly expanding use of coal. Bituminous coal, less efficient but more plentiful than its anthracite counterpart, could be found in dozens of states. Illinois proved to be a mineral rich state, with an estimated 60-70 percent of the land within its borders containing coal deposits. In 1870 Illinois coal production topped 2.6 million tons, and by 1880 that figure had risen more than 234 percent.

Although McLean County was not among the top coal producers, it was a significant contributor. Total output during the period from 1882 through 1892 ranked it 23rd out of 51 counties engaged in coal mining. The bulk of this yield can be attributed to one operation: The McLean County Coal Company of Bloomington.



McLean County Coal Company [owned by the ancestors of Sen. Adlai E. Stephenson III], display ad, *Daily Pantagraph*, October 6, 1881, p. 4.

Serving a customer base in central Illinois, the company began operations circa 1880, using a single deep shaft mine, which penetrated two sizeable coal seams. Despite evidence of unusually warm relations between company management and their work force of approximately 200, it was not long before conflict arose to a degree that necessitated a work stoppage. Receiving authorization by an unidentified labor organization, possibly the Knights of Labor, the workers walked out on February 28, 1881 in a dispute involving the discharge of a fellow employee. Ten days later the mine employees returned to work having failed to achieve their objective. It would be four years before they would try again.

Late March of 1885 found the miners of the McLean County Coal Company at odds with the proprietor over an impending reduction of the price paid per ton of coal mined. Rumors of a strike permeated the community. The first day of April the walkout became official. Details appeared in the April 2nd issue of *The Pantagraph*, the local paper, bearing the headline, "A Strike It Is."

At the outset, it was apparent that this strike was not going to follow the raucous pattern established in many of the early labor-management confrontations in the Illinois coalfields; a pattern of deep animosity and violence. On the eve of the strike, a company official characterized their workers as "a superior and law-abiding class of men". In addition, shortly after the strike was begun the men were not only paid for work done to date, but received their earnings several

BINGHAM, Horatio Henry b 16 Jul 1841 Concord, VT the son of Warner and Laura RANKIN BINGHAM d 27 Oct 1926 from cancer of the throat. He m 4 Jul 1862 Sophia P. MULLEN and she died March, 1915. Surviving were 3 children, Lillie J. PRATER, W.J. BINGHAM and Edith F. FITZGERALD of Bingham. A son Franklin died in infancy. Also surviving was a brother Warner of CT and sister Laura DALLY of Pacific Grove, CA. He also was survived by 4 half-brothers and 2 half-sisters, Lorenzo, Lucy Ann HILL, George and Edward BINGHAM, Edith BALTON and Harry BINGHAM. Harry, George and Edward were lawyers; Edward being Chief Justice of the Supreme Court for a time. H.H. learned the trade of millwright in the east and first settled in Richmond, IN before finally settling in Fayette Co. in 1881. He built a saw and grist mill and a village named for him sprang up around the mill. Burial was in Liberty Cem. near Bingham. Ramsey News Journal 5 Nov 1926, Vandalia Union 4 Nov 1926.

BOLT, Edna age 23 was mysteriously shot and killed in Chicago. It was thought she was hit with a stray bullet in a tea room. The dau of Tom and Emma DONALDSON BOLT, she was born in the Jimson neighborhood. The family had moved to Decatur 6 years ago. Edna had moved to Chicago 9 weeks before to work in restaurants. Surviving with her mother was an aunt Mrs. Arthur ALLEY who lives east of the river bridge. Burial was in Decatur. Her father died a couple of years ago. Vandalia Union 21 Oct 1926.

BOLYARD, Christena LONG died unexpectedly 25 Dec 1926. She was b 31 Oct 1854 near Lafayette, IN and came to this county with her parents when a child. She m 1880 Levi BOLYARD and they were parents of 7 children, 1 died several years ago. The children all live near Vandalia with the exception of Gabe who lives in Spencer, IA. Burial was in the Old Cemetery, Vandalia. Vandalia Union 30 Dec 1926.
