No Cause for Fear, Ladies --

The census takers are now engaged at their work, and our lady readers are assured that the facts communicated to the Marshal's (about their age, etc.) are strictly confidential, they being bound by their oath not to divulge the same or to retain a copy of the facts obtained. There is no personal curiosity to gratify, or private advantage or emolument to the Marshals; and any exposure on their part is made subject to a fine of five thousand dollars. This assurance is contemplated by the law to be ample to secure the confidence of those from whom information is required; but should it fail, the Marshals have the power to exact a fine of thirty dollars from every person who shall hold or refuse information. The public will remember that the statistics obtained, except as to population, are not published in individual cases, but go in to make up the aggregate of a town or city.

Republican Meeting at Tremont --

. . . on the 30th of June. . . The number in attendance was calculated to be, at least, 800. The Republicans of the township. . . turned out very generally. Washington, the best organized township in Tazewell, was, of course, finely represented. Respectable delegations, also, appeared from Hopedale, Morton, Delavan, Sand Prarie, Dillon, &c. All these united and were formed into procession by the Marshal, Mr. Wm. GAITHER, assisted by half a dozen as gallant young Deputies as ever graced a civic cavalcade.

The procession was headed by the Tremont Republican Martial Band, discoursing soul stirring and patriotic music. After parading Sampson street it advanced to the Public Square, its dozen banners, with appropriate devices, spead to the breeze, presenting, in short, a very attractive appearance.

Under the superintendence of Mr. WAUGHOP, of Washington, and Captain SHAW, a lofty and substantial pole was raised with great dexterity. This was surmounted by a huge ball on which stood a representation of the next President of the United States, holding an implement of his early, humble but honest occupation. Then was run up the Flag of the Union; and, as the stars and stripes were unfurled to the winds of Heaven, three hearty cheers arose from the gathered crowd; and, yet, three more went up to greet the admired inscription of Lincoln and Hamlin.

After a brief interval, the company assembled for the intellectual repast on the beautiful ground kindly tendered by mine host of the American House, and conveniently contiguous to the scene of the preceding ceremonies. The meeting was called to order by Mr. Shaw, President of the Tremont Lincoln Club. Major E.N.CULLOM was appointed President of the day, and Messrs. Joshua BROWN, S. WOODROW, Joel CLARK, Peter MENARD, Dr.B.H.HARRIS, and Nathan DILLON, Vice Presidents. Mr. Henry GROVE being first introduced, made one of his best and most effective speeches. With the exception of a few apt illustrations and happy anecdotes, he confined himself to the argument of his several positions, in which he charged home on both wings of the now very harmonious Democracy. He literally carried the "war into Africa," conclusively demonstrating that Mr. Douglas is



entitled to the sole honor of producing and continuing the present slavery agitations. . . .

Died --

On Saturday morning, in this city, Adalaid, infant daughter of Rev.J.C. and Mary RYBOLT.

On Sunday, 1st of July, in Leavenworth, Kansas, Amanda, wife of Abraham BROWN, in the 58th year of her age, formerly a resident of Tazewell county, Illinois.

Nuisance Abated --

Not long since, an old canal boat known up and down the river as the "floating palace," was moured a short distance below the city, out of reach of our local authorities, and in addition to its "ill-fame" it was suspicioned that it was the head-quarters of a gang of out-laws, who are committing their depredations around us; accordingly, the gentlemen(!) who run the institution were waited upon by a committee last Saturday morning, and requested to leave. Five hours were given them, in which to make themselves beautifully scarce hereabouts, and it was also suggested that they had not better land again within five miles of the city. . .

Committed. --

On last Sunday morning Marshal HULBIG arrested two men at a "one-horse dance" in the upper part of town, calling

themselves severally, REED & MATTERSON, on suspicion of vagrancy and thieving. An examination of the prisoners was had on Monday morning before Justice TURNER, when it appeared that the suspicions were by no means groundless. Some valuable papers were found in their possession, which had been stolen from Mr. Phillip OLT, on the Saturday previous. A pocket book was also stolen at the same time, but has not been recovered. One of them was trying to sell a watch on Saturday, but it has not been ascertained what has become of it, as it was not in his possession at the time of the arrest. They were held to bail for the sum of \$200 each, and committed in default. . .

Shooting Affair --

Three men, named MINTZ, BRIDE, and SAFFRON, were shot in Washington, in the county, on Monday night, last, under the following circumstances:

It appears that the corporation has passed an ordinance, by which hogs are not allowed to run at large, and a pound has been built, where stray hogs are shut up, and liable to be sold unless recovered by their owners in a given time. On the night mentioned, the pound-master heard a noise at the pound and went out, when he found three men trying to take out some hogs that were shut up under the ordinance. He ordered them away when he was knocked down by something which he supposes to have been a brick-bat. On recovering himself, he ran into the house and took down a double barrel shot gun which was loaded with fine shot, and on going out saw the men moving off. He fired both barrels at the crowd. Two of them were considerably wounded, one charge having been pretty equally divided between them and lodged in the hip and side of each, and a few scattering shot struck the third. The latter is but slightly, none very dangerously wounded. The men were in the employment of a Mr. JAQUIN, who, though not present at the time, was near enough to hear all that transpired. Suit was brought by Mr. Jaquin in behalf of the wounded men, and the officer defended by the corporation. It was supposed that the officer would be acquitted.

The deceased was born in Sept. 1815, in Green county, Ohio. He removed to Tazewell county, Ill., in 1836, in company with the family, consisting of a mother and his two brothers, thus ranking among our early settlers. He was a man of quiet retiring manners. . .

Died, at Chicago, on the 14th inst., in the fortieth year of his age, John M. BUSH, judge of the county court of Tazewell county.

Born at Brookville, Ind., March 17th, 1821, the lamented deceased, when an infant, migrated with his parents to

Cincinnati, Ohio. He at the tender age of seven, the messenger of death deprived him of a fond mother, and at eleven of an affectionate father. The guardianship of the orphan boy, was committed to his natural grandfather, a most faithful administrator of the trust. . .young Bush was transferred to the Ohio University. and was graduated in the class of 1842 with the first honors. His legal education was acquired in the office of Judge SUMMERS, of Virginia.

In 1844 Judge Bush moved to Illinois, and selected Taze-well county for his future residence. Soon after, whilst prosecuting his profession, he was elected school commissioner; and in 1853, judge of the county court having discharged the latter with . . . with fidelity. . . a devoted husband, kind father. . .

In this city on the 10th inst., Edward M., son of Joel JONES, aged 6 months.


In this city, Saturday evening, August 18th, Catherine, wife of R. ADAMS, aged 45 years.

The Company alone cannot insure good service. There are always three parties to a telephone call--the party calling, the operator who makes the connection at Central, and the party called. Courtesy will help all.

Answer your telephone promptly and accommodate the party calling you, as well as to help the operator to give prompt and efficient service.

Use great care in giving the number to the operator, for if your order is not understood by the operator, someone will be put to the inconvenience of answering the telephone when they are not desired.

Limit your conversation with the operator to giving the number wanted.

Party line subscribers must limit their conversations to five minutes because others may wish to use the line and should be given the opportunity.

If you should take down the receiver and find that the line is busy, do not interrupt the conversation, but hang up your receiver and wait a reasonable length of time.

Party line subscribers, by showing the proper amount of courtesy to one another as regards long conversations over the telephone, can eliminate to a great extent the answer from the operator that the line is busy and also accord to the subscribers on your own line better service.

Service will be disconnected with any subscriber who is six months behind in payment of account due.

No phone will be installed in town without payment of three months advance rental.

No phone will be installed in the country without payment of six months advance rental.

Instructions On How to Make a Toll Call.

TO MAKE A TOLL CALL. -- Call the Local Operator in the regular way. When the Operator answers, give her the number of the telephone desired (if known), the city or town and the state. If a particular person is desired, give his name. Then give the telephone number from which the call is made and the name of the person making the call. If the number of the telephone desired is not known, give the firm name or the name and initials of the person under whose name the telephone is listed, and if possible, the street address.

MESSENGER CALLS.--If the person desired is not connected by telephone, a messenger will be sent to his address to request him to come to a telephone, provided the party calling guarantees payment for the messenger service. The exact amount disbursed for messenger service will be charged in addition to the Company's tariff rates.

APPOINTMENT CALLS. -- Appointment to talk at a specified time may be made by notifying the Operator of the time at which the connection is desired. No extra charge will be made for appointment calls, (except for Messenger service when such service is involved), but the company cannot guarantee the completion of the connection at the exact time specified.

RATES AND CHARGES. -- Rates for Long Distance service are based upon an initial period of 3 minutes; and the three-minute rate will be charged for connections not exceeding three minutes. For overtime, beyond the initial period of three minutes, charge will be made by the minute for each

additional minute or fractional part thereof. The Operator will not interrupt conversation to notify subscribers of the expiration of the first three minutes.

When a particular person is asked for, every reasonable effort will be made to establish the connection with the person desired. If the person desired is not reached, no charge will be made for the service rendered, except for Messenger service, should such service be involved.

When no particular person is asked for at the time the call is given to the Operator, charge will be made if connection with the proper telephone is established.

For information not given above, concerning Long Distance service, call "Operator."


