FOREWORD

The material in this book has been copied from the original record book of Shiloh Cumberland Presbyterian Church. According to the flyleaf the Church was organized on November 22, 1821 by David W. McLinn. The earliest baptism listed is August 14, 1821. The latest date in the book is listed on page 10, a removal by certificate for William Merit on April, 1857.

Shiloh Church was located in Barnhill Township, Section 29, of Wayne County, Illinois. The Hopewell Church mentioned in these records was located straight south of Shiloh Church in Section 9 of Barnhill Township. Neither Church is in existence today. Shiloh, it is thought, was dissolved about 1859 when its members joined churches closer to their homes such as Lebanon and Burnt Prairie Churches. However, both Hopewell and Shiloh Churches are shown on the Barnhill Township map in an 1881 Atlas of Wayne County as reproduced on the following page.

The records copied herein were copied from the original while in the possession of Paul Files of Burnt Prairie, Illinois.

This book is dedicated to all descendants of the pioneers listed herein.

1. McDonald's History of Cumberland Presbyterian Church we note this item:

"The first Presbytery organized exclusively in Illinois was in 1822. But McGee Presbytery (Ky) included in its bounds part of Illinois. In 1822, the order for the organization of Illinois Presbytery was passed. Its original members were to be Green P. Rice, D.W. McLin, John M. Berry and W. Hamilton. Rice did not attend; all the others were present. This Presbytery immediately organized a Presbyterial Board of Missions.

"SESSION BUSINESS"

July the 3rd, 1823.

The Session of the Shiloh Society met at the home of John Files, Junr. for the purpose of considering the case of Needham Hilliard, whose case is as follows, Viz:

Common fame loudly declaring that Needham Hilliard, a member of this Society, is habitually in the practice of using Ardant Spirits intemperately, and that he has repeatedly been drunk; from which practice Religion has suffered reproach & the feelings of Christians have been wounded. In consequence of which the Session, by their Clerk, cited him a first and second and third time to answer to the above charge. And he having failed and continuing to fail in his attendance to these citations, therefore the Session, after deliberately examining the case with its various effects, and following the directions of the Discipline of our Church, have unanimously resolved to exclude, and the Session do hereby exclude, the said Needham Hilliard from the Communion of the Church for his contumacy, and that he no longer be considered a member of this Society until he repents.

The Session met at the home of John Files, Junr to consider the case of John Widows whose case is as follows:

John Widows having been charged by Alexander Stewart, William Files and Henry Grimes of Levity, Profane Swearing & Fighting, was called upon by the Session to answer to the above charges; whereupon the said John Widows, without the examination of any witnesses, freely acknowledged to the charges, & professed his sorrow and repentance, but declared his belief that he had no religion; whereupon the Session received his acknowledgment (and) discontinued him from being a member, & received him as a seeker under their care.

"SESSION BUSINESS"

The Session of Shiloh Society met on the 2nd of October 1826, at Shiloh Meeting House, for the purpose of settling differences in the Church.

The Session having met with the expectation of attending to charges brot up in due form by John Gillison, against members of the Society, and he having failed to bring up said charges, and also to attend, ordered

therefore, that the Clerk give due notice to said John Gillison that the Session has adjourned to meet at the Shiloh Meeting House on Tuesday, the 14th of Novr. to attend any charges that may legally be brought before them & that he be further informed that said meeting will be the last opportunity given for attending to the contemplated charges.

Shiloh Meeting House Novr. 14th, 1826.

The Session met agreeably to adjournment. Constituted by Prayer. Members present James Mayes, from Hopewell; Henry Grimes, James Shaw & A. L. Hamilton, from Shiloh. David N. McLin was chosen Moderator & W. M. Hamilton, Clerk.

Charges were received, and taken up by the Session against John Files, Senr, Wm. E. Files, and John Files, Junr, as laid in by John Gillison.

Charges against John Files, Snr:

1 - For making Ludicy Files, (nee Gillison), consent to give Jesse Day's wife a certificate, when he knew at the same time, she had given one to her mother to the reverse;

2 - For telling willful lies to the Session at James Dickeys about a certain beegum belonging to Wm. Patton;

3 - For telling lies about Dicy (Ludicy) facing her mother down that she did hire her to say what she did about Melinda Day.

Page 50:

Witnesses: James Dickey, Adam Files, C. Young and Jesse B. Day.

1st Charge:

James Dickey, being duly sworn, testified that it was Jesse B. Day who applied to him to write a certificate, that he never heard John Files, Senr ask Ludicy to sign it, nor make any threats if she did not; That he asked Ludicy before he witnessed the certificate, if she gave it freely and of her own accord, and she said that she did. But that said Files appeared considerably out of temper.

2nd Charge:

Abraham Vaught, being duly sworn testified that John Files, Senr stated before the Session at James Dickeys that Wm Patton had not sold Jesse B. Day a certain heifer in consideration of a Beegum, but that Day sold the Beegum conditionally on another trade, and was to receive two dollars in money for it, the condition of the bargain was that if Patton liked the Beegum when he saw it, but that Patton had never come to see the Gum; and that said Patton never had a beegum at his home, because he had not fulfilled the condition.

Jesse B. Day, being duly sworn, testified that he agreed to sell Wm. Patton

seed wheat, & that Patton was to let him have a certain heifer that ran at C. Young's, and afterwards he agreed to let said Patton have a Beegum, at two dollars if he liked it, and that he might go look at it at any time, & then do with it as he pleased & that he never expected to get two dollars in money for it, but that he considered it in connection with some other bargain existing between them, and that Patton sent him word by Jr. Wilson that he would not take the Gum.

"SESSION BUSINESS"

C. Young, being duly sworn, testified that in a settlement between Wm. Patton and Jesse B. Day after they traded about the heifer and Beegum had been made, he heard each of them say that Patton had bought the Beegum from Day for two dollars, if he liked it, and Day got the heifer from Patton for two dollars and a half, two of which was to stand for the Beegum.

No witnesses being present, was laid aside.

CHARGES AGAINST WILLIAM E. FILES:

- 1 - For aiding to steal away Ludicy & for threatening to have her, or leave me (John Gillison) kicking, meaning to take my life.
- 2 - For passing the certificate to obtain the license, knowing the name to be forged.
- 3 - For telling lies about Ludicy & her mother.

1st Charge: Eliza Vought, being duly sworn, testified that Wm E. Files at her house, said that "If we, (the company who took Ludicy away) could not have got her out of the house, we would have gone in and taken her, if we had left John Gillison kicking, providing the girl was willing.

Peggy Vought being duly sworn, testified that Wm E. Files, at her father's house, said that "We went for Ludicy, and were determined to take her, & if we could not have got her out of the house, we would have gone in and taken her, if we had left John Gillison kicking, provided the girl was willing."

Abraham Vought, being duly sworn, testified that in conversation with Wm. E. Files, said Files said that he went to talk to Ludicy and was determined if she was doing the thing unthoughtedly he would detain her. But if she was fully willing he would see to it that she should not be detained; but that he manifested no disposition to do John Gillison an injury; but said the Company went away as fast as they could to prevent any mischief being done, as some

others of the company had determined to use violence, if John Gillison had come up to them.

2nd Charge: Was laid aside for want of testimony.

3rd Charge:

Morgan Wallace, being duly sworn, testified that Wm E. Files stated that Ludicy did face her mother at James Dickey's, that she did attempt to hire her, by the promise of clothing & to give the certificate respecting Melinda Day.

Betsey Wallace, being duly sworn, testified that Wm E. Files said that Ludicy did, at Dickey's, face her mother & say that she (her mother) had offered her her things if she would give her the certificates respecting Melinda Day, & that her mother did not contradict her.

Peggy Dickey, being duly sworn, that on the day of the trial before the Session she did not as she remembered hear any contradiction between Ludicy and her mother, respecting the certificate given about Melinda Day; but a contradiction did take place between them on the subject of needles in a private conversation.

Henry Grimes, being duly sworn, testified that on the time of the trial at James Dickey's house Nancy Gillison asked Ludicy, after the certificate was read, that she had given Melinda Day stating that her mother had promised her a bed if she would make the _____ on respecting Melinda Day which she had made if it was true; and his impression that Ludicy gave her opinion that it was.

Page 53:

James Shaw, being duly sworn, testified that on the day of trial at James Dickey's house Nancy Gillison asked Ludicy if what she had certified in a certificate to Malinda Day was the truth, but he does not recollect distinctly of seeing Ludicy give any motion testifying her opinion but his impression was that at that time she did give her opinion in some way.

Charles against John Files, Junr:

1 - For insisting that Adam Files should take Ludicy without asking for her, that it might hurt my (John Gillison's) feelings, & that it should be done at that particular time that would hurt the worst.

2 - For telling lies on my (Gillison's) wife.

3 - For aiding in forging the certificate for Adam to get license by signing his name to it.

1st Charge:

A certificate was received from under the hand of Thomas Hamilton Files the substance of which was that John Files had told him that Adam should not humor John & Nancy Gillison so far as to ask them for Ludicy; and that he should run away with her on the particular time that he did, and that it would hurt the worst.

2nd Charge:

C. Young, being duly sworn, testified that he heard John Files Junr. conversing about a letter which Ludicy had written to Adam Files; stated that Ludicy told him that her mother could not read writing, and that she had told a lie by saying she had read the note.

William E. Files, being duly sworn testifies that he heard John files in conversation with C. Young state that Ludicy had told him in the presence of several witnesses that her mother could not read writing; and it was on her having said that, she read a letter written by Ludicy to Adam Files that he said she told a lie.

Melinda Day, being duly sworn, testified that Ludicy Files, at her house, stated that she would give her five dollars if she would read one word of writing for she could not do it.

3rd Charge:

John Files, Junr. acknowledged having set his father's name to the certificate.

John Files, Senr, being duly sworn, testified that in conversation with Adam on the subject of a certificate that he gave instructions to John Files, Junr. to set his name to a certificate if it was necessary to procure license.

The Session, after mature deliberation, were of opinion that the 1st Charge against John Files, Senr was not supported; but that is irritation of feelings and temper was wrong, & contrary to the Gospel, for which he should be admonished.

They considered further that the second charge was not supported.

After mature deliberation they were of the opinion that the first charge against Wm E. Files was supported, for which he should be admonished.

They considered that the 3rd charge was not established.

After mautre deliberation they were of the opinion that the 1st charge against John Files, Junr was not supported, but they were of the full opinion that he indulged a bad spirit, and acted in a way unbecoming a Christian, for which he should be admonished.

They considered the second charge as not supported.

They considered the third charge as not supported agreeably to the face of the accusation, but that he was entirely in the wrong in doing what he acknowledged to have done, for which he should be admonished.

Your failing (this) will be considered a sufficient reason to withdraw fellowship from you untill you repent.
