that diocese, which includes both Kings and Queens Counties. The list includes date of establishment, its early ethnic focus, if it has been merged with another parish and that parish's name and the date of merger, and present and former parish addresses, with telephone number. The diocese itself is conducting an inventory of extant sacramental records and looking into bringing pre-1921 sacramental records to a central repository for safe-keeping.

A researcher should, if possible, determine where the family lived in the period being researched, and using maps of the time locate nearby parishes existing at the time of residence. Remember, too, that while a parish may have been an "Irish" parish, all of its communicants were not necessarily of Irish extraction. The first parish in Brooklyn was established in 1825 and in Queens in 1843.

The Brooklyn alphabetical list of 144 parishes (with a helpful locator map) was published in the December 1996 publication of the society, and Manhattan parishes were discussed in its September 1996 *Newsletter*. Here's a sampling of the Brooklyn Diocese list:

group record archive sheets, and the LDS Temple Index bureau.

Next, try to find death certificates because they provide many clues that may include naturalization status, name of doctor, name of cemetery, etc. If you can identify the church the ancestor attended, U.S. German church records are especially detailed. They may be available at the FHC on microfilm.

Of course, vital records and census, plus family histories should be consulted. For German sources, begin with ship passenger emigration lists. Some German states have emigration lists. If the place is found, first check to see if microfilm is available. If not, then use form letters to write the parish for records.

If a village name cannot be found, try two courses of action for your search. (1) Look in lineage books for the place(s) of the surname in general. (2) If you see frequent mention of a physical geographical landmark—river, lake, mountain, large city, etc., pinpoint the location of that in the Meyers Gazetteer. Then use form letters to write German genealogical societies and nearby parishes.

If looking for a “Palatine” try to find your surname in one of three main sources: Strassburger’s *German Pioneers*, Rupp’s *30,000 Names or Emigration from Wurttemberg* and copy all names of others on the same ship. Look for your ancestors in Pennsylvania, but if you don’t find a village for them, then look for each of the other names copied until you locate someone for whom a village is recorded. Write that place for your surname, assuming that all persons on the same ship came from the same place. *Fairfax GenSoc, Vol. 15-2, Nov. 1999.*

**ANCESTORS DRINKING ALCOHOLIC BEVERAGES?** Most of our ancestors probably drank alcoholic beverages. #### **LAND MEASURES OR HOW BIG IS THE GARDEN?**

An acre of land is supposed to be the area that could be plowed by an ox in a day. A hide of land, about 120 acres, is the amount of land that an ox could plow in a year. A hundred hides was the original of the subdivision of a county in England called a Hundred, a term still used in certain areas. The term was used in Delaware in Colonial times. (*Ellen Payne Odom Genealogy Lib, Dec. 1999/ Jan.2000*)

**SNAKE BITE ANTIDOTE.** "The Big Springs Copperhead" When Grandma and Grandad lived at the Big Springs, Delaware Co., OK, they had a smoke house. One day Grandma sent Grandad out to the smokehouse to get a jar of peaches for dinner. While Grandad was in the smokehouse, he noticed that some of the fruit jars on the shelf needed straightened up a bit. So after straightening them up, he reached down to get the jar of peaches and on the jar was a copperhead snake. It bit him on the left hand and finger. After killing the snake, Grandma took Grandad to a neighbor lady who was an Indian. She mixed some roots together and told them to make a strong tea, pour it over his hand, letting it run down his fingers, and wrap his hand. Next, bury the snake and wait 18 days to dig it up. If the snake had rotted, then unwrap Grandad's hand and the rotten part would fall off, and new skin would be growing. So they went home and followed the directions exactly. Eighteen days later they dug up the snake and there was no snake. So they unwrapped Grandad's hand, the rotten part fell off and new was growing back, just like the Indian lady told them. (Ed: Take a copy of this and carry it with you while out in cemeteries, beating the bushes for that elusive tombstone. Or getting a can of peaches from the smokehouse.) Started in December 1997 by Nancy Trice with a single county in Kentucky, the demand soon spread nationwide and worldwide. There are three types of boards: (1) those where you can post to and respond to queries, (2) those you can post to, but queries are not allowed, and (3) boards which are read-only. ### HEADSTONES OF UNION CIVIL WAR VETERANS.

Through the Malcolm Stern NARA Gift Fund, Microfilm M1845 has been published, consisting of 22 rolls of microfilm. These records consist of 3"x5" cards arranged alphabetically by surname, then by given name. Information about each soldier includes rank, company and regiment; place of burial, including the cemetery, community, county and state; grave number, if any; date of death; name of contractor who supplied the headstone; and the date of the contract under which the stone was provided.

The gravestones were provided for Union Civil War soldiers who died between ca 1861 and ca 1903. A few War of 1812 and at least one Revolutionary War soldier are also included. The gravestones were provided by the Federal Government between ca 1879 and ca 1903 under contracts entered into with private companies. In addition, the Berlin Document Center in (then) West Berlin housed biographical records generated by the Nazi Party including the SS, SA and others. In 1994 these records were given to the German national archives with the understanding that microfilmed copies would also be placed in the National Archives of the U.S. The approximately 40,000 microfilms are indexed and housed in the National Archives Textual Reference Branch at Archives II (8601 Adelphi Rd., College Park, MD 20740-6001.) The National Archives does not provide a search service for persons seeking facts about family members who may be in these files. However, the staff will search the index for named persons and inform researchers about which rolls of film contain their files. Researchers can then purchase copies of the rolls or view documents at the facility.

**COPYRIGHT EXPLAINED: SUMMARY.** By Brad Templeton (permission granted to copy.)

These days, almost all things are copyrighted the moment they are written, and no copyright notice is required.

Copyright is still violated whether you charged money or not, only damages are affected by that. Postings to the net are not granted to the public domain, and don't grant you any permission to do further copying except "perhaps" the sort of copying that the one posting might have expected in the ordinary flow of the net.

"Fair use" is a complex doctrine meant to allow certain valuable social purposes. Ask yourself why you are republishing what you are posting and why you couldn't have just rewritten it in your own words.

Copyright is not lost because you don't defend it; that's a concept from trademark law. The ownership of names is also from trademark law, so don't say somebody has a name copyrighted. Copyright law is mostly civil law where the special rights of criminal defendants you hear so much about don't apply. Watch out, however, as new laws are moving copyright violation into the criminal realm.

Don't rationalize that you are helping the copyright holder; often it's not that hard to ask permission. Posting E-mail is technically a violation, but revealing facts from E-mail isn't, and for almost all typical E-mail, nobody could wring any damages from you for posting it. To have a copy is not to have the copyright. All the E-mail you write is copyrighted. However, E-mail is not secret, unless previously agreed. So you can certainly "report" on what E-mail you are sent and reveal what it says. You can even quote parts of it to demonstrate.

(The author, as publisher of an electronic newspaper on the net, makes his living by publishing copyrighted material in electronic form and has the associated biases. Do note that while most of these principles are universal in Berne copyright signatory nations, some are derived from Canadian and U.S. law. This article is not intended to be a complete treatise on all the nuances of the subject.)
