Minnesota County Officials: Big Stone County, 1873-1941

The following list contains names of Big Stone County officials from 1873 to 1941. The names are transcribed from the Inventory of the County Archives of Minnesota, No. 6 Big Stone County (Ortonville), prepared by the Minnesota Historical Records Survey of the Work Projects Administration and published in August 1943. It includes the following officials: county commissioners (1873-1941), auditors (1874-1941), registers of deeds (1874-1941), clerks of the district court (1874-1941), judges of the probate court (1874-1941), court commissioners (1881-1941), coroners (1874-1941), sheriffs (1874-1941), county attorneys (1878-1941), treasurers (1874-1941), county superintendents of schools (1874-1941), county surveyors (1874-1918), highway engineers (1921-1941), and agricultural agents (1912-1924, 1933-1941).

No attempts have been made to verify the accuracy of this information or to confirm the spelling of the names. Incumbents in office as of 1941 show that date in parentheses; their terms probably continued thereafter. The original publication usually includes the month and day on which the official's position began and ended. Copies of the original publication

may be found in the libraries of the Minnesota Historical Society and the Minnesota Genealogical Society.

The territory that became Big Stone County was originally part of the territorial county of Dakota. On 5 March 1853 it became part of Pierce County and was attached to Nicollet County for judicial purposes. Big Stone County was created from Pierce County 20 February 1862. In 1866 it was attached to Renville County for judicial purposes. Two townships of Big Stone County became part of Stevens County on 6 March 1868, and on 27 February 1873 the county was attached to Stevens for judicial purposes. The governor appointed county commissioners in 1874 and they operated the county until court action determined the organization was invalid.

The county remained unorganized until 8 February 1881 when it was fully organized. On 1 January 1938 a small portion in the city of Ortonville was transferred to Big Stone County from Lac qui Parle; 8 November 1977 this portion was transferred back to Lac qui Parle and on 22 May 1979 it was retransferred to Big Stone. The county seat was established at Ortonville in 1874 and has remained there.


Book Review

Poles in Minnesota

By John Radzilowski St. Paul: Minnesota Historical Society Press, 2005. 112 p., Paper, \$13.95.

This is a volume in the Minnesota Historical Society's series on ethnic groups in Minnesota.



Dr. Radzilowski recounts the early history of Polish settlements in Minnesota beginning in the mid-1800s and then moves into modern times both in rural areas and cities.

It provides good treatment on the life of the Polish farmer who made up a small minority of Polish immigrants who came to the United States. According to the book, about ninety percent settled in the large industrial cities of the East and Midwest. He devotes most of the book to Polish church communities, organizations, traditions, and the press, and how often controversies among members arose as to their direction.

Anecdotes, quotes, and pictures fill the gaps as well as a number of sidebars dealing with population statistics, food, and other matters.

I believe the author wanted to also provide an insight into the adaptability and tenacity of the early Pole émigrés. Their life and economic difficulties in their homeland, no doubt, to a large measure fostered the migration. There seemed to be a search for their identity in many instances since they largely emigrated from Prussian, Austrian or Russian-controlled areas—not the Polish nation. Often Poles were never properly recognized. Maybe it was their lot that one of the first planned Polish farm communities in Minnesota was in Lincoln County which had marginal farm land and for many years was the poorest county in the state according to family income.

Later chapters deal with the Poles and their relationship with the outside world. While it is not an allencompassing history, it does provide a flavor of their early history, progression and assimilation in the state.

For me personally it was of great interest since I lived a large part of my early life in some of the communities referenced in the book, being born in Winona and living my school years in the Ivanhoe-Wilno area of Lincoln County.

The book is a good read for Minnesota Polish; for genealogists who are writing their family history and want to supplement it with some historical information; and for those interested in sociological aspects of Minnesota history.

The book comes in a handy 6x9 paperback (101 pages) and is indexed by name, place, and topic. There are over ninety end notes and many references for those who would like to probe further into the subject.
