Tombstone of Child Found Under House

The tombstone of a child who died 92 years ago, was discovered in mid-June during demolition of the old Kirby house, 4 miles east of Mt. Vernon. Wrecking crews found the tombstone under the front porch.

The inscription reads: Infant son of Fillmore and Lucretia Kirby, Died Aug. 6, 1886. Crews worked around the stone until it could be determined whether this was the actual grave site.

News of the find was relayed to the Lawrence County Historical Society with an appeal for help. Kirby family records, filed with the Society by family historian Mrs. Elsie Kirby Allen, of Pierce City, listed the infant. Mrs. Allen confirmed the child died as a baby, but is buried in the old City Cemetery at Mt. Vernon. The grave is marked. Evidently, at some time, a new stone was set to replace the old one.

The infant is a brother of the late Dale Kirby who lived east of Mt. Vernon. "My father said he wanted to be buried by his little brother," Mrs. Allen said. One surviving sister, Miss Fama Kirby, now 84, lives in Los Angeles, California.

Mrs. Allen said she did not know how old the house was, but the farm was purchased by her grandparents, Millard Fillmore and Lucretia (Gibson) Kirby about 1894, and they moved there about 1897.

The Kirby family has been in Lawrence County since 1840.

Some Powell Family Data

My great-greandfather Thomas H. Powell fought with the Confederates in the Civil War and came to Texas in 1870. He married Martha Ann Borah (24 Apr. 1847-31 Mar. 1931). She is said to have been a first cousin of Senator William Borah of Idaho.
