This is an abstract of the above named probate record book in Polk County, Missouri. To the best of my knowledge it is one of the earliest probate books for the county. The original book doesn't have an index and this will serve to provide that.

The book contains 228 pages and not much real genealogical information is provided by the content of the records. If someone is looking for the approximate death date of an early Polk County resident, it might be found in these records. There is a note at the beginning of the book referencing another Polk County probate book which might possibly contain additional will records for the same time period.

In addition the names of the administrators will provide the reader with information as to their residency in those early years.

Most of the records are for those people who died intestate; a few of the records are for people who had wills. If the decedent had a will it is stated in the abstract; otherwise, the decedent was intestate. An example of the page number is: A170.
