Naturalizations for Germans in Otsego County, 1806-1883

The following records were extracted from the naturalization records for Otsego County. Records were included for some German regions even if not actually from Germany (eg Switzerland, or Alsace Lorraine). The information provided is not always the same for each record. The court clerk making the record may not have always spelled the person's name correctly. Where there is a difference between the spelling in the record and the way the subject of the record signed it, the spelling of the signature is enclosed in parentheses. Spelling of German place names may not be correct, but have been extracted as spelled in the records.

During this period, an individual was not required to file a Declaration of Intention if he came into this country while under the age of 18. Instead, when filing the Petition for Naturalization, a document was filed declaring that the individual entered the country under the age of 18. In the records abstracted below, DI and NA stand for the Declaration of Intention and the Petition for Naturalization respectively.

Heinrich (Henry) Staring

Alan Sterling, Interpretive Programs Assistant at the General Herkimer Home State Historic Site spoke on his ancestor, Henrich Staring. Alan began by stating that he grew up believing in two main books: "The Bible" and "The Starin Family in America" by William L. Stone, Albany 1892. He looked up the meaning of "bible" and it is "any book considered to be authoritative in its field." There are many legends about events and persons in the Mohawk Valley in the Revolution. Some are probably exaggerated but he believes Henrich Staring's story to be fairly accurate.

Heinrich Staring is Alan's great-great-great-great grandfather. Heinrich or Henry was of Palatine stock, married a Palatine – Elizabeth Hess. He survived the "ambush in the woods", (Battle of Oriskany). Heinrich was a captain in the 4th Tryon and later became a Colonel. He was a delegate to the New York Convention for the purpose of ratifying the Constitution. He was First Judge of the Court of Common Pleas of Herkimer County. Heinrich died in 1808 as a result of a fall from a horse. He died before he was eligible to file for a military service pension. There is no account, diary, or letters that he left to verify his adventure. Heinrich was in Colonel Peter Bellinger's regiment and was listed as being captured. His story was first told at an early date. Therefore, Alan believes it to be true.

The story takes place some time in late November 1778 or 1779. Heinrich Staring was in the woods some distance from his home when he came upon a part of hostile Indians. They captured him and took him to a small cabin or wigwam, near what is now Deansboro, about a quarter of a mile from Oriskany Creek. There were 2 rooms and he was placed in the smaller room which had a small window high up on the wall. He was tied hand and foot. He understood enough of the Indian language to hear that they decided to put him to death in the morning. He knew he must escape. He managed to get one hand free and took off his boots to free his feet. He feigned sleep when they checked on him and he waited till they were asleep and climbed quietly out the window, dropping to the ground. Unfortunately, he forgot his shoes. However he was free and he headed for the creek. Before he got half way to the creek, he heard a shout and the Indians were after him. He ran the rest of the way to the stream and jumped in and ran down stream in the channel. His wool stockings soon were worn out from the sharp pebbles in the stream. He ripped off his shirt sleeves at the elbows and put them on his feet. He reached Fort Schuyler at dawn and found a canoe and returned home.

After the war, Henry Staring was a Judge. One Sunday morning he saw a man on horseback coming along the highway from the west. The laws of the state prohibited travel on the Sabbath, so the Judge asked the man to stop and inquired of him the reason why he was disregarding the law. The stranger was a New England Yankee and did not excuse his conduct to the judge's satisfaction. He declined to stop over until the next day and was given a fine of six York shillings imposed by the statute for the infringement of this branch of it. After paying his fine, the traveler asked the judge to give him a certificate to that effect, urging the necessity of it to protect him against being again called to account by some other magistrate. Judge Staring thought the request was reasonable and asked the traveler to write one and he would sign it. This was done and the traveler proceeded eastward. Some months later, Judge Staring visited the merchants Kane in Canajoharie on business. They requested that he pay them the \$25 which he owed them from several months previous when he sent the individual for an order. He at first denied giving such an order, but when shown the signature in his handwriting, he remembered the traveler. This incident was then called the "Yankee Pass", from a supposition that no one except a native of New England had the cunning and audacity to practice so keen and grave a joke.

Judge Staring could speak and understand English however his primary language was German. He could write and read German but not English.
