**Hyde Park Reformed Church**  
**Cemetery**

*This set of records has come to light thanks to the watchful eye of Edith Parker, member and sometime historian of the Hyde Park Reformed Church. The records is a type-script and housed in a bound book with an inscription noted on the inside cover "Given 1937 (to the church) by daughter of Edward Braman". From the transcript of the Hyde Park Reformed Church record book by A.C.M. Kelly completed in 1979, we learn that an Edward Ellsworth Braman was b 12.13.1833 as a son of Samuel H. Braman and Ellen Van Vliet and baptized at the church on 1.5.1838.*

*A comparison was made between the inscriptions recorded by Edward Braman and those found in Dr. J.W. Poucher's book 'Old Gravestones of Dutchess County' pages 127-130 and 141. This resulted in 4 categories:*

- 1 Names on Poucher list but not Braman.
- 2 Differing data between Poucher and Braman lists.
- 3 Names on Braman list but not Poucher.
- 4 Braman's "East Park Cemetery" omitted by Poucher.

**#1 NAMES ON POUCHER LIST BUT NOT BRAMAN.**

*These are identified by number found on pages 127 through 130 of Poucher's book: they are 35, 37, 50, 55, 57, 73, 74, 88d-f, 105, 109, 111, 112, 115, 138-142, 147, 194, 200, 221, 222. Most of these inscriptions are of persons who died after 1900. However, some are of much earlier stones especially those of the MULFORD family where that of Capt. David who died in 1778 makes his the earliest death recorded for the cemetery. The oldest stone in Braman's list is that of Noah Bunnel who died in 1790.*

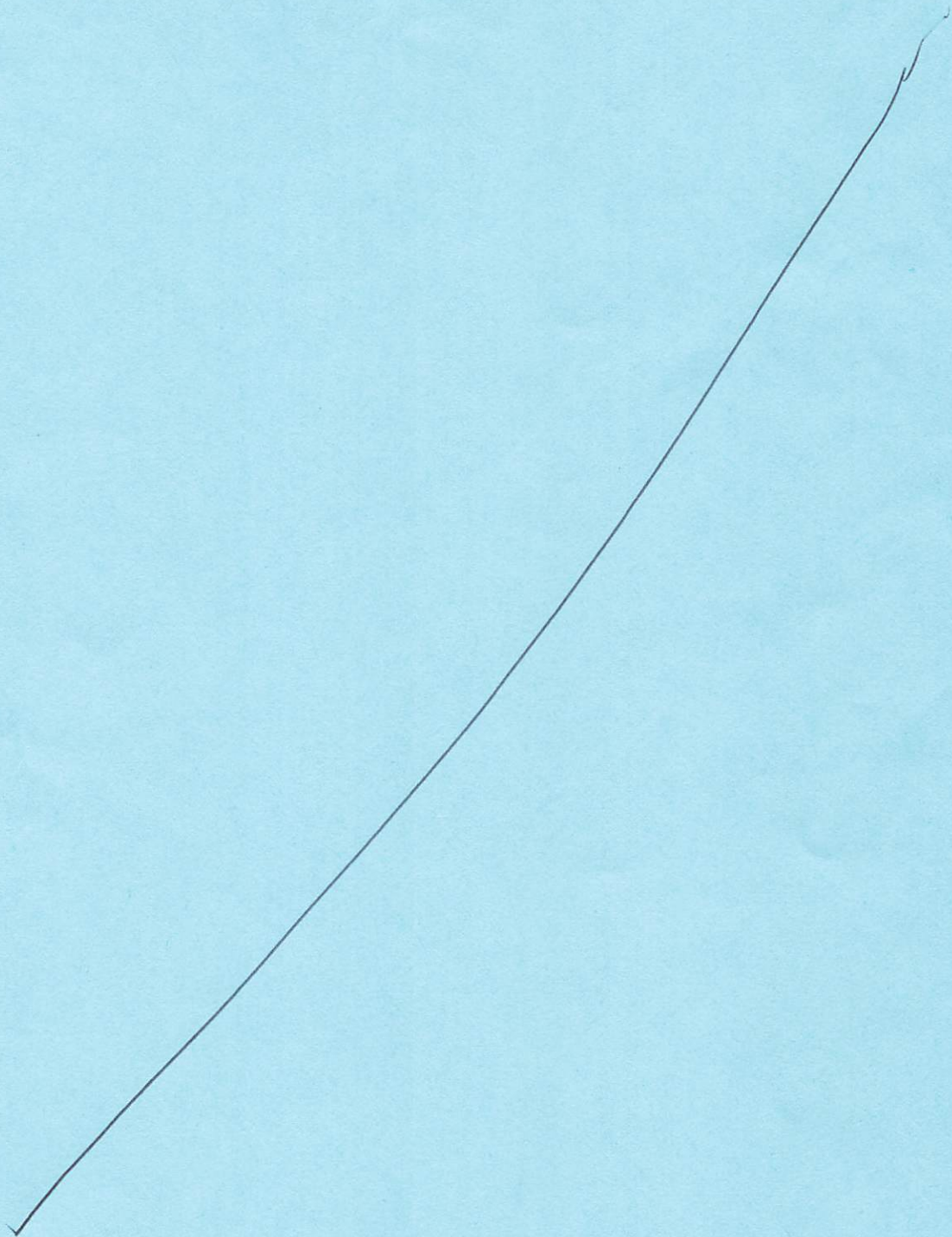
