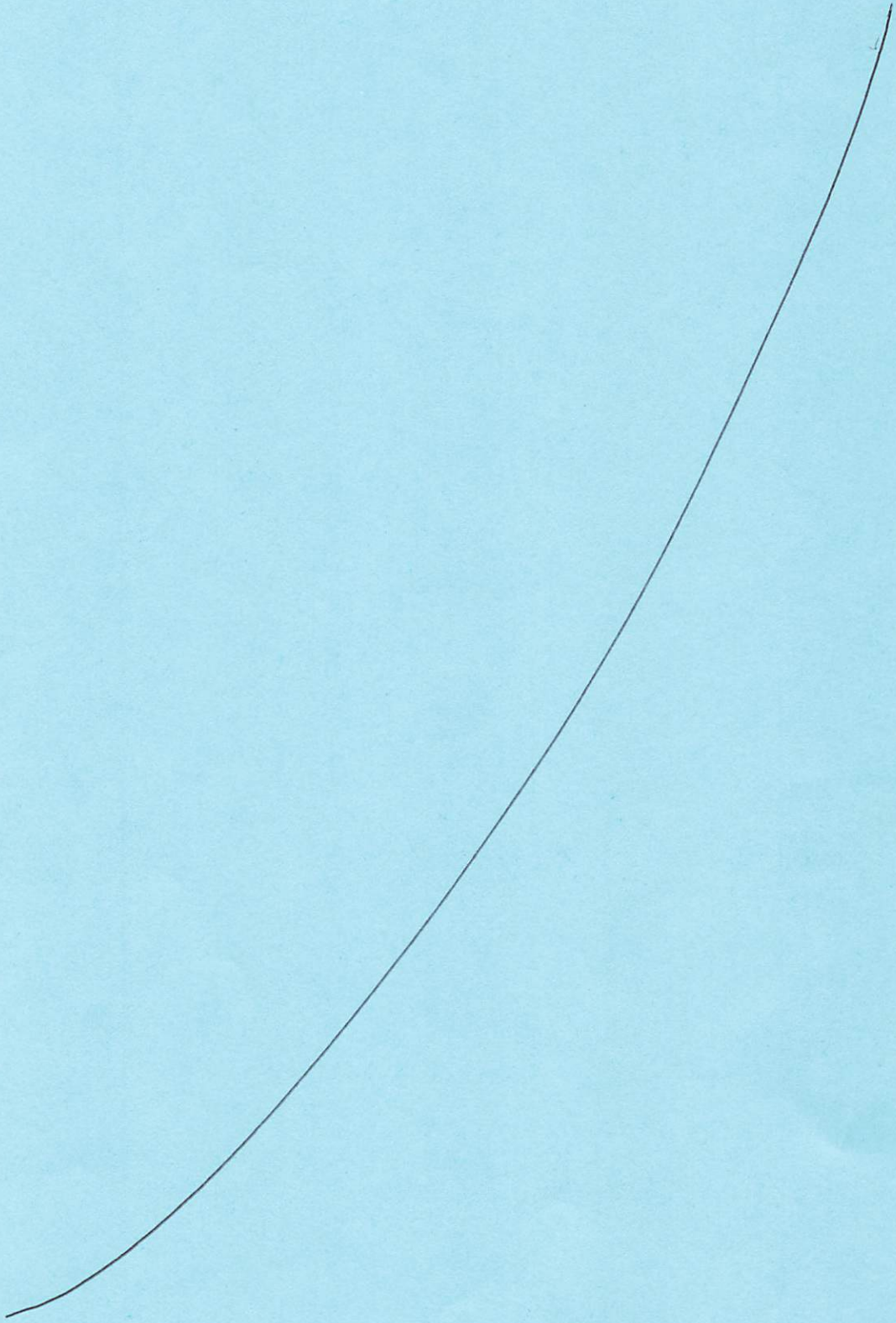

Dalton, Carl Lewis; pharmacist's mate, 2nd class, USN; enlisted in Richmond, VA on 2 Jun 1915; died on the USS TAMPA on 26 Sep 1918 when the vessel was lost. Next of Kin: Father: Lycurgus E. Dalton of Gastonia, NC.

Dellinger, Junius Logan; seaman, 2nd class, USN; enlisted in Richmond 27 Dec 1916; died on the Navy Collier CYCLOPS on 14 Jun 1918 when the vessel was lost. Next of Kin: Father: Albert L. Dellinger of Newton, NC.

Powers, Robert Hardy; painter, 2nd class, USN; enlisted in Raleigh, NC on 4 Jun 1917; died on the Navy Collier CYCLOPS on 14 Jun 1918 when the vessel was lost. Next of Kin: Mother: Mrs. Mary Powers of Asheville, NC.
