They returned to the homes they so nobly defended, and now that they are no longer able to stand with us between the enemy and what is dear to them. We promise them that no traitor shall disturb them while we are blessed with health and bullets.

The dead we shall never forget; each new grave brings to our recollection all the graves of our departed braves; and we can look back along our winding path, even to our first camp in Ohio and see the graves of our brothers scattered along like way marks.
