Abstracts from Here and There

From *Pittsburgh Christian Advocate* newspaper – Ebenezer BARNETT of Monroe County, Ohio, to Margaret MCGILL of Wheeling, Virginia, 20 May 1849 by Rev. G. Cranage.

Wheeling Daily Register, Tues. 8 Oct. 1878, pg. 4 under the "City Chips" column:

Yesterday morning a family by the name of SCHAFER, eight in number, all of Sardis, O., registered at the St. James, and left for the West last evening, en route for Kansas, where they go to make their future home. (This probably refers to St. James which was a hotel in Wheeling at that time.)

DIED OF HIS INJURIES: The Fatal Accident on the Ohio River Road.

The following additional particulars of the accident on the Ohio River road, near Sardis, mention of which was made yesterday morning, were procured yesterday. The man, who was between seventy-five and eighty years of age, was standing on the track, when the gravel train, which was heavily laden, ran into him so suddenly that he had not time to make his escape, nor the engineer time to stop his train, though the engine was immediately reversed and the brakes put down, and the train was almost checked when it reached the victim. He fell a distance of thirty-five feet to the frozen ground and was almost unconscious when reached, but was still rational enough to say he had no friends in this country, but had a brother in Ireland. He was put on the train and brought up to New Martinsville, where his wounds were dressed, but he was beyond medical aid, and only lived till yesterday morning. He was spare built, five and one-half feet high, blue eyes, gray mustache and chin whiskers, right leg had been once broken between the ankle and knee and badly set, decently dressed, and the letter 'D' in India ink under the left arm. Nothing was found on his clothing by which he could be identified, except the names 'John GOUDY, of Henry county, Ind.' and 'Margret RANKIN, Hopwood Fayette county, Pa.,' on a slip of paper, and the cards of Sarah BOYHAND and Frank A BISHOP and a Catholic rosary."

Woodsfield, April 13 – Mrs. Louis SCHUMACHER died at her home on Main Street early Saturday morning. Mrs. Schumacher was a Christian woman and she will long be remembered for her kind acts, and will be much missed in the community. Beside her husband, she leaves three children, Roy and Fred of Woodsfield, and Elmer Schumacher of Massachusetts. Services will probably be held Monday, depending on the arrival of relatives from a distance.

Fred RHINES, aged 84, and a family figure of years, died at his home Friday evening of infirmaries. He leaves a number of children. Services were conducted from the late home Monday afternoon and burial made in the Ozark cemetery.

William MCDUGAL father of prosecuting attorney, A. C. McDougal, died on April 7, at the farm in which he was born near Beallsville, 87 years ago. He was one of the early pioneers of that section and fostered various activities of the community in which he spent his entire life time. He served as a Justice of the Peace for twenty years. He was buried at the East Sunbury Baptist church of which church he had been an official for many years.

Jerilyn Koskan sent us the following item which she found in the *Wayne County Press*, Wayne County, Illinois, 21 Dec 1922.

Mary, daughter of G. W. and Lydia Spaulding, born Monroe County, Ohio, Feb. 2, 1855. Married William Archibald Nov. 27, 1872. Six children: Lydia Ray, Celia Brooks living. Four dying in infancy. Husband died Feb. 16, 1888, 2nd marriage to John Mitchell, Mar 29, 1893. He died 1898. 3rd marriage to Richard Copeland in 1904. He died Apr 28, 1918, leave 2 girls, Mrs. Lizzie Evans of Noble and Celia Brooks of Cisne. Two sisters, Mrs. Ollie Ray and Mrs. Linnie Squire of Cisne. Four brothers, D. G. of Wabaunsee, Kansas, David of Salem, Oregon, H. L. of Kansas City and G. A. of Geff.

John Ogden sent us this item from the 5 Jul 1845 *Spirit of Democracy*.

Died on Sunday evening last, Mr. John Walters, of this township, aged about 84 years. Mr. Walters was a revolutionary soldier, and has for a number of years been receiving a pension from the United States. Out of ten Revolutionary pensioners residing in our county in 1840, there are but three now living.

By the way, there are Freudiger names in the records of Niederbipp and Oberbipp, so this family probably came from the same area as the Haudenschild family.

Finding this record about the widow of John Haudenschild whose name was Elisabeth Smits (Schmiz in Switzerland) meant that the christening record that I had found of Johannes Haudenschilt in Niederbipp was the same person who is an ancestor of both Julie Kamp and Kym Kittell.

So I was able to locate European records on both the Schenk and Haudenschild families. The information found in the German and Swiss records matched well with what was know by Julie and Kym from records found in American records. We couldn't find anything on Catharine Schenk in America before she married in 1850; the Haudenschild family was here by 1840, probably in 1832.
