David Huston, Monroe Tp., Richland Co., [pg. 149], January 5, 1872 - August 22, 1874

First, all just debts be paid, Secondly, the selling of farm as agreed to sons, Alva and Wils Huston. Third, bequeath to my son Geo W. Huston the sum of six hundred dollars from contract between me and my sons, Alva and Wils to be paid as follows: The sum of one hundred dollars by each in one year from the decease of myself and wife, one hundred by each in two years and one hundred by each in three years. Fourth, at the decease of myself and wife, all personal property to be equally divided between my three sons. If they are unable to divide it my executor shall call upon two of my neighbors to divide it and each of my three sons to pay one third of the expenses incurred in selling my estate. Fifth, I nominate my friend Joseph Hastings as Executor. Witnesses: Michael McNeal, Joseph Hastings.

John Bender, Richland Co., [pg. 151], April 10, 1867 - August 27, 1874

First, all just debts and funeral expenses including tombstones shall be paid. Secondly, I bequeath to my beloved wife, Susan Bender, if she should survive me all my personal property except moneys, notes and accounts: I bequeath unto her twenty five hundred dollars in money, to be placed in the care of my Executor for her support and comfort with the interest to be paid to her annually. Third, if any of that portion given to my wife should remain at her death, I will that after her funeral expenses be paid the balance shall be distributed equally to my four children, Elizabeth Van Horn, Annah Cline, Sarah Whisler and Susan Weiser. Fourth, After my death my Executor shall convert all my notes and accounts into money, sell any real estate undisposed of, and after retaining the amount bequeathed to my wife, the balance shall be distributed to my said four children equally. Fifth, I nominate my son in law, Adam Weiser, as Executor of my last will and Testament. Witnesses: William Owings, John Meredith.

Benjamin F. Olin, Richland Co., [pg. 153], March 7, 1873 - August 29, 1874

To my beloved wife Betsey I bequeath all the household goods and furniture we now own and two cows. I also give to her of my land as follows: the west third of the barn, all that part of the orchard which lays east of a line running north from the northwest corner of the barn to the land of Samuel Lantz and the use of the barn yards, the use of the house in which we now live, the yards, the outbuildings, the use of the east half of the garden, and the farm as it lays east and north of the lines drawn as follows: beginning at the northwest corner of said dwelling house running west to land running north and south, thence south, parallel with the east boundary line of the northwest quarter of Section 14 in Township 19 of Range 19 in Richland County, Ohio, to the south boundary line of said quarter. Also the following described wood lot in said quarter section to wit: beginning at the southeast corner of the woodland on the south boundary line of said quarter, running thence west thirty rods; thence north twenty seven rods; thence east parallel with said south boundary line thirty rods; thence south twenty seven rods to the place of beginning. Second, I bequeath to my son Gideon one thousand dollars. I bequeath to my son Gideon and my daughter Catharina, wife of George Hill, all my stock and farming tools and implements to own the same in common. I give to my son Gideon, daughters Catharine Hill and Elizabeth Olin all my real estate to be held, owned and possessed by them in fee simple, subject to the above devise to my wife, to said legacy to my son Gideon, and all just claims against me in which is included a mortgage of myself and wife to Abraham B. Olin, they to own the same in common and bear an equal part in the payment of said claims. Executor: Gideon Olin. Witnesses: Reuben Evarts, John Steel, G.W. Parker.

John Zeigler, Bloominggrove Tp., [pg. 155], Feb 25, 1874 - September 8, 1874

First, I give to my beloved wife the farm on which we now reside situated in Bloominggrove township, Richland County, Ohio containing about one hundred and sixty acres, during her natural life, and all the stock, household goods, furniture and other goods and chattels during her natural life. Secondly, I give to son Solomon Zeigler three hundred dollars, to be paid to him within two years after my decease. Third, I have given to my son Martin Zeigler by warranty deed sixty acres of land valued at two thousand five hundred dollars as his share of my Estate. Fourth, at the death of my said wife and after debts are paid and the legacy to my son Solomon Zeigler are paid, the real Estate aforesaid and also all my personal good, moneys and credits I give to my three daughters, Lovina Burns, Catharine Zeigler and Mary Alice Zeigler to be equally divided. Executor: Andrew Adams, my friend. Witnesses: Ira G. Hackett, Joseph P. Hunter.

Findings from Old Court Packets

The Society holds original records from the Court of Common Pleas. We are working currently putting them into archival folders and Jan Purvis is making an index for the records so the public may have access to them in the near future. The following case has been edited for publishing but a complete copy is available from the Society.

Going to the Gold Fields

An Article of Agreement between Wm S. Granger and James Purdy was signed by Samuel Doyle, John A. McCoy, John Whitnaur and Jacob

Markley for the following services.

Purdy and Granger have agreed to pay Doyle, McCoy, Whitnaur, and Markley each the sum of one hundred seventy five dollars, and they each agree to purchase and procure wagon teams, harnesses, provisions and other things necessary for an outfit for the journey and proceed without delay across the mountains to the gold diggers or some place in their vicinity in the State of California, and to labor for the space of one year at least, after their arrival at digging gold, at a mechanical business or such other employment as to them seems most profitable. The company of men shall keep a full account of all money expended, in fitting the expedition and making the journey.

Any property purchased shall be the joint property of all concerned, one half belonging to said Purdy and Granger and the other half to the parties of the men. They shall send a transcript of the account book to Purdy and Granger monthly by mail and the amount due Purdy and Granger shall be paid to C.H. Cummings or such other person as they shall name.

At the end of the term above stated said parties shall return to Mansfield, their expenses to be taken out of their gross earnings and property on hand shall be rendered and amount due said Granger and Purdy paid. The party of men agree to leave Cincinnati on their journey by the 28th day of March 1850.

......A deposition, of ten pages, was presented to the Grand Jury & filed March 2, 1852, by James Cobean, Jr., a Justice of the Peace, Madison Tp. on behalf of Jacob Markley the defendant. Purdy and Granger, are the Plaintiffs.

Jacob Markley agreed that he signed a contract with Purdy & Granger, and he arrived in/at the gold diggings in California on July 18, 1850, and that

he did not keep an account of expenses as required "by reason of not being scholary sufficient to do so".

He states that upon arriving at the gold fields he worked at digging out a tree stump for \$3.00 a day, then went to work digging in the gold fields, working in Hangtown, Colee Spring, Am—can River, Green Wood

Valley, Devil's Cannon.

Markley often would answer the question of how much he made at the diggings with "I can not recollect", he did agree that he made some 10 to 14 dollars some days, more or less on others and worked with Peter Ludwick for a few days. He had about \$720.00 in dust when he left Devils Cannon and was moving on tp Greenwood Valley and then on to the south fork staying on the south fork until July 27th when he left arriving August 1st, at San Francisco to board the steamer and he did not get off it until August 3, 1851.

The cost of the trip from San Francisco to Panama was about \$130.00 to \$140.00 and it cost \$10 to \$12.00 across the Isthmus, and down the Chagus River cost about \$12.00 where he was detained for a week, costing about \$40.00 and from Chagus to New York was about \$100.00, being detained in Jamaica 2 or 3 days with costs of \$80.00 and then from New York to home \$15.00 and I kept no account of my expenses coming home.

Markley states that he did not correspond with the defendants because he cannot write, and he left the account book given to him by Purdy & Granger at home when he left for California. He admitted he received a couple letters from his wife, they being written in German. He sent her \$125.00 once.

.....We do not know the finding of the court on this case. Hopefully as we get them indexed it will be located and we can give you the results.

....Jacob's name has two spellings in this document. It is spelled as Markle and Markley.

Article of Copartnership May 27, 1859: L.B. Matson and I. Newton Ayres entered into a copartnership in the practice of Law under the firm name Matson & Ayres. Matson is to have and receive three fourths and Ayres is to receive one fourth of the income and proceeds of the business, Matson will pay three fourths and Ayres one fourth of the legitimate and necessary expenses of the keeping up of the office and business of the firm. Said parties are to give close and faithful attention to the business of the firm and can only be dissolved by mutual consent, in writing. [Included in this packet are the certificates for Isaac Newton Ayres admission to the Bar on August 31, 1858 and appointment as a Notary Public on July 22, 1859].

Geo. Carey, Lexington, Richland Co., [pg. 156], July 3, 1871 - September 21, 1874

First, all just debts and funeral charges shall be paid. Secondly, I give to my grandson George Carey, son of Henry S. and Margaret Carey, who now reside in the State of Iowa, the one undivided half of Lot number 30 in Degraff, Humphreys Addition to the village of Quincy, in the County of Logan, State of Ohio, to his heirs and assigns forever. Third, I give to my grandson Carey Pratt, son of Moses L. Pratt and Sarah Pratt, now residing in Quincy, Logan County, Ohio, the other one undivided half of said lot number 30 in Humphreys Addition to the said village of Quincy, Logan Co, Ohio and to his heirs and assigns forever. Fourth, I give to my granddaughter Dellia Carey, daughter of George W. Carey and Margaret Carey, now residing in Lexington, Richland County, Ohio the following premises in the county of Richland, village of Lexington known as Lot number 89 on the recorded Platt of the Corporation of Lexington, to her heirs and assigns forever. Fifth, I do forgive, cancel and make void to my son George W. Carey, two promisory notes made by him to me. One for \$100.00 and the other for \$200.00. Sixth, I give to my granddaughter Aseneth Kizor of Paris, Champaign County, Ohio, daughter of Isaac and Rosannah Carey the sum of \$25.00 to be paid within one year after my decease. Seventh, All other real and personal property I bequeath to my sons Simon B. Carey and George W. Carey, and my daughter Sarah Pratt, to be equally divided. Eighth, I desire after my decease my said Executor procure and have placed on my grave proper tombstones not to exceed \$50.00 and that my said Executor procure tombstones and place them on the graves of my first and second wives, neither to cost more than \$50.00. I desire that said Executor procure the services of my son George W. Carey to procure and put up said tombstones. Lastly, I appoint George W. Carey as trustee of the above named Dellia Carey to hold said lot and premises devised to her until she shall become of age or get married. I appoint my daughter Sarah Pratt Trustee of the premises devised to Carey Pratt until he comes to be twenty one years of age. George Carey, being of suitable age to select a proper trustee to take charge of premises devised to him until he shall be twenty one years of age. Executor: George W. Carey. Witnesses: James M. Blair, G.W. Fry

Codicil, July 3, 1871 - September 21, 1874

I authorize Trustees George W. Carey and Sarah Pratt to bargain, sell and alien in fee simple all the premises devised in said last well and testament to said Dellia Carey and Carey Pratt, provided that said property shall only be sold if the said Trustees deem it to the interest of said Dellia and Carey and money to be invested in such a manner to be in the best interest of said Dellia and Carey. Witnesses: James M. Blair, G.W. Fry, Lexington, Ohio.

Susannah Carr, Mansfield, Richland Co., [pg. 161], September 8, 1874 - October 1, 1874

I comit my body in a Christian burial to the Earth in the Cemetery at Warsaw, Wyoming County, New York. I bequeath to my beloved Niece Mary M. Seelye, all personal property and also all that remains of the \$200.00 with interest, after my funeral expenses now held in trust by Welcome Arnold of Warsaw. I appoint J. Edwin Seelye of Mansfield, Ohio as my Executor. Witnesses: Elias Troutman, T.S. Weatherby, Lyman A. Parrish.

Charged with Enabling a Slave to Escape

State of Ohio vs William Lyon:

Indictment for furnishing facilities to enable a

slave to escape. Filed November 12, 1842.

......We find that William Lyon, late of Richland county heretofore on the first day of June in the year of our Lord one thousand eight hundred and forty two, with force and arms, at Richland County unlawfully did furnish to one James Monroe (he the said James Monroe then and there being a Negro and black person, and he the said James Monroe then and there by the laws of the State of Kentucky, owing labor and service to a certain person of the State of Kentucky) other facilities with the intent and for the purpose of enabling the said James Monroe to escape from and elude the claimant of James Monroe. Lyons furnished the said James Monroe with food, and acting and serving as a guide, conductor and pilot of James Monroe with the intent and for the purpose aforesaid, he the said William Lyon well knowing the said James Monroe to owe labor and service to the said person of the State of Kentucky, contrary to the form of the statue in such case made and provided and against the peace and dignity of the State of Ohio. Edward Thuma living near Woodburry was instantly killed on Monday afternoon. Thuma and James Gifford were felling trees in the latters woods about 2 miles south of Woodburry. They had cut a tree and when it commenced falling ran in opposite directions Gifford cleared the tree and on turn saw Thuma down. By the time Gifford got to his side he was dead.

A large limb had broken off the tree and was thrown about 40 feet from the trunk striking Thuma. The limb was laying across his leg and arm. No mark of any kind that came from a blow that could cause his death could be found upon the body but it was found that his neck had been broken. [Source: The Bellville Star - Jan 26, 1888

Home Entered by Burglars

Desperados entered the house of Michael Oswalt, near Jelloway, in his absence in the early part of the evening, brutally treating his wife, leaving her tied to a chair, and unconscious; they went through the house, but secured no valuables. Mrs. Oswalt was revived and gave a particial (sic) description of her assailants, who will be roughly handled if caught. {Source: The Bellville Star - Jan 26, 1888]

Shiloh Post Office

Historians tell us that the Shiloh Post Office had its beginning at "Planktown" crossroad (as we know it) one mile east of Shiloh. The first Shiloh, Ohio Post Office was established as "Runner's" by Michael Runner on Feb. 22, 1833; changed to "Richland" by Henry Saviers on Jan. 12, 1838; changed to "Shiloh" by Jacob Koerber June 8, 1863. The following postmasters served at the Shiloh Post Office:

Births and Deaths - 1905 compiled by Sherry Norton

- 26-Jan-1905 12:4 Charles T. REID, agent of the Wells Fargo Express company here, has received word stating that his cousin, Leroy REID, residing near Bedford, Ia., was killed in a violet (sic) manner. He was aged 25 years and manager of his father's farm. The young man was caught in the belt of the engine on the farm and thrown on the fly wheel, being so severely crushed that he died in a few minutes. It is only a short time since Mr. REID received the news of the death of his uncle, who was cremated in his own home by falling against a stove which was overturned and the house burned over his head. The second casualty in the family within a month is, indeed, a severe blow.—Ashland Times-Gazette.
- 2-Feb-1905 3:3 Bedtick Valley. A son was born to Mr. and Mrs. John McDANEL, Jr., Friday.
- 2-Feb-1905 5:4 LANTZ Jacob LANTZ, 62 years of age, died Wednesday morning about 6 o'clock at his home in Spring Mill. He leaves a widow, but no children. Funeral Friday afternoon at 1:30 from the church of the Believers in Christ, corner of Diamond and Second streets. Samuel Engwiler will have charge of the services.
- 2-Feb-1905 5:4 COOKSTON Jesse COOKSTON, aged 59 years and 4 months, died Tuesday morning at his home east of the city after lying unconscious for a week as the result of a stroke of paralysis. The deceased leaves one brother, William COOKSTON and two sisters, Mrs. John MARSHALL, of this city, and Miss Martha COOKSTON, east of the city. Funeral Thursday morning at 10 o'clock from the house.
- 2-Feb-1905 5:4 MASON Parvin L. MASON died this afternoon at 1 o'clock at his home, 14 Steel avenue, of a stroke of paralysis. He was taken suddenly ill this morning at 7 o'clock when the stroke occurred and was unconscious part of the time. He died this afternoon at 1 o'clock. He was 59 years of age last July and is survived by a wife, two sons and a daughter. No funeral arrangements have as yet been made. He is the first one of the children to die and it is not known yet where the family will decide to make the interment.--Shelby Globe.
- 2-Feb-1905 5:4 CONDICT A dispatch to the News conveys information of the death of Mrs. Aretta G., relict of Capt. A. H. CONDICT, at Washington, D. C., Jan. 25 at the home of her daughter, Mrs. Frank G. CARPENTER, with whom she had made her home since the death of her husband, March 16, 1904. The dispatch stated that death was due to pneumonia which followed an attack of grip. Capt. and Mrs. CONDICT lived in Mansfield for many years and when, but a little over one year ago, both went to Washington for a holiday visit with their children, and where Feb. 20, the 80th birthday anniversary of Capt. CONDICT was celebrated, it was expected that they would again return to resume their residence among old friends and neighbors in this city. But fate ordered otherwise. Capt. CONDICT died in Washington and his body was laid to rest at Morristown in his native state of New Jersey and there the remains of the long time partner of his joys and sorrows, who was but little his junior, was laid by his side last Monday.

 MOSER David MOSER, an old watchmaker of Dalton, committed suicide by hanging sometime between Monday night and Tuesday morning. The MOSER home is about three miles south of the Dalton village. Some weeks ago MOSER sold his farm for \$6,000, reserving for himself a strip of land to pass his remaining days. On this strip he built new buildings and had the house fitted up in good shape with the modern conveniences. His mind has not been in the best of condition, however, and on account of this his son-in-law, A. A. SUMMERS, has been staying with him and watching him. SUMMERS has been sleeping in an adjoining room with only folding doors between, and these kept open the majority of the time. SUMMERS thinks that the old man arose some time between 11 and 12 o'clock Monday night. When he did get up he went to the barn, took a strap off the harness, and with a stepladder ascended in the hay mow. Here he threw the strap over a beam, hooked it under

his chin and jumped off from the stepladder. He was found early Tuesday morning, cold and stiff, with his feet six or eight inches above the hay. Coroner H. J. Sullivan was sent for and the remains were left hanging for some time pending his arrival. MOSER was well known all over the eastern part of the county. He was a watchmaker of the old school, and was well skilled in his business, doing a great deal of work, most of which was tranacted (sic) through the medium of the postoffice at Dalton, where he left things for his customers.--Wooster Republican.

She leaves a husbnad (sic), John, and two sons, William, of Galion and John, of Barberton. Funeral Wednesday afternoon at 3 o'clock from the house. The Rev. William N. Dresel officiated.
- 9-Feb-1905 5:5 SECHRIST George SECHRIST died Monday morning about 6:30 at his home in Shenandoah from a stroke of paralysis. He was an old resident, having lived in Shenandoah all of his life. He was about 80 years old and leaves a wife and three children.
- 9-Feb-1905 5:5 POTH Mrs. Elizabeth POTH, aged 81, died at the home of her daughter, Mrs. George MARKS, 247 Park avenue east, Sunday at 1:30 p.m., after an illness of seven months with Bright's disease. Mrs. POTH has been a resident of Mansfield for more than 50 years and for many years resided on Altamont avenue. Her husband died 16 years ago. Funeral services at St. John's Evangelical church, conducted by the pastor, the Rev. William Dresel, Wednesday at 2 p.m.

 IHLENBURG Henry W. IHLENBURG died at his home, 582 Spring Mill street, Saturday evening at 6 o'clock aged 64 years. Death resulted from cancer. 

- 26-Jan-1905 6:4 POLAND Bloominggrove. The infant child of Mr. and Mrs. POLAND was buried Saturday.
- 26-Jan-1905 6:5 GRIMWOOD J. E. GRIMWOOD, of Shiloh, was struck and instantly killed by a Big Four passenger train, No. 24, near New London Friday evening between 11 and 12 o'clock. GRIMWOOD was a son of J. B. GRIMWOOD, a Shiloh grocer. He had been married twice, his first wife being divorced. He had not been living with his second wife for some time though they were not divorced. He left three children by this last marriage. GRIMWOOD had been working for a farmer named BRIGGS north of New London, but for the past two weeks was not working and was staying around the hotel in New London. Friday Mr. BRIGGS hired him again to go to work Saturday morning. He sat around the hotel all the evening and about 11 o'clock arose saying he believed he would go out to the BRIGGS place that night. This was the last seen of him until No. 24 brought in the body about midnight. GRIMWOOD gained some notoriety not long ago by hiring a rig in Attica and after filling up started to drive to Greenwich and somewhere between Plymouth and Greenwich he drove on the railroad track in front of an approaching train and the horse was killed. He was arrested on complaint of the liveryman. The last grand jury indicted him for non-support of his minor children and his case was to come up for trial this week. The funeral was held Monday afternoon in Shiloh at 1:30.
- 26-Jan-1905 7:4 BECKWITH Another name was added to the list of victims that have met death in the new east yards of the Pennsylvania company, when Edward BECKWITH, a brakeman on the main line of the Pennsylvania lines and residing at Conway, Pa., was instantly killed by falling beneath the wheels of a freight train Monday evening. The accident occurred about 6 o'clock. The train, of which BECKWITH was the brakeman, was doing some switching in the yards. BECKWITH was on top of the cars signaling the engineer. He had signaled for the train to advance but the engineer did not advance immediately, and when he did put the train in motion the jerk came so suddenly that BECKWITH was thrown from the top of the train beneath the wheels. Every effort was made to stop the train immediately, but the wheels (?)ed over both legs. He was taken to the yard office at the foot of Park avenue east and Niman's ambulance was summoned, but he died before the ambulance arrived. The remains were sent to his home at Conway, Pa., Tuesday morning at 10:27.
- 26-Jan-1905 8:7 LEITER In the case of Samuel LEITER, struck and instantly killed Saturday afternoon near Lucas by No. 17 on the P.F., Coroner Goodman reports: "I do find that the said deceased, Samuel L. I find the engineer whistled the danger signal when he saw the said deceased, but he paid no attention to said signal, and I further find that the said train was running about 35 miles an hour and was one hour late, being due in Mansfield at 1 p.m."

Volume 4 Compiled by Nancy Hidinger

William B. Bradley, Mansfield, Richland Co., [pg. 134], April 10, 1874 - May 4, 1874

I give and bequeath to my wife Clarrissa Bradley, the house and lot in which I now reside for her use all her natural life and I give her permission to sell or rent the property to be invested on good security and to apply to her own use. After her decease the property if not already sold to be then sold and the proceeds of sale divided among the children of my first wife Priscilla Bradley (now deceased). viz: one seventh part to Jane Cross, one seventh part of Margaret May, one seventh part to Mary Miller, one seventh part to Thos Steele Bradley, one seventh part to Elizabeth Nicholas, one seventh part to Priscilla Lasher, one seventh part to James Bradley. I also give and bequeath to my beloved wife Clarrisa Bradley the interest of all monies I now have invested to apply for her use and support. I also bequeath to Ezekial Stokes Bradley the sum of one hundred dollars. I bequeath to my wife Clarrissa Bradley all my furniture and chattels to use during her lifetime and after her decease to be sold and proceeds to be equally divided among the children of my first wife Priscilla Bradley (now deceased) one seventh part to each as aforesaid mentioned. My eldest daughter Jane Cross being now deceased her share in property, money or chattels to be equally divided among her four children, share and share alike. I also desire that in case either of my other daughters should be deceased before my death then their share in property, money or chattels to be equally divided among their children. Witnesses: William P. Clarke, D.H. French

Codicil: William B. Bradley, Mansfield, Richland Co., [pg. 135], April 16, 1874 - May 4, 1874

Having neglected to appoint an Executor, I therefore desire to make and publish as a Codicil to said will the appointment of my friend William P. Clarke, Executor of my Last Will and Testament. Witnesses: W.P. Clarke, D.H. French

John Bookwalter, Richland Co., [pg. 137], November 19, 1872 - May 30, 1874

First, all debts and funeral expenses shall be paid. Second, I bequeath to my beloved wife Catharine the use of my homestead on which I now live as long as she remains my Widow. She shall be entitled to all the rents and incomes of said farm in her own name and use of all the household goods on hand at my death and all personal property she may select for her use. Third, It is my will that upon the death of my beloved wife all my Estate and personal [property] not consumed by her in her lifetime shall be sold and equally divided amongst my Heirs or their representatives, except my son Daniel, who shall only be entitled to one third of one share and Arthur Bookwalter, Daniel's heir one third of one share, Emma Bookwalter Daniel's heir one third of one share. Fourth. It is my will that the shares of Dora Dell, Iona Bell and William Howel heirs of my daughter Catharine, also the shares of Rosanna Dora and Simon Scott heirs of my daughter Eliza, also Arthur and Emma heirs of my son Daniel remain in my homestead until they become of age, it being situated in the county of Richland, State of Ohio, as follows: the West half of the Northwest quarter Section 26, Tp 20, Range 20, containing 76 acres, also the east end of the east half of the Northeast quarter Section 27, Tp. 20, Range 20, containing 14 3/4 acres which shall be paid by the purcher or purchers as they respectfully become of age. Fifth, it is my will that what money is due me at my death be divided as follows: to my wife, five hundred dollars, to my son Simon four hundred dollars, to my daughter Susannah three hundred dollars, to my daughter Sarah three hundred dollars. Sixth, I nominate and appoint my son Simon Bookwalter, my Executor. Witnesses: J.P.K. Riblet, H. Barr

James Mount, Troy Tp, Richland Co., [pg. 138], January 11, 1871 - June 6, 1874

First, It is my will that so much of my personal property as will be necessary be sold to pay all my just debts and funeral expenses. Second, I give to my beloved wife Anna Mount the tract or panel of land on which we now reside containing about sixteen acres with all the appurtenances to use during her natural life. I also give to my said wife, all good, chattels, stock and provisions belonging to me at my death for benefit during her natural life and after the death of my said wife it is my will that the said farm or tract of land on which we now reside together with my personal property be divided among my children as follows...my daughter Barbara to have one half. The remaining or other half to be equally divided among my other three children. I appoint my esteemed friend James Cracraft Executor of my Last Will and Testament. Witnesses: J.M. Mitchell, Lizzie S. Barr

Michael Beam, Richland Co., [pg. 140], February 14, 1874 - June 11, 1874

First, I will my soul to God and my body to the dust from which it came, Second, that my funeral be conducted decently and the expenses of my last sickness and funeral expenses and all debts be first paid. Third, It is my will

that my beloved wife and family remain on the homestead for one year after my death and to have the use of all the personal property that I now hold. Fourth, At the expiration of one year that all my real and personal property be sold by Public Sale and that my beloved wife receive one third of the proceeds of the real estate and two hundred dollars out of the proceeds of the personal property. If my wife should not be disposed to keep all the stock now owned by me she may sell such stock and the proceeds be applied to the payment of two hundred dollars willed to her. Fifth, I will to my beloved wife all the household goods that is necessary for her and the family and the grain. Sixth, After the sale of my real and personal property I will to my daughter Elizabeth Ann Beam one hundred dollars for services rendered after and since she has become of age and the balance of the entire estate be equally divided amongst my children Harriet Arctic intermarried with Musselman Arctic one equal share, Daniel Beam one equal share Michael Beam one equal share, Elizabeth Ann Beam one equal share, Noah Beam one equal share, Martha Ann Beam one equal share and James Jacob Beam one equal share. I appoint my son Daniel Beam, Executor. Witnesses: R.E. Cook, J.M. Reed.

Cordelia Frost, Plymouth Village, Richland Co., [pg. 142], May 14, 1874 - June 20, 1874

First I wish that all my just debts and my funeral expenses be paid and that my Executor place suitable monument of marble at the grave of my daughter Polly Lyman and myself. Second, I give to my grandchildren, the children of my son Rufus Frost as follows, to Phebe Atyes, Chloe Lee, Mary Packer and Ella Barns a note calling for three hundred dollars made and signed by Geo Brink and Curtis Frost to be equally divided between them and Curtis Frost the sum of seventy five dollars to be deducted from a note I hold made and signed by him and George Brink the remainder of said note to be paid to my Executor. Third, I give to my son Solomon Frost my gold watch and my picture, Fourth, I give to my son Ira a sett of slave buttons, which was my husbands and is a family relic, Fifth, I give to my daughter Sally A. Young my silver spoons, Sixth, I give to my son Ansell Frost a book of History which was his Fathers, Seventh, it is my wish that after my death my daughter Sally A. Young shall divide my household and personal effects as her and I have talked and I explained between herself and the wives of my sons Solomon and Ira. The residue of remainder of my Estate shall be divided as follows...my daughter Sally A. Young, one fourth, my son Solomon Frost, on fourth, my son Ira Frost one fourth and my son in law James J. Young one fourth and the reason why my son Ansel Frost does not share in this item and my son in law does is that my son in law has purchased my sons interest in my Estate and made to him advancements to its full value. I appoint James J. Young Executor of this my Last Will and Testament. Witnesses: Mrs. (Harriet) E. Tranger, Wm W. Drennan

Solomon Culver, Washington Tp., Richland Co., [pg. 144], March 12, 1872 - July 4, 1874

I give to my beloved wife the farm on which we now live together, the north half of the Southeast quarter of Section 4, Tp 20, Range 18 during her natural life with entire control. It is my wish that my son David continue to cultivate said land as he had done in my lifetime and give my wife the same share that he did to me. I bequeath to my wife the two cows, two head of horses and all or any hogs or sheep, a buggy, buggy harness and all household and kitchen furniture. I give and bequeath to my son David Culver and his heirs and assigns forever that tract of land on which he now lives to wit: forty seven acres being a part of the Southwest quarter of Section 3, Tp. 2, Range 18, Virginia Military School land and I likewise give to him my son David Culver, the North half of the Southeast quarter of Section 4, Tp. 20, Range 18 upon the following conditions. He shall pay all taxes during the lifetime of my wife and keep it in good repair and pay my son Cyrus Culver the sum of two thousand dollars as follows....five hundred dollars, one year, after my death, three hundred dollars each year thereafter, making six years after my death. If David shall advance any payments to my son Cyrus before my death it shall be deducted from the above amount. It is my wish that after the death of my wife that my personal property be divided equally between my two sons or sold and the proceeds equally divided between them. Any money at my death shall be paid to my wife. I appoint my worthy friend William Gass, Executor of this my Last Will and Testament. Witnesses: William B. Hammett, Jacob Deems

Codicil: Solomon Culver, [pg. 146], June 7, 1874

Having in my will of March 12, 1872 bequeathed to my son Cyrus Culver two thousand dollars, I now by this Codicil revoke said bequest and bequeath the said two thousand dollars in the same manner and on the same terms to the body heirs of my son Cyrus Culver, to wit: Rosanne Culver and Allice Rosina Culver and in the event of my son Cyrus Culver being the father of any more children in that event I give and bequeath said two thousand dollars be equally divided among them. Money to be received when they respectively arrive at the age of twenty one years. Witnesses: S.G. Swisher, George A. Mull

James Morrison, Worthington Tp. Richland Co., [pg. 147], May 7, 1874 - August 21, 1874

I bequeath to my son Benjamin M. Morrison five hundred dollars out of my personal property, the five hundred

dollars to include a note of hand I hold against him calling for two hundred dollars payable one day after date and dated Sept 2, 1853, no interest to be computed. I bequeath to my daughter Albina Wohlford five hundred dollars out of my personal property, this five hundred dollars to be canceled with the promissory notes of hand calling for two hundred and five dollars as far as the same will apply said notes bear dates and amounts as follows...one calling for one hundred and five dollars dated November 12, 1860 and two notes of fifty dollars each dated January 2, 1871. I bequeath to George Wohlfort my son in law one small chest. I bequeath to my daughter Amanda A. Loney five hundred dollars out of my personal property. I bequeath to my daughter Albina Wohlfort and her children my house and lot No. 9 in Independence, Richland County, Ohio should she survive me, if not then to her children. After each heir shall have received their five hundred dollars out of my personal property the balance shall be divided in two equal parts, my daughter Albina Wohlfort getting one half and the other half divided between my two daughters Martha A. Barret and Amanda A. Loney equally. I appoint John Ramsey and Robert McLaughlin Executors. Witnesses: A.C. Kile, Isabel Kile

Pioneer Passes Away

James Hervey Cook died at his residence Thursday night, aged 81 years. The deceased had been a citizen of Mansfield over half a century. He was born Sept 3, 1816, on a farm two and one-half miles south of Mansfield and was the oldest son of Jabez Cook. He was married Mar 27, 1842 to Miss Mary Ann Wiler. Until 1849 he was engaged in teaching school, farming and buying produce. In the spring of 1849, he took possession of the Wiler House and was in charge until 1859. He resumed charge once again from 1864-1869. He was connected with the First National Bank, the Coldwater railroad and a number of other Mansfield businesses. He was a charter member of Richland Mutual Insurance Co.

He leaves four children: Mrs. G.W. Blymyer, of this city, who is now at New York on account of the condition of her daughter's health; Mrs. C. H. Brucker of Mansfield; Mrs. E.B. Sturges, Dayton; J.M. Cook of this city, secretary of the Mansfield Mutual Fire Insurance Co.

Mr. Cook was the eighth descendant of Francis Cook who came to this country in the Mayflower in 1620 and landed on Plymouth Rock.

Catharine Snyder by her next friend Peter Snyder vs Jacob Beam Jun.: Suit brought for breach of marriage contract. Promised to marry May 1, 1817. C.R. Sherman, Deft. Atty. says Defendant was under 21 years of age at time of promise. Cause discontinued and Plaintiff to pay Defendant costs. [Page 353]

State of Ohio in Complaint of Catharine Snyder vs Jacob Beam Jr.: Catharine Snyder appeared before Samuel Williams J.P. on October 15, 1817 and is pregnant with child, the father is Jacob Beam Jun. Defendant says "not guilty". Jury: Robin Weldon, Thomas Phillips, David Cook, John Pugh, Henry Watchell, William Ayres, Thomas Johns, Jonathan Grubaugh, John Owens, John Palmer, John Thompson, Joseph Curran say the Defendant is guilty. Jacob Beam Jun. judged father of child and charged with the maintenance thereof in manner following: To pay Catharine \$60.00 forthwith and to pay Catharine further sum of \$90.00 as follows - \$5.62½ on 12th November next, and further sum of \$5.62½ every three months until sum of \$90.00 fully paid, unless child should die...if he fails to pay he will be put in jail until he complies with orders.

State of Ohio vs John Shanks: Indictment for assault and battery made on December 20, 1817 on John Weldon. Pleads guilty...fined and to pay costs. [Page 359]

George C. Simpson vs Michael Grubaugh: Simpson sued October 14, 1817. Suit brought to recover on note for \$79.30 dated November 29, 1815, due four months after date. Defendant to pay Plaintiff \$88.20, damages and costs. [Page 360]

David Carter vs Wm and David Dickey: Debt of \$86.00. Plaintiff to recover of Defendant costs. [Page 363]

George Vannemann vs James Thornton: Suit brought to recover \$75.00 promissory note of May 14, 1817, due in sixty days. Defendant defaulted. Plaintiff to recover of Defendant \$78.75 and damages and costs. [Page 366]

Winn Winship vs James Thornton: Suit brought to recover \$75.00 on promissory note dated May 21, May 1817 endorsed by James McClure and Thomas R. Crocker. Plaintiff to recover of Defendant \$78.75, damages and costs. [Page 367]

John Garrison vs Robert Cunningham: Suit brought to recover \$100.00 on promissary note dated July 10, 1817, endorsed by James Kirk and James Wallace, due in 60 days. Defendant failed to Defendant damages and costs. [Page 370]

John Garrison vs Jacob Cook: Trespass - Suit brought to recover \$200.00 on promissory note dated June 26, 1817, due sixty days, endorsed by ---- Cook and Wilson Elliott. Defendant failed to file plea. Plaintiff to recover \$208.75 and costs of Defendant. [Page 372]

Ladies March On Tavern

On the evening of the 1st, we are informed that a number of ladies entered Sickinger's Tavern, in Washington Township, and summarily disposed of the liquors and other "stock in trade," belonging to the aforesaid establishment. It appears that the tavern has been a nuisance to every one in the neighborhood. Rifle whiskey and red eye brandy were dealt out indiscriminately to all applying. The ladies of the neighborhood, believing that the abatement of the nuisance was positively essential to the community, sent word to Sickinger to leave. No attention was paid to their request, and so on the evening above stated they visited Mr. S. en masse, and while one or two gentlemen kept him in conversation, they emptied his villainous compounds in the street. Sickinger, we understand, has been in this city, "getting some Law," but the only verdict he will ever receive will be, "served him right." Feb 2, 1860 - Mansfield Newspaper
