THOMAS LEWIS RIDER'S GRAVE SITE LOCATED

On a cold November day after reading about a grave site on a farm just outside of Durant, Oklahoma two great-great-granddaughters, **Ynema (Smith) Whiteside** and **Ruth (Rider) Faulkner**, and a great-great-grandson-in-law, **Jay Garland Faulkner**, and a great-granddaughter, **Audrey (Rider) Oxford**, set out to find the resting place of their loved one, **Thomas Lewis Rider**, born 1814 - died 1863.

An article in the *Chronicles of Oklahoma* stated that near the location of what was once called Fisher Station (Carriage Point) was evidence of a settlement and the scattered remains of headstones indicating a cemetery was once there.

At the time the article was published it stated the only gravestone that remained standing was approximately four feet in height and read:

THOMAS L. RIDER
D AUGUST 17, 1863
AGE 19 YEARS 4 MONTHS 14 DAYS

Knowing the age of death didn't coincide with their records the family was hoping this could be a misprint and this could possibly be the resting place of their grandfather.

It was known their **Thomas Lewis Rider** had carried the mail from Boggy Depot, Indian Territory to Bonham, Texas during the Civil War under the command of a **General Cooper C. S. A.** Due to bad health and his untimely death, **Thomas's** son, **Bluford West Rider**, a young man of 15 years, carried the mail for the duration of the contract for his father. The contract was for a period of approximately 2 years. This was a grave undertaking for such a young man. **Bluford** described in his application for a Civil War Pension the hazards he endured to carry out the task of delivering mail to **General Cooper. Thomas L. Rider** was a 4th generation descendant of **Nancy [Ward]** and **Kingfisher**, which would make **Bluford West Rider** a 5th generation descendant. The strength **Nancy** had shown through her life time was evident through the strength of her great-great-

grandson, **Bluford** to continue his father's duty on the mail route. Also the story had been handed down through generations to the family that **Thomas** was once a United States Marshall (This has not been verified as of yet.)

Note: Even though **Bluford** carried the mail for **General Cooper** he was never granted a pension for his service to the Confederate States of America.

Not being discouraged by the age at the time of death they decided to try to find the location. The *Chronicles of Oklahoma* stated that the grave was on property owned by a **Mr. A. O. Cross**.* Since the book was published several years ago they doubted the same owner still lived there.

Upon finding the location of the farm to their amazement **Mr. O. A. Cross** was still living there. He was very cooperative and told them there was a headstone out in the pasture behind his barn for a young man that had been a U. S. Marshall but the name **Rider** did not sound familiar. Since he was in bad health, he had not been able to leave the house in quite some time. He told them they were welcome to go look for themselves. Feeling a little discouraged the group started looking in the vicinity of where **Mr. Cross** remembered the stone to be. After walking and looking for about an hour, they were beginning to think the hunt should be called off. When suddenly to their delight they came upon one of the old wells that had been described in the article. This was encouraging so they decided to go a few feet north as the book had said the stone was scattered just north of one of the wells.

Sure enough, just a few feet north of the well the headstone of **Thomas Lewis Rider** was found! You can imagine the screams of joy and the tears that were shed at finding their family ties with this man that had been dead for over 132 years.

The stone had fallen over and broken in several places but for the most part was still in legible condition. It was easy to see why the mistake was made given the wrong date for his age at the time of his death in the article. The four had been defaced by a chip out of the marble monument, but upon closer examination you could definitely see that it was a four instead of a one which would make him 49 years at the time of his death which was correct. This completed the puzzle and they knew without a doubt that this was the final resting place of their loved one. Also they discovered by the insignia on the headstone that it appeared
