Correspondence from Jonathan Stayer, Head, Reference Section of the State Archives, Harrisburg regarding the following list concerning additional papers which they may hold reads: "I briefly compared the list with our index of Revolutionary War pension records at the State Archives, and found that we hold payment ledger entries for many of the names. Although my brief scan of our index did not locate any actual papers or applications for the men listed, I assume that it is likely that the papers survive for a few of the veterans. Unfortunately, for most of the Acts of the Assembly granting the payment to Revolutionary veterans or their widows, no application-type papers survive — if any were ever submitted. The Revolutionary War pension records in our custody are available for research during our normal public hours. Most of them have been microfilmed. The index is available in our Search Room. We will check the Revolutionary War pension records by mail upon the payment of \$10.00 per name search fee. The fee includes the search and copies of records found. Frequently only one or two payment ledger entries will be found per veteran. The ledgers usually indicate the name and residence of the veteran, and the dates and pension payments as well as the name of the person receiving the payment. The date of the veteran's death often is noted because his decease terminated the pension payments."

The Flying Camp is mentioned frequently and your ed. quotes from *The Pennsylvania Line: Regimental Organization and Operations, 1775-1783* by John B.B. Trussell, 1993 2d edition, Pa.Hist.Mus. Comm. Harrisburg Pa. pp. vi-vii. The 'Flying Camp' was created in July 1776, as a reserve or pool of organizations, to reinforce the Continental Army on an emergency or temporary basis. It consisted primarily of local, militia-type units called up from the colonies of the Middle Atlantic region. Although the unit structure remained relatively constant, the individual personnel comprising it fluctuated, departing on the expiration of their prescribed limited tours of duty and being replaced by others, until the tours of those men also expired. The members of the Flying Camp, although provided by the individual colonies, were paid by Congress. In the case of Pennsylvania, some units in the full-time service of the colony (as distinct from short-term volunteers or from militia in State service, and from Continentals in the service of Congress) were briefly made available to the 'Flying Camp.' Allen, Peter of Huntingdon county; in Colonel Watts' Flying Camp; subsequently in Captain Thomas Alexander's company, Colonel Piper, stationed in Sinking Valley [Blair County] to protect the lead mines.

Allen, John of Butler county; in Colonel Potter's regiment at Trenton, Princeton, and skirmishes at Piscataway and Quibbletown; served under Colonel Antes at Big Island.

Bittenbender, Conrad of Northampton County; taken prisoner at Fort Washington; released Feb. 1777. Bonde, Samuel, Lieutenant; killed at Brandywine.

Bodle, Abraham of Fayette county; in Captain Boyd's company of Rangers; wonded in right thigh at Frankstown [Blair County] when in pursuit of Indians.

Beard/Bardt, Henry of New York; a native of York county; served in Captain Fred. Kurtz's company, Colonel John Andrews' regiment, General Potter's brigade; wounded Dec. 1777.



Bonner, Thomas of Adams county; Capt. Orbison's company, 5th battalion, York County associators.

Brunson, Daniel of Dauphin county; in Capt. John Reed's company, Flying Camp; taken prisoner at Long Island.

Bobst, Michael of Lehigh county; served under General Stanwix, 1758-59 against Indians on the frontier; served as major in the Revolution.

Beard, Adam of Berks county; Lt. of Associators May 17, 1777; in service March 1, 1778.

Boltzley, Jacob of Monongalia county, Virginia; enlisted in Pennsylvania militia Aug 1, 1780. served 7 months.

Bush, Henry of Pike county; served in the Associators and Flying Camp.

Bradley, William of Allegheny County; served in Flying Camp; taken prisoner at Fort Washington, and confined on Jersey prison ship.

Bower, David of Lancaster county; served as commissary of provisions; died in 1823.

Brown, John of Philadelphia; served as Pvt. in Capt. Robert Kirkwood's company, Delaware Regt., and in the Pennsylvania associators.

Bean, William, served in Flying Camp.

Brandon, William of Butler county; served on the frontiers until 1779.

Barkelow, James of Union county; served in Flying Camp.

Blythe, Samuel of Franklin county; captain of a company of rangers in 1780.

Bower, Adam of Somerset county; major in the militia, died about 1813.

Bodine, Frederick of Lycoming county; served in Capt. Calhoun's company, Col. Hunter's regiment on the frontiers.

Buyers, George, in Capt. William Scott's company, Lancaster county associators.

Bury/Berry, George, in Capt. William Scott's company, Lancaster county associators.

Campbell, Thomas of Franklin county; captain in Flying Camp; taken prisoner at Fort Washington; released Nov 9, 1778; subsequently Capt. of Rangers until 1780.

Clark, John of Northumberland county; in Col. James Murray's Regt., wounded in his hand.

Coulter, Nathan of Washington county; in service on the frontiers in 1781 & 1783; on Sandusky Expedition.

Connor, John, in Capt. David Wilson's company of Flying Camp; taken prisoner at Fort Washington and confined on Jersey prison ship.

Coyle, Manassah of Fayette county; in 1781 in Capt. Orr's Co. on expedition down the Ohio river, and Aug. 24, 1781 taken prisoner by Indians.

Charles, Leonard of Bedford county; served as ranger on the frontiers.

Carmany, John of Lancaster county; served in one of the Lancaster county battalions of the Flying Camp on Long Island.

Clark, John of Allegheny county; Capt. in Pennsylvania Line; commanded a sub-legion under St. Clair, and was wounded at the Miami [in Ohio].

Curtis, Marmaduke, a Lt. in the militia in 1776.

Cook, Reuben of Tioga county; "minute man" in Col. Stroud's regiment in 1776.

Cary, Samuel of Luzerne county; taken prisoner by Indians July 3, 1778 at Wyoming [Valley], battle on Abraham's Plains.

Cowan, William, of Westmoreland county; captain on the frontiers.

Campbell, Thomas of Westmoreland county; ranger on the frontiers.

Carter, Thomas of Venango county; spy under Lt. Hunter; subsequently, in 1777, under Capt. Clark.

Carson, James of Mifflin county; under Captains Clark and Sanderson.

Campbell, John of Franklin county; in Capt. Samuel Blýthe's company of rangers in 1780.

Dougherty, Henry Jr. of Lycoming county; pvt. in Col. James Potter's regiment; wounded at Piscataway February 1777.

Darr, Leonard of Mt. Joy Twp., Lancaster County; in Col. Curtis Grubb's Co; wounded at Powles Hook, made prisoner in hospital and died soon thereafter.

Dunlap, Robert in Capt. Willard's company, Col. Wm. Montgomery's battalion; taken prisoner at Fort Washington.

Duffy, Terrins of Tioga county; in Capt. Moser's company in 1776 in the regiment commanded by Col. Crawford to New York under General Roberdeau.

Eichelberger, George of Dauphin county, served in Flying Camp.

Frew, Alexander of Beaver county; served in Third Co, 8th battalion, York county militia in 1781.

Fisher, Samuel of Northumberland county; capt May 21, 1777, Northumberland county battalion; made prisoner at Guelph Mills, Chester county, and kept in captivity 3 years.

Gump, Frederick of Greene county; served in Chester county militia, Capt. Culbertson's company in the Flying Camp.

Gallendin, Jacob of Fayette county; waggoner in Flying Camp; at Amboy [N.J.]

Gillespie, James Jr., wounded on the Sandusky expedition.

Gallagher, Thomas of Mifflin county; at Crooked Billet; cut and mangled by the British.

Gentzler, Conrad of York county; ensign in the Associators; killed near Perth Amboy [N.J.] in 1776.

Graham, James of Mifflin county; ranger on the frontiers.

Graeff, Garret of York county; captain in Flying Camp; taken prisoner at Fort Washington, and died in captivity.

Gorman, William of Franklin county; with Wayne in his campaign against the Indians.

Gelwicks, George of Mifflin county; ensign 1776077, in Capt. Eichelberger's company of York county associators; and marched to Amboy to guard the prisoners captured with Burgoyne; subsequently ensign in Capt. Foreman's company York county militia, and marched to Guelph Mills.

Hunter, John of Westmoreland county; private Fourth company, 2nd Regt., Westmoreland county militia; wounded in service.

Hyleman, Martin of Chester county; in Capt. McKissack's company, Col. Baxter's regt; taken prisoner at Fort Washington; after release served in Capt. Thomson's company, Col. Lacey's regt, and wounded in the head near 'Burned Mill.'

Harbeson, John of Allegheny county; in Capt. Clark's company under Gen. St. Clair, and wounded in the back at the defeat in 1791.

Holmes, Samuel of Berks county; in Capt. John Van Etten's company, Col. Stroud's regt; Apr 20, 1789 wounded in battle with the Indians on the frontiers.

Hamilton, William of Indiana county; in Capt. Samuel McCune's company of Flying Camp; took sick at Fort Lee [N.J.].

Hoffman, Philip of Lancaster county; served several tours in the militia 1776-77.

Hermanies, John of Franklin county; served 3 tours in the militia.

Hughes, John of Lycoming county; in June 1778 in Capt. Simon Cole's company, Col. Antes' command; in 1779 scouting in Buffalo Valley.

Irwin, James of Philadelphia; served as Capt. during the Revolution.

Ickes, Peter of York county; captain in the militia.

Irwin, James (2nd) of Philadelphia; served 2 tours in the militia; died prior to 1825.

Johnson, Richards of Mifflin county; served in Col. Hazlett's (Delaware) regiment until discharged in Dec 1776; went to Carlisle [Cumberland county] and served in Col. Watt's regt; in service on the frontiers of Cumberland, Northumberland, Bedford and Westmoreland counties; ensign in 1780; subsequently Lt.

Justice, Peter of Indiana county; in Capt. Stokeley's company of Rangers.

Kennedy, John of Butler county; in Flying Camp.

Kreider, Jacob of Northampton county; in Flying Camp; taken prisoner at Fort Washington; released on parole, Feb 1777; exchanged May 1780.

Kerr, Thomas, in Capt. Robert Clark's company, Flying Camp; taken prisoner at Long Island, and died in captivity.

Kocher, Conrad of Northampton county; served on the frontiers.

Kerr, William of Perry county; served 7 months in Col. Potter's regiment.

Kinsey, William of Bucks county; in Capt. Thompson's company in 1776; was at White Marsh, Germantown, Chestnut Hill and the taking of the Hessions at Trenton; in 1824 aged 69.

Kountz, Thomas of Lancaster county; in 1776 in Col. Ross' Flying Camp; in 1777 in Capt. John Miller's company.

Lauther, James of Franklin county; served 3 tours in the militia; died 1826.

Light, John of Lancaster county; served as captain in the militia.

Little, Henry of Adams county; served 7 months in Col. Potter's regt; aged 77 in 1826.

Little, Andrew of Adams county; served 7 months in Col. Potter's regiment.

Lewis, James of Chester county; in Capt. James McClure's company, Col. Wm. Montgomery's regiment, of the Flying Camp; taken prisoner at Fort Washington; confined on prison ship Jersey, and died

shortly thereafter.

Langenbach, Michael of Northampton county; in Flying Camp; taken prisoner at Fort Washington and confined on Jersey prison ship.

Lutz, Henry of Northampton county; in Capt. Hagenbush's company of Flying Camp; taken prisoner at Long Island August 7, 1776.

Lemmon, John of Armstrong county; enlisted in the Maryland Line in 1775; subsequently served in the Cumberland county battalion of the Flying Camp; afterwards served in the marine service; in 1821 was 76 years of age and blind since 1793.

McGee, Patrick, in Capt. Houston's company, Col. Watts' regt of the Flying Camp; taken prisoner at Fort Washington; paroled in January 1777.

Morrison, Alexander of Lancaster county; wagoner, Capt. Samuel Hewitt's company in 1778.

McVickar, Duncan, served 2 months in Capt. Wm. Wilson's company at Potter's Fort in Penn's Valley; and several tours on the frontiers.

McGregor, William of Allegheny county; in Capt. Wilson's company of the Flying Camp; taken prisoner at Fort Washington and died shortly after release from captivity.

McFarron, John, killed by the Indians at Piper's Fort in 1782.

Martin, Richard of Lycoming county; served on the frontiers under Col. Samuel Hunter from 1776-1778.

Martin, Thomas of Lycoming county; served on the frontiers under Col. Samuel Hunter from 1776-1778.

Means, Hugh of Mercer county; in Capt. John McDonald's company Bedford county militia in 1779, serving 8 months; in 1781, 3 June in an engagement with the Indians near Bergod's Gap, was wounded in arm. (unable to find location of Bergod's Gap).

Markle, Bernard of Dauphin county; on ship Hyder Ally, Capt. Barney, Apr. 8, 1782; wounded in the engagement with the ship General Monck.

Machimer, William of Berks county; served in 1776 in Capt. Joseph Hiester's company of the Flying Camp Moser, John of Northampton county; served in the Flying Camp.

Musney, Jacob of Lehigh county; Lt. in the Flying Camp.

Meloy, John of Mifflin county; served 5 several tours in the militia.

Markle/Merkle, Christian of Northumberland county; in 1776 served in the Flying Camp; was teamster under General Wayne at Valley Forge; subsequently in Berks county militia under Capt. Landig.

McCrum, William of Bucks county; served with the Associators at Trenton, Princeton and Brandywine; in 1826 aged 73 years.

McWilliam, John of Armstrong county; in Capt. Robert Buyers' company, Lancaster county Associators at Amboy; afterwards with Capt. William Scott at Trenton.

Newell, William of Bedford county; served as orderly sergeant in Bedford county Associators in 1777; in 1823 was 77 years of age.

Nye, Samuel of Washington county; served with the militia on the frontiers.

Plumb, Jacob of Somerset county; wounded and taken prisoner at Piper's Fort in 1782.

Purdy, James of Mifflin county; Capt. and Col. of a battalion on the frontiers during the Revolution; one of his sons drowned in the Juniata [river] while pursuing Indians; two others, Capt. and Lt. killed at St. Clair's defeat.

Pool, Conrad of Berks county; in 1777 served in Capt. William Scull's company; killed in action in New Jersey.

Penegar, Amos of Philadelphia; in 1777 in Capt. Rudolph's company, Gen. Irvine's brigade at Brandywine and Germantown; in 1779 was Ensign in Col. Davis' regiment.

Patterson, Benjamin of the State of New York; in 1776 served in Capt. Cambleton's company.

Paul, Benjamin of Chester county; in Capt. Heatherland's company of Flying Camp; subsequently in the quartermaster's department Col. William Evans' regiment; in Capt. Eyre's company at Brandywine.

Roth, Christian of Northampton county: served in Flying Camp, and taken prisoner at Fort Washington; released on parole in Feb. 1777; exchanged May 1780.

Ritchie, William of Montgomery county; served in Capt. Thomas Craig's company, Col. Wm. Baxter's regiment; taken prisoner at Fort Washington and held 2 years.

Rogers, George of Lancaster county; served in Capt. Zantzinger's company Flying Camp; subsequently Capt. Clark's company, Col. Cunningham.

Robb, Samuel of Butler county; in Capt. Wm. Armstrong's company, Col. Wm. Montgomery's regiment of Flying Camp; taken prisoner at Fort Washington; after release was wagon-master 3 years. Andrew Jersen

Reed, Samuel of Indiana county; in Capt. Thomas Craig's company of Flying Camp; taken prisoner at Fort Washington.

Ream, Henry of Lancaster county; served several tours as Lt. in the militia.

Salmon, Joseph of Northumberland county; Capt. in Col. James Murray's battalion on the frontiers; taken prisoner by the Indians in 1781 and kept captive in Canada 2 years.

Spar, Valentine of Westmoreland county; served on the frontiers in Col. Christopher Trubey's regiment; was in Gen. St. Clair's campaign of 1791 and wounded at Maimi [Ohio].

Shook, John of Northampton county; in Capt. John Arndt's company, Col. Kechline's battalion of Flying Camp, taken prisoner at Fort Washington and confined on Jersey prison ship.

Smith, George of Bedford county; served in Colonel Piper's regiment; subsequently in Capt. Boyd's ranging company; in June 1781 taken prisoner by the Indians and held in captivity until November 1784.

Smith, Thomas of Mifflin county; in Capt. Templeton's company; taken prisoner at Fort Freeland, and held captive 3 years and 5 months.

Stahl, John of Union county; served in the Militia.

Sellers, George of Westmoreland county; ranger under Capt. Shannon on tour to Wheeling; subsequently with Capt. Leasure, guarding the frontiers.

Scout, James of Bucks county; served in the Associators.

Stewart, Thomas of Franklin county; served under Gen. Wayne in his campaign against the Indians.

Shaffner, George of Lancaster county; was a Major in the militia; died prior to 1828.

Spriggell, Joseph of Cumberland county; in Col. Curtis Grubb's regiment; subsequently in Capt. Henry Neems' company; afterwards in Col. Benjamin Mills' regiment, wounded at the battle of Fort Montgomery.

Sharp, James of Butler county; served 6 months against the Indians during the Revolution; in 1823 was 82 years old.

Thompson, John of Indiana county; in Capt. Wilson's company of militia.

Titlow, John of Bucks county; served under Gen. Potter; wounded in the foot at the battle near Yellow Springs, and was at Brandywine.

Trexler, John, commissioned Capt. May 10, 1778 and marched to Wyoming.

Ulrich, George of Northumberland county; in Capt. Michael Weaver's company, Northumberland county in 1780.

Underwood, John of Cumberland county; was commissioned Mar 15, 1776 Ensign 5th Battalion, Lancaster county Associators, and served susequently as Lt. and Capt.

Van Gordon, Wilhelm, served under Capt. Henry Shoemaker at Wyoming, and wounded in hip in action with Connecticut settlers July 20, 1784.

Vogan, Samuel, served in Capt. Brown's company, Lancaster county Associators.

Wallace, James, Pvt. in Col. Watt's regiment, taken prisoner at Fort Washington.

Wallace, John, served in Capt. Thomas Robinson's company of rangers, and killed in an engagement on Bald Eagle Creek in 1782.

Walter, John, served in Captain Brown's company of Lancaster county Associators.

Wilson, Matthew of Allegheny county; served on the frontiers of Northumberland county; was a spy among the Indians during the Revolution; was out 4 summers.

Weigant, John of Northampton county; was Adjutant of militia regiment during Revolution.

Wolf, George of Northampton county; served 3 several tours on the frontiers against the Indians on the Delaware [river], north of the Blue Mountain, first as Sgt., then as Lt. and afterwards as Capt. of the militia.

Wright, Robert of Cumberland county; in Capt. Thomas Brewster's company, 4th battalion, Col. Thomas McKean, General Cadwalader's brigade of Philadelphia in 1776.

Weitzel, Philip of Lancaster county; served 3 months in Capt. Jacob Glotz's company, Col. Cunningham's regiment of the Flying Camp.

Young, Felix of Cumberland county; in 1781 marched to Lancaster guarding prisoners.

Young, William of Northampton county; Lt. of Flying Camp; a prisoner 2 years.


This letter was written on June 9, 1862 to Jacob Walter by his younger brother Alexander Walter

Alexander became ill with typhoid fever at or near Fredricksburg, Virginia, the first day of September 1862. He was taken to Fairfax Seminary Hospital in Virginia, and he died on September 9, 1862 at the age of 20.

Note:

"While the average soldier believed the bullet was his nefarious most foe. disease was the biggest killer of the war. Of the Federal dead. roughly three out of five died of disease. and of the Confederate, perhaps two out of three."


