The first list of children whose parents were unable to pay county personal taxes which supported the schools, for Smith Township are found in the 1814/15 duplicate tax books. Why are these lists so important to researchers? Because aside from census listings, these people did not own land, nor did they have personal estate for which they would pay taxes – the kind of family which left little record of a residence in a time or place. If you find a family here, check also the 1810 census and the 1820 census and possibly 1830 to see if you can trace them in this manner also.

UNITED STATE VERSUS JACOB WOLF WASHINGTON COUNTY, OCTOBER TERM, 1796

Taken from Addison's Reports #312 page 277 at the Allegheny County Law Library.

By Act of March 3d 1791, §§ 21, 23, 24, Congress imposed on certain Stills, employed after June 30^{th} , 1791, a yearly duty, to be measured by such stills' *capacity*, unless the actual amount distilled was shown by a *book* kept for that purpose by the still's owner, and to be paid upon demand of him *at his dwelling*; by Act 8th May 1792, §§ 2, 13, stills were required to be entered in *June* yearly at an inspection office in the county or district, by the Act of June 5th 1794, § 10, they were in, under a penalty; by Act June 5th 1794, § 16, a personal demand of duties had the effect of the demand required by the Act of 1791, and by § 17, means were provided for remitting fines, penalties and forfeitures.

There was an insurrection against this excise duty: the secretary of the treasury, in November 1794 authorized collectors to receive entries of stills for the year beginning July 1st, 1794, without exacting arrears of duty, except for the year ending June 30th 1794.

Jacob Wolf in *November* 1794, entered his still for the year beginning July 1st 1794, and promised payment of duties for the preceding year; and past penalties and forgeitures incurred by him were waived.

In indebitatus assumpsit against Wolf for the duties of the year ending June 30th 1794, there was evidence that his stills were worked in the spring of 1794, and that a demand was made of him. A *paper* showing a number of gallons of whiskey distilled, was offered for the defendant. *Charged*. That, under the said acts the penalty and duty therein provided could both be exacted, and the existence of an inspection office in the county with the still was immaterial in this suit for duties. That the said duties had been sufficiently demanded, and, being due, the law raised a promise to pay them.

That no *book* being shown, the duties calculated accordidng to the stills' capacity could be recovered. That the waiving by the United States of the penalty for not entering Wolf's stills in June 1794, and all past duties (other than those sued for here), express promise to pay the duties here sued for.

Verdict for the United States.

REVEREND THADDEUS DOD & THE EARLY TEN MILE SETTLEMENTS 1777-1785 IN WASHINGTON COUNTY PA

The following material is held in the Historical Collections of Washington & Jefferson College in Washington Pa. The Rev. Thaddeus Dod's journals were transcribed by John A. Dodd of New Jersey in 1955 and donated to W&J, and published by C.M. Ewing, director of the library. The journal contains baptismal and marriage records 1777-1785; and Session records of the Upper and Lower Ten Mile Presbyterian Church from 1781-1783. Unfortunately the pages covering the years 1784 to 1796 had been cut from the journal. Dod's Latin & Mathematical School opened in 1781 and was the early antecedent of W&J College. When the school was continued as Washington Academy under charter of 1787, Dod became its first principal. (Lines indicate the end of journal page).



The parents John George was b. 7/9/1769, immigrated to Philadelphia 19 Sept 1804 on the Ship *Margaret* with other Harmonists (Strassburger *Pennsylvania German Pioneers* Vol.1 pp. 163-169), he was admitted to the Society 2/15/1805, withdrew 4/1832; the mother was b. 10/21/1771 d. 2/27/1838 in the Society. Other children of the parents were: son Simon b. 5/17/1806 in the Society, withdrew 4/1832; Jonathan b. 5/6/1808 in the Society, withdrew 4/1832; dau Anna Maria Melina b. 3/17/1799, admitted 2/15/1805 with parents, d. 1/7/1847 in the Society; David b. 10/18/1803, admitted 2/15/1805 with parents, withdrew 4/1832.

SESSIONAL RECORDS 1781-1783 UPPER & LOWER TEN MILE PRESBYTERIAN CHURCH

Revd. Thaddeus Dod (then a licenciate of the Presbytery of New York) came to Western Pennsylvania and spent some time two or three months in the summer of 1776-1777, principally on the waters of Tenmile [creek] in the southern part of Washington County [and what became Greene County in 1796]. He then resolved to make this the scene of his future labours; and returned to his home in Mendham New Jersey and was ordained by the Presbytery of New York on the 15^{th} day of October A.D. 1777; and the next week set out with his family westward. On his way he received much information of the state of things at his intended location; many of the inhabitants having fled on account of Indian depredations, that he stopped at Pattersons Creek in Virginia. There appears, from his journals, that there had been no organized congregations in that part of the country, and his time was occupied in preaching in private homes in that vicinity and in the neighboring parts of Maryland until the month of September 1779 when he continued to his destination in Washington County Pa.

There was no Church organized here until the 15th of August 1782, nearly two years after his arrival. The first house of worship was built in 1784-85 on the site now occupied by the Lower Tenmile Congregation. In the upper part there was none until the summer of 1792 when a house was erected on the site now occupied by the Upper Tenmile Congregation, previous to which time meetings were held in private homes, barns or in the woods, the pastor dividing his time equally between the two.
