

HENRY YOUNG WAS SCOTTISH, NOT DUTCH!

As I was gathering information on my Orangeburgh ancestry, I was looking closely at various sources of information, and was particularly interested in some of the entries in the Giessendanner records transcribed and published in Salley's *History of Orangeburg County*. One of the entries of particular interest was that printed as the last item on page 94 of Salley's *History*:

12 April [1738]. I have married in presence of English & German wittnesses-after 3 time publishing the Banns & in presence of the congregation of our Church Christian Meyers—Johannes Meyers' Lawful son to Rebecca Young - William Young's daughter from Holland— Johannes Myers from Switzerland.

At the Caroliniana Library in Columbia, in order to protect the original from further deterioration, the visitor is usually given a reversal (white on black) photocopy of the Giessendanner record to inspect, if requested. However, on one occasion I was allowed to view the original record. Inspection of the original and copies showed that the above entry is in German, and the word interpreted as "Holland", which happens to be the last word visible on that page, is in fact "Schottland", the German word for Scotland.

The combination of letters "sh" is not used in German, with "sch" being the correct combination. However, in German handwriting of the period which I have seen, the "c" in this combination may be only a tiny squiggle between the "s" and the "h". Both the capital "S" and the "h" are usually shaped quite differently from the forms used in English handwriting, and the combination "Sch" could well appear to be an English form of capital "H".

However, the "Sch" in "Schottland" is formed exactly the same as the same letters in the name, "Elias Schnell" higher on the same page, and elsewhere in the same handwriting, and the rest of the word is consistent with "Schottland" in German script. To me, there is no question that William YOUNG and his daughter Rebecca hailed from Scotland, rather than from Holland.

The above bit of information may be of interest to those who tentatively or positively trace their ancestry to Henry YOUNG and his children. The following appear to be the children of William YOUNG and his wife (there may be others):

- i. Rebecca YOUNG married 1738 Christian MEYERS
- ii. Mary YOUNG married by 1750 to Luke PATRICK
- iii. Sarah YOUNG married 1750 William HART
- iv. William YOUNG married 1752 Mary LINDER
- v. Henry YOUNG married 1754 Ann HILL

I believe that William YOUNG (the elder, father of Rebecca who married Christian MEYERS), may have died by about 1737, and that his wife (or widow), also named Rebecca, subsequently became the wife of Christian MINNICK, explaining why Rebecca MINNICK was a sponsor or godmother to children of Luke and Mary PATRICK, William and Sarah HART and Henry and Ann YOUNG.

AND THEN THERE WAS JACOB

From Petitions for Land From the South Carolina Council Journals, Vol.I:1734-1748. Brent Holcomb. (Columbia, SC: SCMAR 1996.) p.171. [This is just a "teaser". Most of us should buy the book.]

"...Petition of Jacob Young... a family of four persons...issued a warrant for 200 acres...and Bounty...had served Doctor Moultrie for three years in this Province...wife and two children under twelve. [June 1743].

On page 200, we find:

"...Petition of Jacob Young showing that he has a family of five ...intends to settle in Saxe Gotha Township over the Savannah River, prays that 550 acres of land there be granted. Granted upon condition that it not be in any of the "reserved Lands", nor on any land granted to another. [November 1744]. Does this indicate a new child and 10 slaves?

We have here a wonderful picture of an immigrant, "poor, Protestant and Foreign" who comes as an indentured servant, works out his time and then proceeds to get 750 acres of land in less than a year and a half. Unless this land was terrible, or Jacob died young, he almost surely became a prosperous farmer.

To establish Jacob on his land, we turn to the *Jury Lists of South Carolina*, by GeLee C. Hendrix and Morn M. Lindsay (Greenville, SC: 3 Acorn Ct. c. 1978,) This is the nearest thing to a Census for 1778-1779; although non-inclusive of all families. The YOUNG men in Orangeburgh eligible for jury duty (p 66-73) are Thomas YOUNG, betw. S. Fork of Edisto and Savannah River. [Barnwell?] and Henry YOUNG, Sr., betw. N. and S. Fork of Edisto River.

The only possibility in Saxe Gotha is:

John YEARG. There seems to be no trace of a YOUNG family which stayed in the Saxe Gotha area. The index to deeds of S.C. gives no clue as to a possible son for Jacob; nor is there a sale of his 750 acres. Perhaps this will turn out to be one of the families who lived near Little River in Ninety-Six District, not far from Saxe Gotha. In the 1790 Census of Spartanburg, there are John YOUNG with 9 slaves, Capt. Isaac YOUNG, Hugh and a Henry. Since Isaac had no slaves, John is the most likely to be Jacob's descendant found.

Estate sale "at place of the late Lewis H. Zimmerman, deceased, in Orange Township on Tuesday, Dec. 15, 1874...the remaining personal property of said estate, consisting of horses, mules, cattle, hogs, corn, fodder and other produce with Plantation Machinery, Farm Implements, etc. Terms cash."

Doc.dated 3-16-1874: "I, the widow of Lewis A. Zimmerman, deceased, do recommend and request that Thomas E. Rickenbacker of Orangeburg County be appointed administrator on his estate and I pray ... be granted. Signed: Anna A. Zimmerman, Witness: David Fersner.

Doc.: "sheweth that...departed intestate, at his residence in said county, on the 12th of March 1874...surviving are his widow, Anna A. and three children, Cornelia Mary Ann, Ella and Ida all being minors...that petitioner [Thomas E. Rickenbacker] who is brother in law of the deceased to be administrator."

Doc. Newspaper adv.: "Notice is hereby given that in one month from the 22 of Nov. 1879, I will file my final account as administrator of said estate with the probate judge and apply for final discharge. Thomas E. Rickenbacker, dated 11-21-1879."

From Will dated May 18, 1871: "...leave to my wife a tract of land situated in Richland County, 400 acres being a part of my Pinckney Tract, bounded by lands of Nancy Braddy, Zom Braddy, Daniel Zeigler, and the Old River...also leave to her my homestead tract situated in Orangeburg containing 75 acres...upon her death to go to son Daniel and daughter Mary Jane and their issue...(also named another daughter Caroline R. Paulling and a deceased son, Frederick Zeigler).

Doc.: "...the humble petition of Mrs. Jane M. Zeigler, of said State and County respectfully shows unto your Honor, that she is the sole qualified Executrix of the last will and testament of Daniel Zeigler deceased, who departed this life in the month of July one thousand eight hundred and seventy-two. That among the assets of the Estate of your Petitioner's Testator is a claim against one Albert Crumpley of the State of Alabama, which originated as follows: In eighteen hundred


and fifty seven, Nicholas Zeigler, the brother of your Petitioner's Testator, departed this life in said State of Alabama, bequeathing to your Petitioner's Testator a family of slaves. That your Petitioner's Testator allowed the said Albert Crumpley to take said family of slaves, he agreeing to pay him therefor. That in a settlement had on the fifth day of July eighteen hundred and seventy two, the said Albert Crumpley was found to be indebted to your Petitioner's Testator in the sum of One Thousand and fifty dollars. That said sum of one thousand and fifty dollars has never been paid, but is still due and owing. That the property of the said Albert Crumpley has been greatly reduced by the results of the late war, which fact, together with the large "homestead' exemption allowed in Alabama, renders it utterly impossible for your Petitioner to collect said debt by process of law and the same is in danger of being wholly lost to her Testator's estate. But your Petitioner hopes and believes that by offering a compromise of said debt to the said Albert Crumpley, some portion thereof may be saved to her Testator's Estate, wherefore, she prays your honor that she may be authorized by order of this honorable court, and by virtue of the Act of Assembly of this State in such case made and provided, to compromise said debt for such sum as she may be able to obtain from said Albert Crumpley in satisfaction thereof. And your Petitioner will ever pray and so forth. Signed Izlar & Dibble. Doc: Ex Parte Jane M. Zeigler, Executrix - Petition to compromise debt of Nicholas Zeigler State of Alabama. Personally appeared Albert J. Crumpley before me and made oath that he is the son of Albert Crumpley, residing in Talledega County, State of Alabama, who is indebted to Daniel Zeigler deceased, late of Orangeburg County, S.C. in the sum of One Thousand and fifty dollars, with interest from 5th day of October A.D. 1861, as his share of the Estate of Nicholas Zeigler deceased late of Alabama, and that the said Albert is wholly unable to pay the whole amount of said debt if any part thereof, and that in the opinion of this deponent the executrix of Daniel Zeigler deceased will do well to compromise said indebtedness for the sum of four hundred and fifty dollars. Sworn before me ___April 1873. Thompson H. Cook, Judge 8th Circuit, SC. Signed A. J. Crumpley.

Doc: That the estate of David F. Zeigler is not fully administered by reason of the following circumstances: His appointed executors, John P. Spigener and David Hair have renounced their commission dated March 21, 1873. The said Will was duly admitted on March 12, 1873, but the said John P. Spigener and David Hair declined and refused to accept the appointment...the widow, Emma Zeigler applied for administration with the will annexed, but did not qualify; whereupon at request of said Emma Zeigler, one George Boliver obtained Letters of Administration on Sept. 16, 1873 and proceeded to probate estate.
