

To the memory of my great grand parents, John M. and Charlotte E. Ashley Moore, who lie buried in Little River Cemetery.

Today, May 4, 1941, we pause to celebrate the one hundred and fiftieth anniversary of Little River Church, Saluda Association. We are indebted to our forefathers for blazing the way in the forest and erecting an altar to the Supreme God, where the hungry soul of their ancestry might partake of the Heavenly manna, which would stand out as a beacon light to the weary traveler, and which has stood the trials these 150 years, and is still a living monument to the faithful.

Little River is a branch of Turkey Creek Church, organized in 1791, about a mile from the present church, under a brush harbor, then built a log house, known as Hogskin Church, taking its name from the creek nearby, within a very short distance of where the only battle was fought between the Homeguard under Josiah Carwile. and the Tories. It seems that in the early part of the Church there was some negligence in keeping church records, then some carelessness in preserving them. We are at a partial loss to know just who were the particular organizers, but we find on the first page of the record February 1810 (records prior to this seemingly lost) such names as Williams, Gantt, Holland, Durham, Wakefield, Smith, Crowther, etc.

The name Little River takes its name from the stream of water nearby. The land for the building was deeded by William Moore, later from others, with the Western part of the cemetery by Henry P. McGee. Just what date the first building was erected, there's no available record. (Bro. F. E. Ellis, now deceased, informed us that his great-great-grandmother was the first to be buried in the cemetery about 1812.) It must have been erected about 1810, being a small building. We find on record a communion service at the new meeting house, with an invitation to Turkey Creek to be partakers, 1812. The records are very clear as to meetings and adjournments, citing Brother or Sister so and so to appear before conference for non-attendance, or for misbehavior, one towards the other; occasionally ill feeling ran pretty high. On one conference, a brother carried his shotgun to settle a difficulty with another . . . unfortunately the records are "adjourned." In 1814, Brother Williams and Gantt are named to the association, place not given. The first record of election of Deacon was September 1820 that of Brother Jas. Brock, following to meet with Barkers Creek celebrating the Lord's Supper, Oct. 14, 1820. It appears that the church had worked these years without a constitution.

On Oct. 20, 1821, these are some selected to draw up a constitution, Reuben Brock, Wm. Hunt, Hugh Clement, John Gantt, Laban Massey, Elizabeth Shirley, Milly Reed, and others.

The first record of a church clerk is Cador Gantt. Oct. 14. 1818, the similarity of the writing shows that he must have acted as Clerk quite a time. The greater part of the records 1818 to 1822 inclusive shows citations for offending members to appear at Church Conference, from 1822 to 1826 the records seem to be misplaced. In June 1826 Brother John Given was named deacon and Brother R. Tribble singing clerk. Brother Nicholas Boeshel came and acknowledged drinking too much spirits. The colored people were taken into the fellowship of the church, for in May 1827, we find a black brother cited to appear for charges against him after prayer and sermon, in Oct. 1829. A discussion in conference, whether to commune with Pedo baptist, carried over. In Oct. 1830 a man of color was charged with stealing corn from a white brother, the man of color charged his white brother with having a hog with his mark. In July 1831 delegates were named to the association. Rev. Arthur Williams, Cador Gantt and Josiah Carwile. No mention is made of the place. Just after this it was placed on record to have the minutes read on Conference days. In June 1834 John Kay and Reuben Shirley were named as delegates to the Friendship Union meeting.

It is noteworthy that some of the brethren had the welfare of the Church at heart, Cador Gantt, Wm. Pratt and Josiah Carwile named as a committee to see into having the Church incorporated. Just a little over a year later, May 1836, Cador Gantt was ordained to the ministry. Brother Gantt was most active in all church work in 1842 he ably assisted Brother Gaines in a protracted meeting when 27 united with the church. Brother Gantt's activity was cut short after his ordination. A page in the minutes is dedicated to his memory—Dec. 2, 1845.

In 1837 in Conference the question was discussed whether a member should attend a Valentine party, etc. It was agreed that members who did would be dealt with. In August, 1838 Brother Crawford was appointed deacon, a little later granted the privilege to exhort, shortly after this was licensed to preach. Brother Hiram Lecroy assisted in a meeting of days, when 42 were added to the Church. Union meetings met with the different churches then, as done now. In May 1835 the Union met with Little River. No query is mentioned for discussion, but in a later conference, Brethren Williams and Cador Gantt named delegates to Union at Penial Church. In the April Conference, Brother Fisher was named deacon, the admonition

was given by Brother Jas. Fantt, by request of the church, that Cador Gantt, L. M. Tribble and R. Kay to lay out the cemetery and have it fenced and that Brethren L. M. Tribble, Fisher, Griffin and Wm. Pratt serve as wardens of the incorporation. (Miss Laura Robinson was the last person to be buried in the old part, before adding the new.) In Feb. 1851 the constitution ordered prepared should be produced and investigated. July 1851 is the first mention we find of sending money for association minutes, \$2.00 is named. Then again in July 1854, \$2.50 for minutes. Just prior to this at a revival 30 had been added to the church. By now the church had grown numerically. There was need for more room. In July 1855 it was agreed by church action to add twenty feet on the north end of the present house, to be completed in and outside the work to be done by contract \$505.00 being the contract price, while no contractor is mentioned, Colonel Wm. Clinkscales is mentioned in building the steps, etc. At the same conference a collection was taken for Home and Foreign Missions amounting to \$30.50. Just one year later another similar collection which amounted to \$44.07—two new deacons being elected. Jas. M. Carwile and Sherard W. Callaham.

In May 1859 Rev. Jas. Kay departed this life, S. M. Tribble, Church Clerk asked the church to draft suitable resolutions in memory of Brother Kay. A page in the minute book dedicated to his memory.

HISTORY OF LITTLE RIVER BAPTIST CHURCH By John M. Pratt

Rev. Arthur William, or Father Williams as he was affectionately known, died in May 1860, at the age of 81. A page in the minute book with resolutions of respect dedicated to his memory. Father Williams' exhortations began in the early history of the church, starting from some remarks he made at the baptismal waters, the day of his immersion, he joined the church at Providence, Stony Point, Abb. Co. his pastor Rev. David Tilly offered his encouragement to Father Williams, as he could not read a correct sentence offering to send him to school. Father Williams declined. saying I thought I heard, I thought I saw. He served Little River faithfully for about 50 years or about one third of the church history. Be it said of him that he served the church one year for 50c and a pair of sox. His last resting place is in the cemetery near the church for which he labored so long, quietly awaiting the resurrection. In appreciation for his loyal service, the church voted the remainder of the year's salary to his estate. Just here I wish to state that there is no record of who was the first pastor of the church, but tradition names George Tillman as first pastor with Joseph Culp - - - as deacon.

The first conference after Father Williams death, Rev. Willson Ashley was elected. In accepting the call, he stated to the church, that he would be there if it didn't rain straight down. The Church Clerk, L. M. Tribble, records the same day that \$97.34 was sent up to the Association; for what purpose is not stated. Rev. Ashley served as pastor 1 year. Tradition says that his services were much in demand in performing the marriage vow, performing over 500.

Elder V. Young was elected after Rev. Willson Ashley. At this time the struggle between the North and South was going on. In July 1863 \$135.00 was forwarded to the association, under the same date \$111.80 to buy Bibles and Testaments for the soldiers.

By a rising vote in Oct. 1866 Rev. Ashley was elected again to serve one year, by a previous resolution of the church that the colored brethren should be taught and nourished. More than 100 were members with nearly 300 white. Rev. W. E. Walters succeeded Rev. Ashley, preaching his first sermon in Feb. 1867 at a salary of \$200.00 a year. \$25.00 more than to Elder Young. The first stipulated salary on record. Rev. Walters was a man of great ability, one who could break up the fountains of the cold and indifferent. He was instrumental in Little River taking a part in the endowment fund of Furman University. The result of the protracted meeting in 1868 was 36 whites and 3 colored, there was no night services then. 2 sermons a day with dinner on the ground. In 1869 J. N. Carwile, Robt. Pratt and Wm. Clinkscales did some repairing to the church, for which they received \$6.80 with \$20.00 turned over to S. J. Callaham for the house and wood, this being the first direct reference to heating the church. The heaters now used are the same ones from the old church.

In 1869 Rev. Walters was again elected at a salary of \$300.00. In 1870 Rev. Rice was voted \$100.00 to preach the 1st Sunday in each month and the following 2 years Rev. Walters \$100.00 per year for each first Sunday. At this time the records show a membership of 252 whites and 27 colored. Other churches had sprung up and many letters of dismissal had been granted. At this conference we notice the first mention of an annual report of moneys, for benevolent purposes \$32.45, for all purposes \$477.77.

In April 1873 Rev. Walters resigned and Rev. Willson Ashley was elected for the year. In Jan. 1874 Rev. R. W. Burts began

his duties as pastor, a beloved man. Brother C. C. Tribble states that the colored members are requested to bring tools to do some repairing on grave yard fence and that 6 or 7 inches to be taken off of back seats in church. In 1875 some board timber was cut, the church selling the school house their part of the boards at 35c per hundred.

1876 the church bought a piece of land from Henry Clamp for \$25.00. In 1876 S. M. Tribble, the Church Clerk, prior to Brother Tribble, John Pratt served 13 years as Clerk. Tribble 27. J. W. Ellis succeeded Tribble. Rev. R. W. Burts was elected for the year 1878 at \$150.00 salary. Rev. Willson Ashley to preach each first Sunday for \$50.00. During the pastorate of Brother Burts many were added to the church. In 1879 he resigned, Rev. J. Scott Murray elected as pastor, Brother Jas. M. Carwile who had served as treasurer for many years resigned in Feb. 1880, his son P. B. Carwile was elected in his stead. Brother Carwile specially appealed to this writer being young and small, he had some encouraging word, and a hearty hand shake, Brother H. Robinson is worthy of mention, for the encouragement and advice given us. Both of these noble men lived neighbors and were builders in the church.

In 1881 Rev. J. Scott Murray was again elected by a rising vote, and to pay \$200.00 salary for 1st and 3rd Sundays and \$100.00 as supply. The writer joined the church under Brother Murray's preaching in 1880.

In Feb. 1882 R. N. Pratt asked that a committee be appointed to assist in the organization of a church at Due West. (Brother Pratt worked up the organization of a church at Abbeville.) It should have been stated before that Brother Pratt was ordained to the ministry here, preaching his first sermon here and did the preaching at some of the revivals. Rev. Murray served the church 1883 and 1884 at a salary of \$300.00. During his ministry the church grew steadily.

In 1885 the church appointed a building committee for the erection of a new house of worship and that each family be given the privilege of taking a part. In 1886 the necessary amount being subscribed, a contract was made with Mr. John Wrenn to furnish all material and labor for \$1200.00. Part of the old church was torn down, the newest addition rolled back and converted into a baby house, services were held in the old school house near where a parsonage was later built. In June 1886 the new church was dedicated. J. C. Furman, D.D., preached the dedication sermon. Ps. 133, Ephes. 4:4-6. The writer could not be present on account of measles.

1888 Brother Scott Murray retired and D. Weston Hiott

elected as pastor, Rev. Mendenhall helped in the Summer revival. 37 united with the church, a baptistry had been built at the spring near the parsonage.

1889 a church contribution was taken for Mrs. Sophronia Martin who had lost her possessions by fire.

1890, the ladies took the initiative to carpet the aisles. In Aug. 1891 the Centennial of the Church was fittingly observed by the Saluda Association meeting with us, though it was rainy most of the 3 days. There was a good crowd. Dr. Jones from Atlanta, Ga., was a main speaker. In large beautiful letters arranged in a semi-circle "1791 Centennial 1891"—In those days the delegates sometimes went to their assignments the night before by horse and buggy. Quite a difference now.

1891 Mrs. Hawkins reports \$25.00 on hand, to be used for a special purpose. It should have been stated that R. D. Hawkins was elected pastor in 1889 and under his guidance as shepherd during his ministry of three years many united with the church, many restored. Upon their leaving us the W. M. U. presented them with a beautiful silk crazy quilt and chair cushion.

1893 Rev. J. J. Farmer was pastor at \$400.00. Brother T. L. Haddon, pledged individually \$25.00 above the \$400.00. The parsonage had been completed by pledges and labor. It appears that the salary of Brother Farmer was over due for in preaching his farewell sermon in 1894 he used the text, "bring ye the tithes into the store house."

There is a short period here the church was without a pastor, in 1896 the services of C. E. Burts was secured. In 1896 Rev. P. G. Hopper was elected for 1897. He and his wife moved into the new parsonage, but his work was cut short, about June, 1898 he and his wife took fever on July 4, both died. W. D. Moorer was elected for the remainder of the year, 1899 living in the parsonage. Dr. Robinson was keeper of the Church at \$10.00 per year. Brother Moorer was a great teacher, a number joined during his pastorate, two of the number here today. M. G. and S. F. Ellis. Brother Moorer taught that anything which failed to do that for which it was intended was "a thing." From the building of the parsonage and sinking a well, the well had never furnished any water, it was discussed in Conference in Feb. 1902, the advisability of selling the parsonage with 7 acres, to pay some indebtedness thereon, later it was sold. Just prior to this the W. M. U. began advocating enlarging the cemetery and erecting a lasting fence, the result of which is the enclosure as is seen now, costing approximately \$500.00 to begin with to keep it cleaned off, it was let by contract for \$36.00 and until now is let by contract, there are about 750 buried therein.

- R. E. Small was called to the pastorate for 1903. J. T. Bryant, C. C.—Brother W. W. Leathers made an appeal to buy a tent for the association. 1904 a collection was taken to pay for the carpet already down. A. T. Rogers was pastor for 3 years, many were added to the church during his pastorate. The church bought singing books and has continued to do so until now. In the meantime, W. W. Willson was elected housekeepe: at \$16.00 per year for 1910. G. T. Ashbill was elected as pastor for 1911 at a salary of \$350.00 per year, the church agreed to have a telephone put in the parsonage for his use. J. C. Pruitt had been elected Supt. of cemetery, in rendering his report he reported \$20.70 on hand, after the workings completed.
- 1912 J. E. Covington of Greenville was elected as pastor for 1913, at \$350.00. Brethren M. G. Ellis and A. F. Carwile, Jr. named as a committee to confer with First Creek on the parsonage finance. F. E. Ellis of blessed memory was instructed to buy grape juice for the May communion service, Brother Ellis had been active in Church work for many years, serving in various capacities, Clerk pro tem, Mod. pro tem, S. S. Teacher, deacon for many years.
- 1915 W. J. Foster was called to the pastorate. J. N. Pratt, C. C.—(A. F. Carwile, Jr. had served as clerk 7 years). At a later conference W. N. Ellis was elected treasurer to succeed Brother Carwile who resigned. Brother Ellis has succeeded himself these many years. The first revival of Brother Foster resulted in 35 being added to the Church by baptism with several by letter, the baptism taking place in R. O. Branyon fish pond. There seemed to be an awakening to some of the real needs of the church, an active move was started to put an addition to the pulpit end of the church, build a pool and dressing rooms, and sink a well. A committee was named to carry out the plans. In Sept. the work was completed by labor given and pledges paid. John N. Pratt, Clerk for committee, reported Jan. 1916 the work finished, \$256.67 rec'd and paid out. Realizing that the church needed a new organ the S. S. Supt. proposed that each member give 1 cent for each year of their age; \$102.67 was raised. 1917 G. L. Alewine was paid \$9.65 for making the necessary repairs on the heaters. This pulpit stand the same one used in the old church. Brother Alewine is the oldest living member of the Church being about 93. J. E. McManaway preached during the revival with 12

additions. Looking forward to the Association meeting with us next year a committee was named to make the necessary provisions. Aug. 1918 the association met with us. Dr. P. B. Carwile made the address of welcome. Brethren Robert and Vol Pruitt of Mt. Bethel ask for a delegation. Rev. Dean Crain was one of the principal speakers.

1918 Rev. Hohn assisted Brother Foster in a meeting of days with 17 additions. On account of the flu epidemic, but very few meetings held in winter by request of authorities.

1920 Cecil Pratt was given the contract to repaint the cemetery fence for \$35.00. 1921 J. M. Culbertson was elected pastor at \$500.00. serving two years during which time 24 added to the church. T. T. Campbell had the contract to clean the cemetery for \$48.00. L. M. Smith succeeded Brother Culbertson for two years receiving \$500.00 per annum. During his ministry a sanitary communion set was purchased for \$20.75. Brother John Jolly assisted him in a meeting of days w.th 22 conversions. Brother E. P. Driggers was pastor for 5 years at a salary of \$500.00 annually during which time 66 united with the church, being assisted in different meetings by John Hicks, E. C. White and Biers of Greenwood. During this period 7 new deacons were elected and ordained so far as the records show. This is the only meeting where young ladies lead a prayer service, Misses Carrie Lee Burton and Willie Kay. P. H. Kelly was elected pastor for 1933 at a salary of \$300.00. During his two years as pastor 14 united with the church. The W. M. U. presented the church with a new piano. After serving 20 years as Clerk, John N. Pratt resigned. R. L. Ashley elected to fill the vacancy. Prior to this M. B. Clinkscales had left a bequest to the cemetery fund amounting to \$250.00. During 1937 and 1938 C. D. Garner was elected pastor. Earl Simmons, Clerk. W. A. Loudermilk assisted in a protracted meeting, also L. M. Smith, 20 uniting with the church. It was during this pastorate that a special collection was taken for (my good neighbor) J. W. Strickland as a token of sympathy in the loss of his companion. A little later a collection of \$20.00 was given to First Creek Church to help replace the building lost by fire. C. H. Southerland was called to the pastorate for 1940. Arthur Murdock, C. C.—It should have been stated that in '39 a new front was added to the church, making it more attractive, also worthy of mention W. F. McAdams left \$200.00 to the cemetery fund. Brother Sutherland's salary was set at \$400.00. He has only held one revival, 7 joined by experience, 2 by letter. In March 1938 the church was nicely covered with asphalt roofing adding much to its appearance. After which \$1500.00 insurance is carried. Instead of the old wall lights we have electric lights. Brother Sutherland has just resigned his pastorate; for the present we are without a pastor. A short glimpse backward reveals the fact that there are not many of the membership now who have the names of those who are so often mentioned 70 years ago, who have answered the last roll call. A new generation has grown up, but we are thankful for their great zeal for the Master, down through these many years the church has possessed many choice spirits in both men and women. leaving to future generations the highest standard of Christian living.





FOREWORD

Little River Baptist Church, located in Abbeville County, South Carolina, was organized in 1791, as an "arm" of Turkey Creek Baptist Church, and was given its name because of its proximity to Little River. It has held a place of leadership in its community and denomination throughout the years.

My husband's great-great-grandfather, John Callaham, worshiped at this church, along with his neighbor, Zachariah Carwile. Also, Hugh Robinson, my husband's maternal grandfather, was a deacon and active member. Many descendants and relatives of these three men have been numbered among the church's members and officers, and it is the meeting place for the Annual Reunion of the descendants of John Callaham and Zachariah Carwile.

The Church Cemetery is a very large one, enclosed by an iron fence, and adjoins the property on which the church building is located. It is used regularly at the present time as the burial place for church members and others, is a revered and fascinating spot for descendants of many old families, and is visited often by persons interested in genealogy.

Our attempt to record the tombstone inscriptions began with the oldest section of the Cemetery in November, 1966. If new graves or markers have been placed in this area since that date, these may not be included. Several visits between November, 1966, and November, 1968, were required to complete the data on the following pages. In some instances, relationships determined by the names of husbands and wives on a single stone, placement of graves, etc., are shown within parentheses, which will indicate these are not actually inscribed on the stone.

The condition of some of the stones is such that it is very difficult to read the inscriptions. Many of them have been affectionately "patted" with a small cloth bag containing flour, which made it possible to decipher names and dates, or to identify them by tracing with the fingers. Much time was spent placing fragments of stones together, or removing soil from them, in order that all inscriptions might be listed.

The very fact that human effort is involved in an undertaking of this kind makes it probable that there may be some errors, but an honest endeavor has been made to copy the markings on the gravestones as accurately as possible.

It is our hope that this compilation will be of interest and aid to many whose forebears rest in Little River Baptist Church Cemetery, and to others who may hold pride for an old historical church and community.
