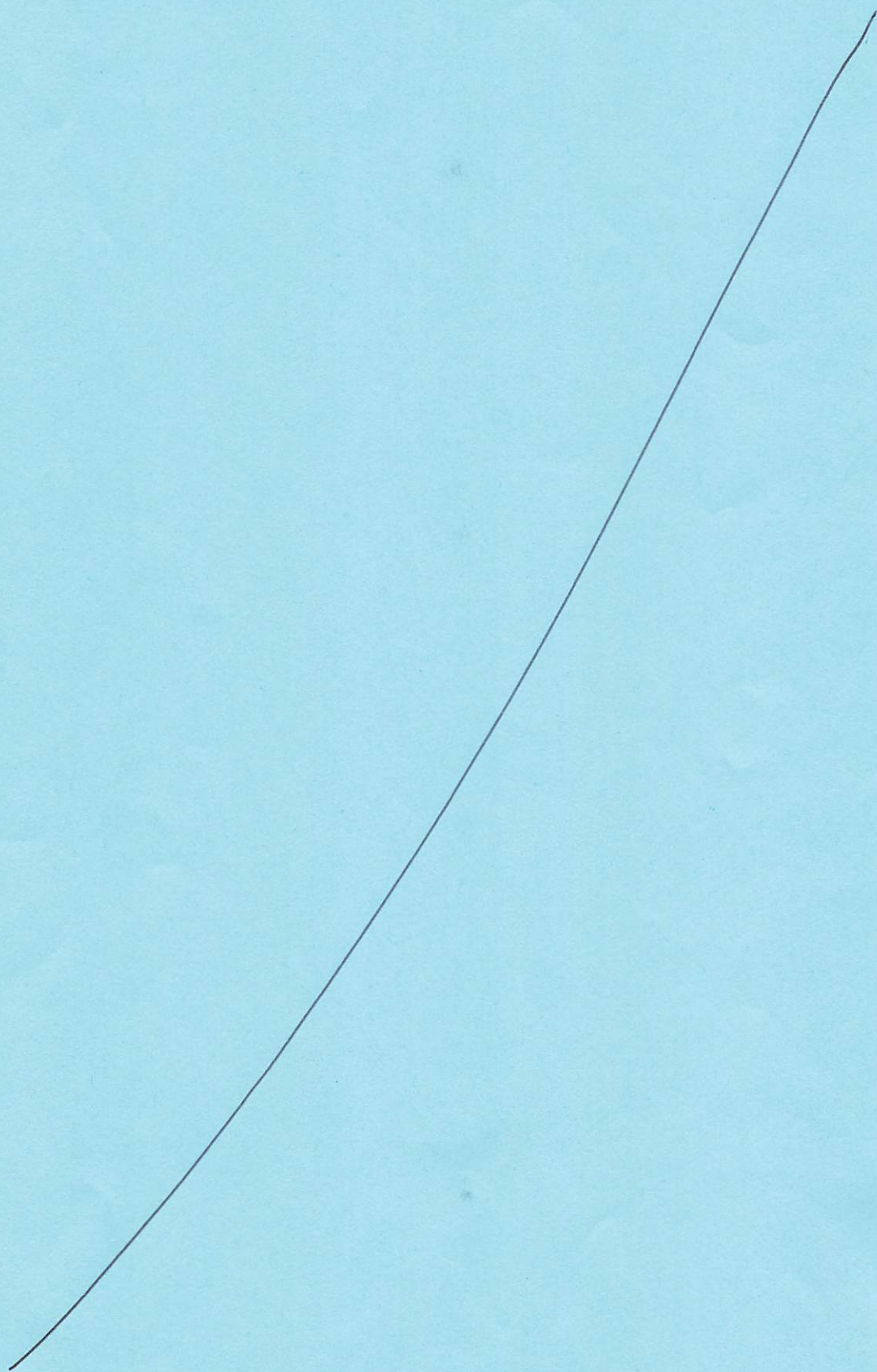

and fifty seven, Nicholas Zeigler, the brother of your Petitioner's Testator, departed this life in said State of Alabama, bequeathing to your Petitioner's Testator a family of slaves. That your Petitioner's Testator allowed the said Albert Crumpley to take said family of slaves, he agreeing to pay him therefor. That in a settlement had on the fifth day of July eighteen hundred and seventy two, the said Albert Crumpley was found to be indebted to your Petitioner's Testator in the sum of One Thousand and fifty dollars. That said sum of one thousand and fifty dollars has never been paid, but is still due and owing. That the property of the said Albert Crumpley has been greatly reduced by the results of the late war, which fact, together with the large "homestead" exemption allowed in Alabama, renders it utterly impossible for your Petitioner to collect said debt by process of law and the same is in danger of being wholly lost to her Testator's estate. But your Petitioner hopes and believes that by offering a compromise of said debt to the said Albert Crumpley, some portion thereof may be saved to her Testator's Estate, wherefore, she prays your honor that she may be authorized by order of this honorable court, and by virtue of the Act of Assembly of this State in such case made and provided, to compromise said debt for such sum as she may be able to obtain from said Albert Crumpley in satisfaction thereof. 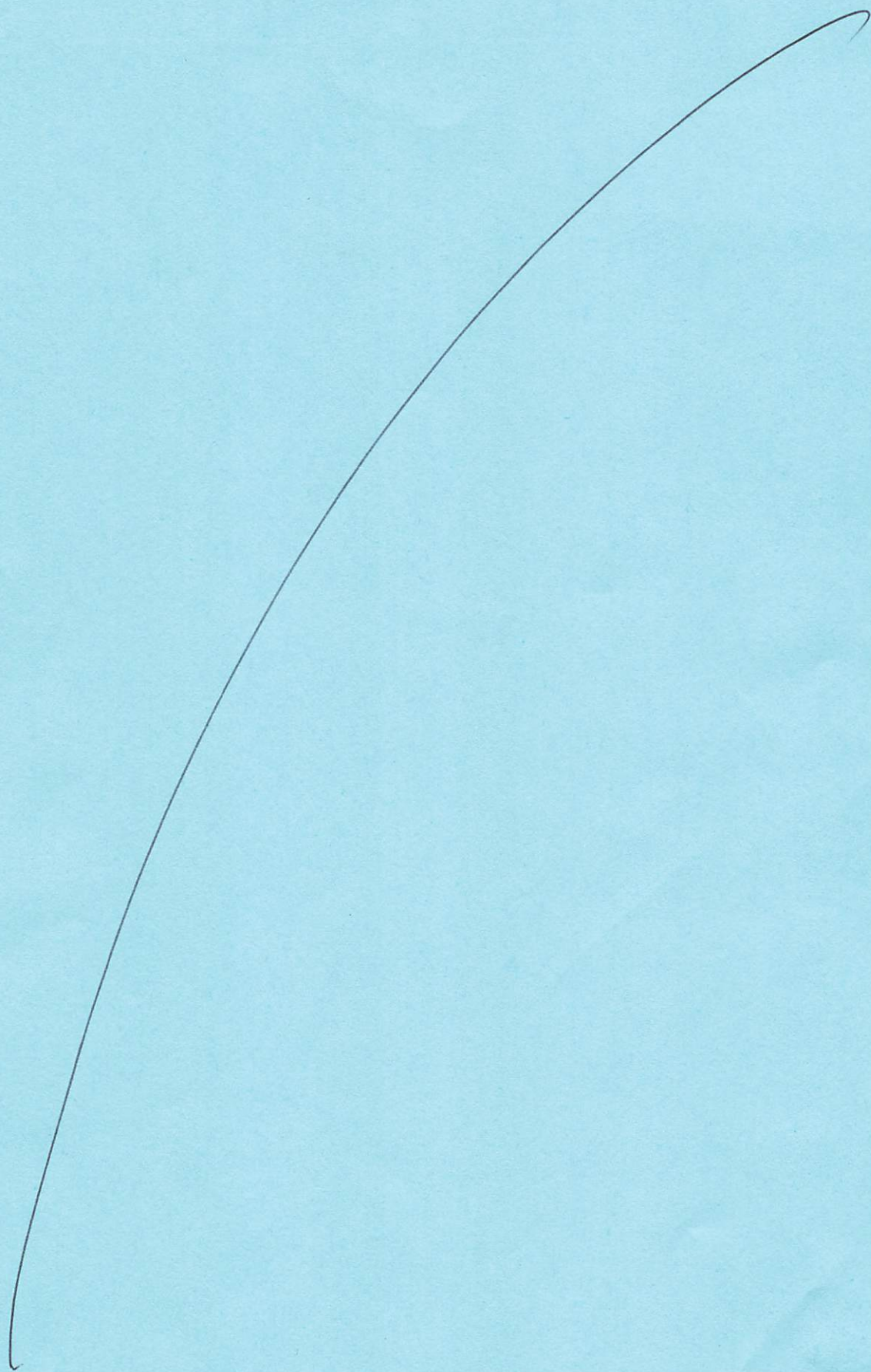

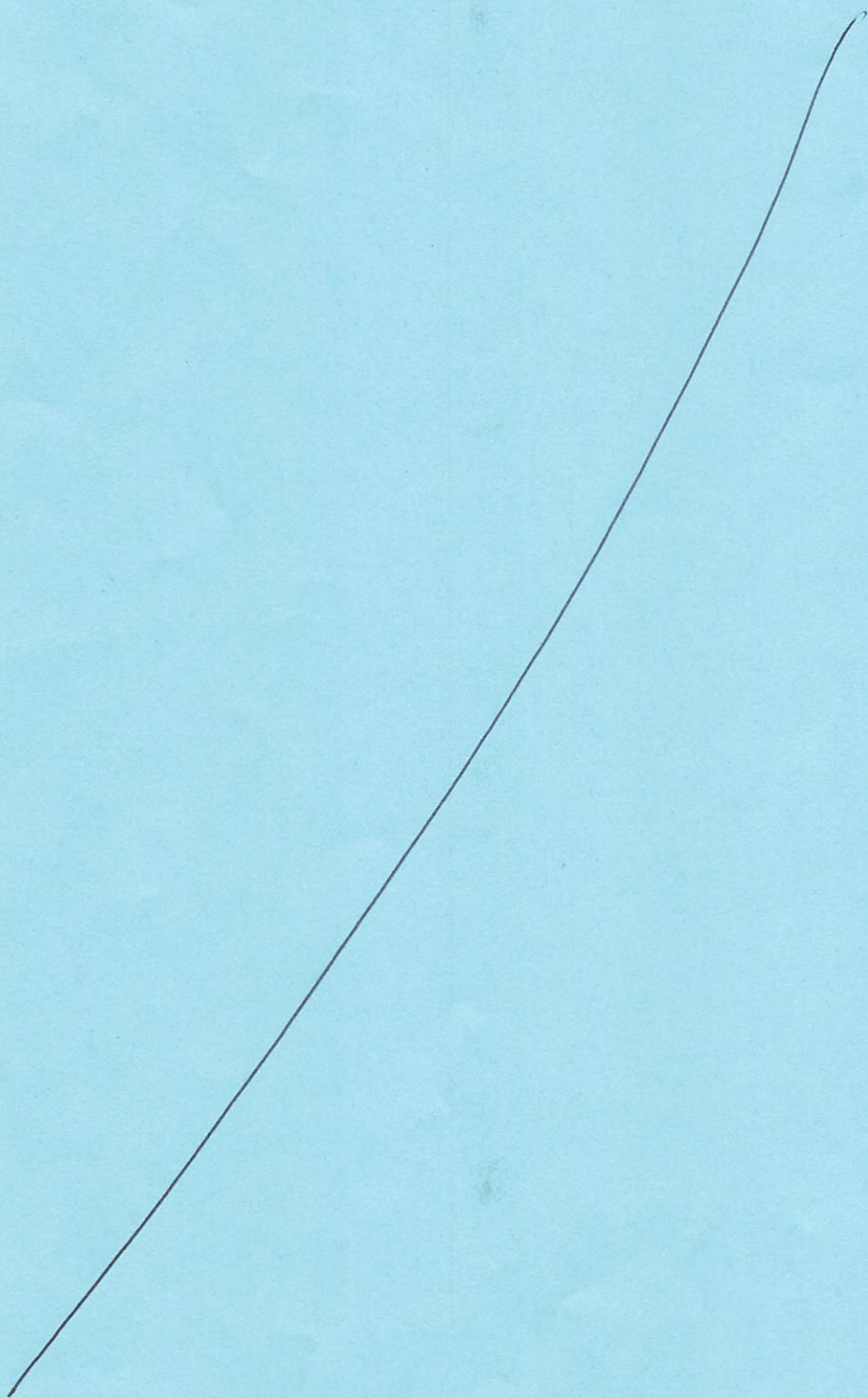
