Finding the Five Tribes at Clayton Genealogical Library

When researching the five tribes removed from the southeastern United States, Cherokee, Chickasaw, Choctaw, Creek and Seminole, one should research the Dawes Roll for each respective tribe, first. This enumeration was the result of the Curtis Act of 1898, which authorized the Dawes Commission to begin allotting land to individual Indians as soon as the citizenship roll of their tribes was completed. The final Roll of the Dawes Commission closed in 1906. Citizenship was based on proof of Indian lineage and not on blood quantum. Recipients had to be residents of Indian Territory (Oklahoma) at the time of enrollment, 1896-1906.

The best source for all five tribes at Clayton is the Native American CD of the Dawes Roll. It lists every individual who was a recognized citizen of one of the five tribes and received a land allotment. The CD is user friendly and one can easily find an individual by typing in the name and tribal affiliation. Details for that individual will come up which include age, blood quantum, Dawes Roll number and the Census Card Number. By clicking on "Search Page", an individual may be found listed with his/her family.

If this appears correct for your research, then use the Census Card Number and go to the microfilm in the Native American Drawers and look for that number on film. These cards list the head of family, wife, and children and their parents. The head of the family's parents may be listed as John Jones, Non-Citizen, and Mary Smith, Coo. Non-Citizen means that John Jones was not a citizen of the Cherokee Nation but Mary Smith's listing as Coo means she was a citizen of the Cooweescoowee District of the Cherokee Nation and she was the Cherokee by blood. If both parents were Indian by blood then they will be listed as residing in their respective districts in their Indian Nations.

If you are successful in finding a direct ancestor on the Dawes Roll, the CD will generate a letter for you so that you can order the application packet,

which contains a personal questionnaire of the individual who applied for registration. It will also include records of birth dates, dates of death, marriage records and family relationships. Some even contain family tree charts. Armed with this information, one is prepared to make application through their tribal registration office for tribal membership. Other genealogical information can be obtained from those persons who were rejected for the Dawes and their applications can be ordered with the CD-generated letter also.

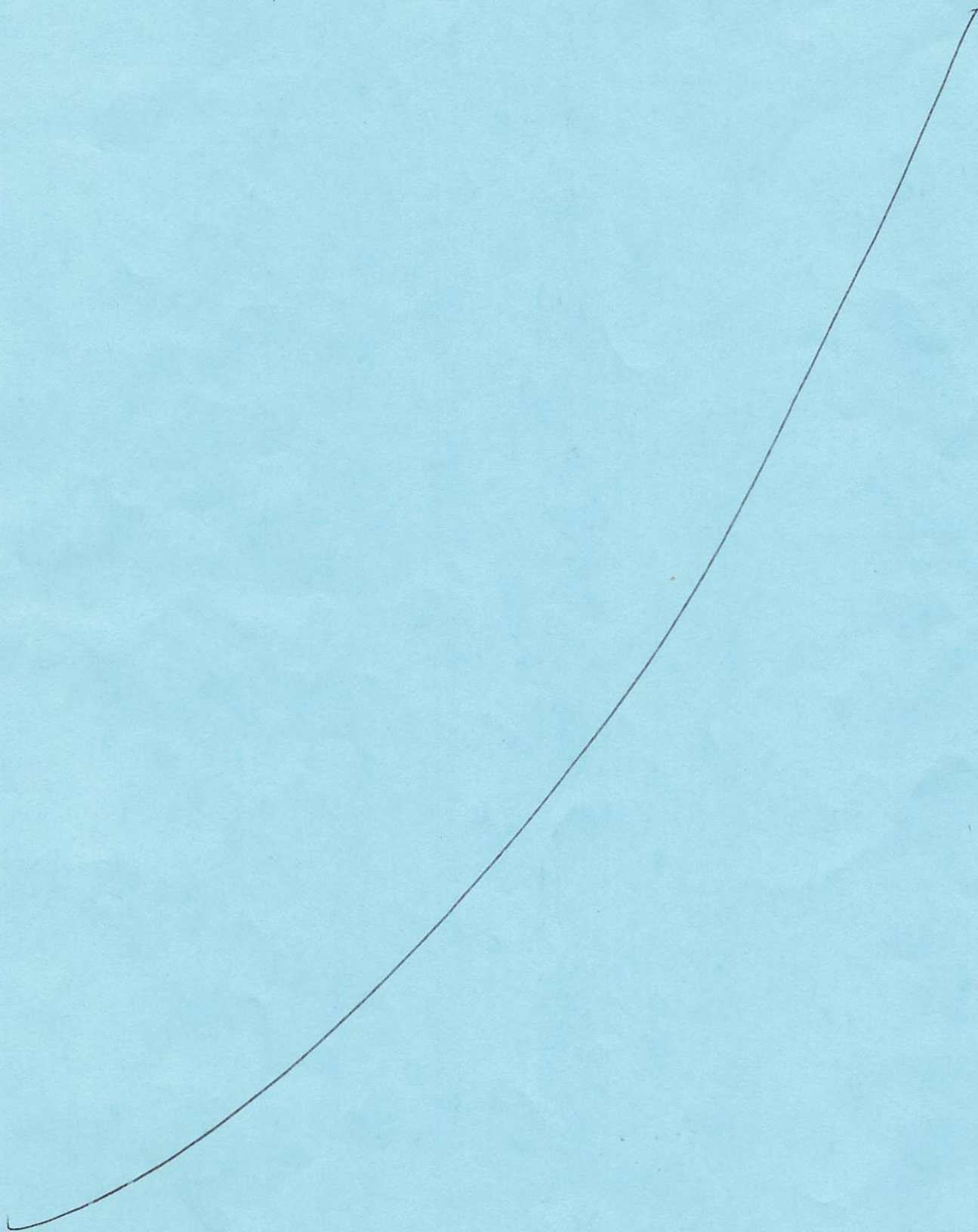
Other records available for research at Clayton include: The Cherokee Guion Miller Roll Index; the 1832 and 1893 Creek Census; 1878 Chickasaw Annuity Roll (also in book form); 1893 Chickasaw Payroll; Register of Choctaw Emigrants to the West (OK Section); and Choctaw Marriage Records, 8 Vols. (OK Section). M295 lists census records of most federally recognized tribes, 1885-1940. The 1860 Western Arkansas Census lists enrolled citizens living in Indian Territory and this information is at the end of these rolls.

Later census records for the five tribes at Clayton are the 1900 Oklahoma Federal Census, Indian Territory, which includes the five tribes, and the Peoria, Quapaw, Seneca, Wyandotte, Seminole, Modoc, Ottawa, and Shawnee tribes. The 1910 Oklahoma federal census denotes Indian citizenship with a listing that continues below the standard enumeration. This census names tribal affiliation and the degree of white blood.

There are many more resources for researching the five tribes at Clayton but they are too numerous to mention here. By following these suggestions, you can begin your research and then do a more in-depth study after exhausting these sources. The Clayton Staff will be glad to answer any questions you may have concerning these records. Take advantage of their knowledge and take the plunge.

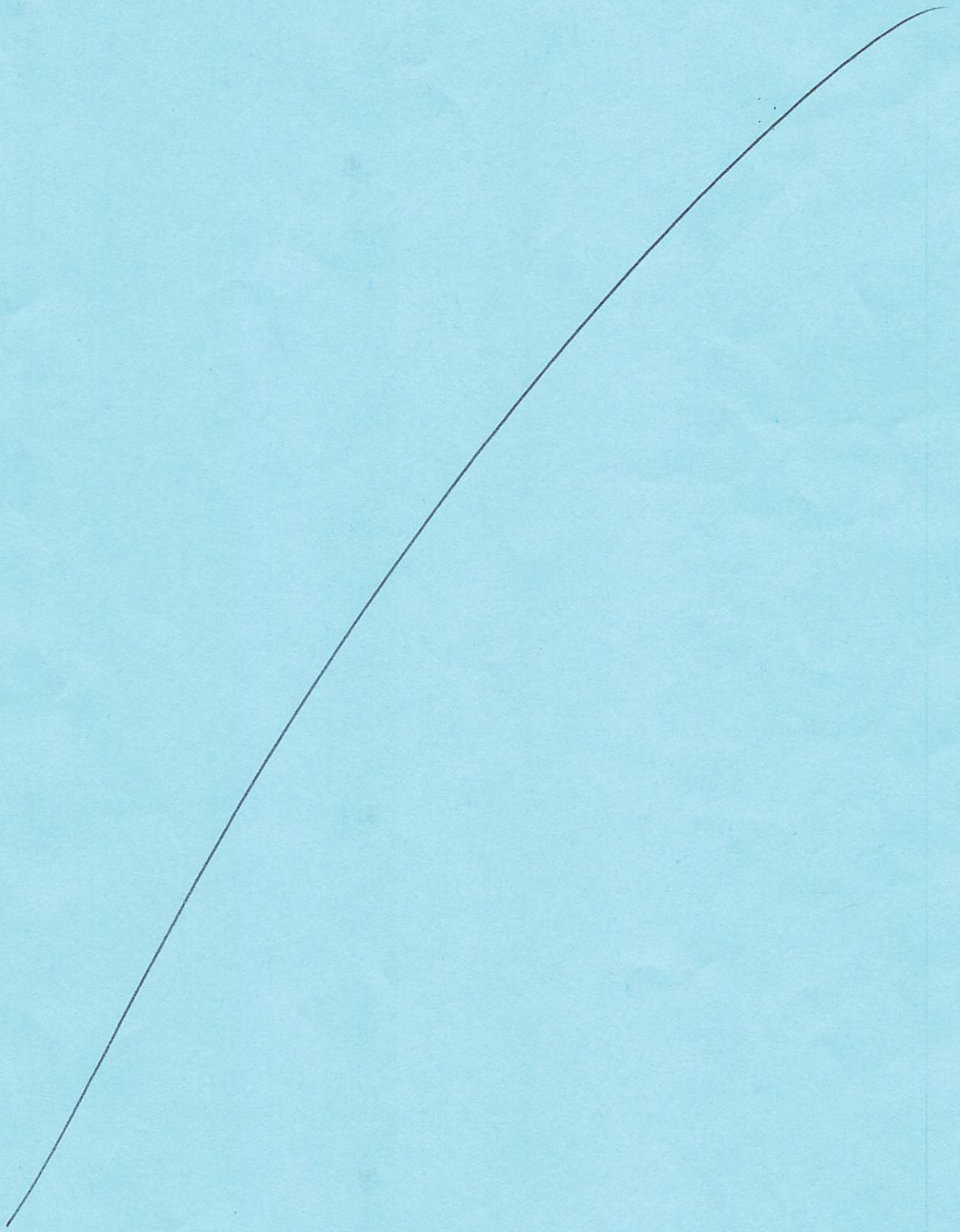

Vital records of this church between 1851 and 1978 have been microfilmed at least twice. Those films are available at Clayton Library and the Texas Room of the Houston Public Library, as well as through any LDS Library.

There are two sets of baptism records on the primary microfilm: 1847-1859, and 1851-1950. Confirmation records start in 1852, marriages in 1874, and burials about 1857. Records prior to 1918 are in German, and those prior to 1904 are in the old-style handwriting ("der alte Handschrift") as well.

The first record of Communicants is dated 13 July 1851, two months before the formal church constitution was adopted. Thereafter, they were typically recorded on Easter, Pentecost, and Christmas; sometimes also Trinity Sunday, the first Sunday of Advent, and other dates.

In the period 1851-1880, newly confirmed persons are listed both with the Communicants and in a second list (sometimes with different spelling) that usually includes their birth dates.

The lists that follow have been

alphabetized for ease of use; numbers have been added indicating the original order of the names. An asterisk indicates that the person was confirmed at that time. These dates have been extracted as indicative of some (not all) adult members of the church community:
