- Wed, 9 May 1917 (2-5) Joe and Jesse BOHNE, twin brothers, left Cuero, Texas, on 25 March 1917 and went to Houston to enlist in the U.S. Navy. In the training station at Great Lakes, Illinois, Jesse became sick and died. He was buried in Cuero. Joe did not know of his death because Joe was on the battleship "Arizona". On 9 May, their parents, Mr. and Mrs. Fritz Bohne, were notified that Joe died at the naval hospital at Portsmouth, Virginia, after one week of illness. Burial was to be in Cuero. They were age 17.
- Wed, 9 May 1917 (4-3) In San Angelo, E. P. DUGGAN shot and killed J. A. PASLEY, a grocer, in a dispute over a dozen eggs.
- Wed, 9 May 1917 (7-4) Dorothy Marion WHEELER was born 9 May 1915 to Mr. and Mrs. Wm. T. Wheeler, now of 720 Reynolds St., Waco. On 8 May 1917, she died. Burial was in Oakwood Cemetery.
- Wed, 9 May 1917 (9-5) Jeptha FRY, 80, died today from burns on Sunday when accumulated gas exploded in the bathroom of his brother, W. S. Fry, in Denton. W.S. was badly burned. Thurs, 10 May 1917 (7-3) Mrs. Julia May SMITH, 18, of Hico died today in a Waco sanitarium. Burial was to be in Hico. Survivors: husband J. H. Smith, one child, father J. M. GRISHAM, several brothers, and one sister.
- <u>Fri, 11 May 1917 (1-6)</u> Thos. W. ROZELL, 64, died today at home at Gholson, after a long illness. Burial was to be 12 May at the Gholson cemetery. He lived in Gholson all his life. Survivors were three daughters, two sons, brother Jim Rozell, and sister Mrs. Mary Jane WALKER. They all lived in Gholson.
- Fri, 11 May 1917 (1-7) Mrs. M. J. HOOTEN, 69, died today in San Antonio at the home of her daughter, Mrs. Jimmie MELTON. Her funeral was set for 12 May from Fifth Street Methodist Church in Waco. She left Waco 10 years ago for Fort Worth and moved to San Antonio one year ago. Survivors were her children: Mrs. Jimmie Melton of San Antonio, Mrs. R. A. TRICE of San Antonio, Mrs. George DAVIS of Kansas City, Kansas, and Sam Hooten of Waco. Fri, 11 May 1917 (3-3) M. D. WATSON, 47, died today of erysipelas (St. Anthony's Fire) at the Savoy Hotel in Waco, after a week's illness. He was well known as a hotel owner and operator throughout Texas. He came to Waco at age 24 from Marion, South Carolina, and opened a restaurant in the Katy depot. Next, he acquired control of the Exchange Hotel at 3<sup>rd</sup> and Franklin Sts., then the McClelland Hotel, then went into a partnership with T. H. GLANCY to buy and operate hotels in Waco, Dallas, Fort Worth, and St. Louis, Missouri. He returned to Waco in 1916. Funeral arrangements were not stated.
- Fri, 11 May 1917 (10-3) W. R. HODGES died suddenly at home in Ranger, Texas. His funeral was to be in Ranger. Sons were Dr. R. H. Hodges and Dr. W. R. Hodges, both of Waco. Fri. 11 May 1917 (10-5) Mrs. Minnie Ward MOODY, 42, of Gatesville, died of heart trouble on 10 May at the home of her sister, Mrs. Lile DeCORDOVA, 118 South 16<sup>th</sup> St. Her funeral was set for 12 May from the DeCordova home, with Rev. Alonzo MONK of Gatesville officiating, followed by burial in Oakwood Cemetery. She was born in Wise County. Survivors: husband Ed C. Moody, four children, parents Mr. and Mrs. O. G. WARD of Springtown, Texas, sister Mrs. Lily DeCordova of Waco, and brother Will Ward of Fort Worth.
- Sat, 12 May 1917 (1-1) In Goliad, Charles JOHNSON, who owned and managed City Garage, was killed on 11 May when he touched a live wire on his sign in front of his garage. Sat, 12 May 1917 (1-6) Arthur MULLINS, 36, a farmer near Midway, four miles west of
- Temple, shot and killed himself today. He was worried over his poor health.

Sat, 12 May 1917 (5-4) The funeral of M. D. WATSON was to be tomorrow from the Puckett chapel with Dr. F. P. CULVER, Pastor of Austin Avenue Methodist Church, officiating.

Sun, 13 May 1917 (10-4) A jury in Wichita Falls found R. E. and Ewell MORRIS of Quanah not guilty of murder of Garland RADFORD at Quanah in 1915. Winnie Joe Morris, who was their daughter and sister, was acquitted in a trial a year ago in Quanah for the same homicide.

Tues, 15 May 1917 (1-3) In 37<sup>th</sup> District Court in San Antonio, L. D. WEBSTER, a newspaper man of Bryan, was acquitted in a trial for murder of Dr. G. W. EMORY of Bryan on 12 February in San Antonio.

Tues, 15 May 1917 (3-4) Mrs. Mattie E. HERBERT, 78, died suddenly today at home, 217 Dallas St. in East Waco. She was born in Newport, Kentucky, and came to Texas in 1869, to Austin and then to Waco in 1883. She was the widow of J. S. Herbert, a long time member of the Waco City Council from the Fifth Ward. At death, she still held membership in a Baptist church in Newport, Kentucky. Survivors were her son, Sam P. Herbert, who was city building inspector, and her brother, George BRINSTIN, of Ohio.

Tues, 15 May 1917 (12-4) W. P. WILLIAMS died in San Antonio yesterday morning. His funeral was today from the Katy depot in Waco and burial was in Oakwood Cemetery. He left Waco 10 years ago. He worked as a Katy railroad conductor for 25 years. Survivors were his wife and one daughter, Miss Kate Williams.

Wed, 16 May 1917 (3-2) Mrs. Addie Lee HARDIN, 73, died yesterday at 4:00 p.m. in the home of her son-in-law, S. L. MARRS, on the Marlin road. Her funeral was at 3:30 p.m. today with burial in the Harris Creek cemetery.

Wed, 16 May 1917 (10-4) John Wm. CALDWELL, 81, died at 2:30 this morning at home, 718 Garland Ave. He was born 1 August 1835 in Wayne County, Kentucky, settled near what is now McGregor in the early 1850s and went into ranching. He served in Company I, 30th Texas Cavalry, Confederate Army, in Kentucky, Missouri, Louisiana, and Texas. Since 1882, Waco was his home. Survivors were his wife and a sister, Miss Mollie Caldwell of Clinton, Kentucky. His funeral was at 5:00 p.m. today from home, under the direction of Pat Cleburne Camp No. 222, United Confederate Veterans, and a minister. Burial was in Oakwood Cemeterv. Thurs, 17 May 1917 (1-7) Miss Marie MAYES drowned in Patterson Lake near Keenan, Texas, on 16 May. When their boat was sinking, she asked a companion to save a friend, Miss Cora LIVINGSTON, who could not swim, and let her fend for herself. The friend was saved. Thurs, 17 May 1917 (5-3) Mrs. Mamie GUITTARD, age about 36, died today in Albuquerque, New Mexico. She had gone there from Waco to try to recover from illness. About 11 years ago. she married Professor F. G. Guittard, teacher of history at Baylor University, and moved to Waco. Her funeral and burial were to be in Shiner, her former hometown. Survivors: husband, infant whose age was about two months, son Francis, age 9, mother Mrs. E. WELHAUSEN of Shiner, two brothers at Shiner, and one brother at Yoakum.

<u>Fri. 18 May 1917 (2-5)</u> Rowena JEZEK, 19 months old, accidentally hanged herself near Oscar, Texas, today. Her bonnet caught on wire as she went through a fence.

Fri. 18 May 1917 (9-3) Miss Stella ROSS, a teacher in a public school at San Antonio, died there on 17 May after being hit by an automobile. She was from Lockhart. Survivors: brothers Charles H. Ross and Dr. A. A. Ross of Lockhart and a sister in Dublin, Texas.

Mon, 21 May 1917 (3-2) J. W. ALLISON died today in Dallas of heart failure. He was well known as a cotton trader. He had been grieving over the death of his son, Lieutenant Joseph W. Allison, Jr., eight months ago, in the Army hospital at Fort Bliss at El Paso. The lieutenant

served with the expedition under General John J. PERSHING to catch the bandit, VILLA. He contracted pneumonia at Casas Grandes and was brought to Fort Bliss by motor car or truck. Pneumonia was the cause of death.

Mon, 21 May 1917 (3-4) Rev. W. W. SCALES, Secretary of the Baptist Missionary Association, was killed on 20 May when a Missouri, Kansas & Texas RR train hit the family automobile at Maple Ave. in Dallas. His wife and children were injured. Rev. Scales was age 46, was born in Texas to Dr. and Mrs. John H. Scales, and lived at 724 Center St. in Oak Cliff. Survivors: wife, son J. W. Scales in the U.S. Navy, daughter Lucy Lee Scales, in El Paso, and five children at home, who were Mary, 18, Ruth, 15, Nellie, 13, Edward, 9, and Harry, 6. His two surviving brothers were J. M. Scales of 410 West 10<sup>th</sup> St. in Oak Cliff and B. Scales of Birmingham, Alabama.

Mon, 21 May 1917 (4-5) R. B. (Bob) MARTIN, the Hill County Tax Collector, died on 20 May in Hillsboro from burns received the day before when he tried to rescue his son, Brooks Martin, age 14, from their burning home. Authorities assumed the gasoline stove used to heat bath water was left burning, when the family retired, and exploded. The residence of Marion CONOVER, next door, was almost a total loss. R. B. Martin was a son of the late Congressman Howdy Martin. A daughter of R. B. was in the 1917 graduating class of Hillsboro High School. The class publicly expressed their sympathy at the ceremony. The funeral for R. B. and Brooks was at First Baptist Church of Hillsboro on 21 May. Survivors were his wife and three children. One son was named Will.

Mon. 21 May 1917 (6-5) W. T. CAMPBELL, 80, died last night at the home of his daughter, Mrs. Cliff McDOWELL, at Clarendon. He was born in Washington County in July 1836. He owned and operated many ranch properties near Childress. He was a long time Methodist. Survivors were daughters, Mrs. Cliff McDowell of Clarendon, Mrs. N. A. OLIVE of Waco, Mrs. J. G. SMITH of Waco, six other daughters, son W. T. Campbell, Jr., of Wellington, Texas, brother C. M. Campbell of Temple, and two sisters.

Mon, 21 May 1917 (6-5) Mrs. Virginia McCollum STINSON of Camden, Arkansas, died 20 May and was buried there today. She was survived by several children. She was the eldest child and State Senator A. R. McCOLLUM was the youngest child in a large family.

Mon, 21 May 1917 (6-6) Mrs. May Eugenia ELLIOTT, 29, was killed when a train hit the family automobile on 20 May at South Bosque, 11 miles southwest of Waco. Her funeral was to be at Mount Calm, her old hometown. Survivors: husband J. A. Elliott, parents Mr. and Mrs. J. L. McKINNEY of Mount Calm, brothers Jim and Wilbur McKinney of Mount Calm, brother Norris McKinney of Abbott, and sister Mrs. Ben SMITH of Fort Worth.

Mon, 21 May 1917 (7-2) Dave SULLINS died in Dallas today after an operation for shotgun wounds suffered in Kaufman on 19 May. The alleged shooter was arrested in Kaufman.

Tues, 22 May 1917 (10-4) Mrs. James B. MOORE died in Cameron today and was to be burie

Tues, 22 May 1917 (10-4) Mrs. James B. MOORE died in Cameron today and was to be buried there. Her daughter was Mrs. John B. POTEET of North 13<sup>th</sup> Street in Waco.

Wed, 23 May 1917 (3-3) Louie Edward MORRIS, age 4 ½ months, son of Mr. and Mrs. T. E. Morris, died at home on South 3<sup>rd</sup> St., south of Waco city limits, at 5:20 a.m. today. He was to be buried at 4:00 p.m. today in Bethany Cemetery.

Wed, 23 May 1917 (4-1) Miss Eliza EARLE, 50, daughter of Major Isham H. Earle, died on 22 May at her father's home near Hewitt. Her funeral was to be on 24 May at home with burial in Oakwood Cemetery in Waco. She was born in Waco and lived most of her life in Hewitt. She was very active in the Baptist Church. Survivors were her father, sisters Miss Mary Earle of Hewitt and Dr. Hallie Earle of Waco, and brother S. R. Earle of Toltville, California.

<u>Thurs, 24 May 1917 (4-5)</u> Mrs. Ouida PRINGLE, 25, died at 2:35 a.m. today in a Waco sanitarium. Her funeral was to be at 4:30 p.m. today from the Thornton Christian Church. Survivors, all of Thornton, were: husband, R. V. Pringle, three children, mother Mrs. J. W. STUTTS, five brothers named J. M., H. C., W. B., P. P., and K. L. Stutts, and sister Miss Vera Stutts. Her sister, Mrs. J. M. TAYLOR, lived in Anderson County, Texas.

Thurs, 24 May 1917 (9-1) Gus ROSS, 50, was found dead in a shallow tank of water on a ranch near Abilene, Texas. He had no known family.

<u>Fri, 25 May 1917 (1-7)</u> Mrs. Eddie FISCH was charged with killing Miss Mamie BISHOP by gunshot last night in a Fort Worth hotel, managed by her husband. She accused Miss Bishop of destroying her marriage. Miss Bishop was a member of a prominent family in Cleburne. Another report on p. 12, column 6, said Miss Bishop was a stenographer in the county attorney's office. She died at the Mansion Hotel at the corner of 4<sup>th</sup> and Commerce Sts. in Fort Worth after being hit by six bullets.

<u>Fri, 25 May 1917 (14-3)</u> Mrs. J. M. PRESSLER and her son, Leonard Pressler, were killed on 24 May in an automobile wreck near Bullard. Miss Mollie Belle Pressler, sister of J. M. Pressler, was seriously injured.

Sat, 26 May 1917 (1-3) W. J. COOKE, an electrician for a theatrical stock company, was accidentally killed in a death chair on stage at a theater in Clinton, Oklahoma, on 24 May. By mistake, the chair was connected to a 2300-volt live wire. The play was, "Electrocuted at Five A.M." Cooke lived in McAlester, Oklahoma.

<u>Sat, 26 May 1917 (2-3)</u> Mrs. Katherine Hope JACKSON died yesterday. Her funeral was today from the family residence, 1219 North 16<sup>th</sup> St., and burial was in Oakwood Cemetery in Waco. <u>Sat, 26 May 1917 (6-3)</u> The funeral of J. B. COPELAND was today from home, 1508 McFerrin St. Members of WOW (Woodmen of the World) were in charge at the grave in Oakwood Cemetery.

Sun, 27 May 1917 (1-6) Mike DANA, 55, was gored to death by a bull on 26 May at Sour Lake, Texas. He died as others were taking him to another town to get help.

Sun, 27 May 1917 (2-7) Carl BRAZIL, 8, was killed on 26 May when he fell under a moving auto truck in Fort Worth.

Sun, 27 May 1917 (3-2) Ross EVERETT, 37, a coal miner, was killed when a string of mine cars ran over him in Carbon, Oklahoma, on 26 May.


Sun, 27 May 1917 (p.6, columns 1-3) An advertisement by Park Lawn Cemetery (A. L. STEIN, Superintendent) offered a burial plot for \$50 and up and a single grave space for \$10. Prices included perpetual care of a lot without further charge. Payment could be made in small monthly installments. The cemetery would send a car to carry those who wished to look.

Sun, 27 May 1917 (9-1) Mrs. Lucy Bell KEENAN, 80, died yesterday at the home of her daughter, Mrs. Kate Q. OLIPHINT, 308 North 12<sup>th</sup> St. Her body was sent to Huntsville for the funeral today at the Methodist church. She was born in Dallas County, Alabama, 29 July 1836, to J. R. and Matilda BELL. In 1853, she married W. H. QUARLES. To their marriage were born two sons, now deceased, and a daughter, Mrs. Kate Quarles Oliphint. Mr. and Mrs. Quarles moved to Mississippi in 1855. He enlisted in the Confederate Army when the war began and served until the end of the war. They moved to Huntsville, Texas, in December 1865. W. H. Quarles died in a yellow fever epidemic in 1867 at age 32. Later, the widow Quarles married W. Keenan. She had lived with her daughter in Waco since 1890. She had been an active Methodist for 40 years. Survivors: daughter Mrs. Kate Q. Oliphint of Waco and two granddaughters who were Mrs. W. W. CHAMBERS of Houston and Mrs. Sam PORTER of Canada.

Mon, 28 May 1917 (6-6) William BISHOP, 77, died 27 May at the home of his daughter, Mrs. Jas. E. ROWE, 712 Earle St. His funeral was held yesterday and burial was in Oakwood Cemetery, with members of Pat Cleburne Camp, United Confederate Veterans, as pallbearers. He served in Company K, Second Arkansas Infantry. His Methodist Church membership was at his old home in Arkansas. Survivors: wife and three daughters, who were Mrs. Jas. E. Rowe of Waco, Mrs. J. R. SINGLETARY of Waco, and Mrs. Mollie BENSON of Pine Bluff, Arkansas. Mon, 28 May 1917 (7-5) Mrs. Lida A. CRAIK, 79, died today at the home of her son-in-law, J. T. DAVIS, 1401 Washington St. Her funeral was to be from there tomorrow, conducted by Rev. W. P. WITSELL, Rector of St. Paul's Episcopal Church. Burial was in Marlin. She was born in Alabama and had lived in Waco for 30 years.

Mon, 28 May 1917 (10-3) Mrs. Ida Belle BRATCHER, 39, died in a Waco sanitarium on Sat, 26 May. Her funeral was today in Hillsboro. Survivors: husband Oswald Bratcher, one daughter, parents Mr. and Mrs. D. B. WHITE of Bynum, brothers George, Baxter, and Rufus White of Bynum, brother Byrom White of Lubbock, and sisters Mrs.Ola KING and Mrs. Pearl AKINS of Bynum.

Mon, 28 May 1917 (10-5) The Waco letter carriers held their annual memorial service on for deceased members in Brook Avenue Baptist Church on 27 May. They remembered Ewell ROBINSON, Dave POAGE, and Claude CARPER.

Tues, 29 May 1917 (1-6) Bill HORNSBY was killed by gunshot in Fort Worth today. His brothers were Roger Hornsby, who was a shortstop with the St. Louis Cardinals, and "Pep" Hornsby, a pitcher with the Fort Smith Club of the Western Association.

He had lived in Waco 19 years. He was a member of First Baptist Church of Waco. Survivors were his children, who were Mrs. T. H. YARBOROUGH and Miss Grace Bloodworth, both of Waco, Mrs. R. T. DEAN of Paris, Mrs. A. J. HORTON of Tyler, George B. Bloodworth of Hugo, Oklahoma, and Tom and Alvin Bloodworth of Manitou, Oklahoma. Wed, 30 May 1917 (4-3) Billie BEARDEN, a barber aged about 25, was electrocuted on 29 May in a bathtub at a boarding house in Waxahachie. He filled the tub with water, attached an electrical massager to a light socket, got in, switched it on, applied it to his body, and died. He was reared on a farm near Waxahachie.

Wed, 30 May 1917 (5-6) Eddie SPELLMAN, 6, accidentally shot and killed himself in Ennis while playing with an automatic pistol. His father was W. E. Spellman, a railway conductor. Thurs, 31 May 1917 (5-2) Richard SMITH, age 6 weeks, son of Mr. and Mrs. C. B. Smith, died at home on Oakwood St. at 11:30 last night. His funeral was at 3:00 p.m. today.

Sat, 2 June 1917 (1-2) In a tornado on 1 June, Velma HIGGINS and Mrs. John GODFREY of Love County, Oklahoma, were killed and so were five members of the WILLIAMS family at Drake in Murray County, Oklahoma.

Sat, 2 June 1917 (1-1) The dead who were identified by name from a tornado near Coalgate, Oklahoma, on 1 June were: infant child of Mr. and Mrs. M. G. TONINI, one-year-old child and eight-year-old daughter of Mr. and Mrs. J. L. COOK, Mrs. Newton BURLESON, and a child of Francis GRENHAM. Mrs. J. L. Cook and Mrs. M. G. Tonini were injured and not expected to live. At Coffeyville, Kansas, a tornado killed Dale McDONALD, 25, Mrs. J. K. LOVE, 25, and a daughter, age 11, of Chas. PETERSON.

Sat. 2 June 1917 (1-7) Mrs. Esther E. EDWARDS, 39, died today in a Waco sanitarium. Her husband, J. K. Edwards, was the steward at the County Club. Her funeral was to be tomorrow from the cottage adjoining the Country Club with burial in Park Lawn Cemetery. She moved from McKinney to Waco in 1900. Survivors: husband J. K. Edwards and four children named Marie, Thelma, Eugene, and Evelyn, mother Mrs. A. E. HARRISON, and sister Mrs. M. R. WEAVER.

Sat, 2 June 1917 (4-6) On 31 May, Mrs. M. O. STEPHENSON, a widow age 50, dropped dead from heart trouble at home, 10 miles east of Beaumont in Orange County. She was survived by three sons and five daughters. Mrs. Hannah Elizabeth GOODE, 73, of Moss Point, Mississsippi, dropped dead from apoplexy on 31 May at the home of her daughter in Beaumont, Texas. She was visiting her daughter.

Sat, 2 June 1917 (6-4) Geo. F. NEMMER, 16, died at the residence of his father, 2101 Herring Ave., at 11:25 p.m. last night, after a short illness. His funeral was to be from there at 4:00 p.m. today, with burial in Oakwood Cemetery. Survivors were his parents, Mr. and Mrs. Frank Nemmer, four sisters, and two brothers.

Sat, 2 June 1917 (6-6) Jack RYALS, age 5, died last night at Ross. His funeral was today with burial at Gholson. His parents were Mr. and Mrs. Seba Ryals.

Sat, 2 June 1917 (8-6) J. W. WALKER, Jr., 3, son of Mr. and Mrs. J. W. Walker, died at home, 505 Sherman St. in East Waco, at 3:00 p.m. yesterday. His funeral was at 11:00 a.m. today at Teague.

Sun, 3 June 1917 (4-1) Ed McDONNELL, 71, of Arlington, fell from an Interurban car in Oak Cliff on 2 June and died quickly in a Dallas sanitarium. He was a Confederate veteran and left no known relatives.

Sun, 3 June 1917 (10-2) In another report about the funeral of Esther E. (Mrs. J. K.) EDWARDS, her mother's name was shown as Mrs. A. E. GARRISON instead of Mrs. A. E. HARRISON, and there was the addition of the name of her sister, Mrs. Dow RIPLEY of California.

Sun, 3 June 1917 (14-4) S. T. CANTRELL, 72, fastened a rope around his neck and twisted it with his cane until he killed himself on the poor farm. Tues, 5 June 1917 (4-2) The bodies of Bruno HEROLD, his wife, and their two sons, aged 9 and 11, were found in their burned home, 16 miles north of Austin in Travis County. Justice of the Peace A. W. GOESDEL, of the Pflugerville precinct, investigated and declared it was murder and suicide by Bruno Herold, a farmer aged about 50.

<u>Tues, 5 June 1917 (4-2)</u> Ben DOLSON, 83, died today in Galveston. He was born in Frederickstadt, Norway, and came to Galveston in 1858. His home was on the line between Hood and Palo Pinto Counties; so, officers from both counties, carrying warrants, were trying to arrest him for wife beating, not for evading conscription. He shot first and was killed by return fire. He was buried in a rural cemetery near Midway.

Tues, 5 June 1917 (10-5) Mrs. Armanda BRAMLET, 75, died yesterday at the home of her daughter, Mrs. B. HOLLIS, 417 South 5<sup>th</sup> St. She was brought from Tennessee as a child and had lived in Waco 65 years. Her funeral was set for today from that residence, with burial in Oakwood Cemetery. She was survived by six children, who were Mrs. F. E. ASHBURN, Mrs. B. HOLLIS, Mrs. M. E. POWERS, and Miss Eva Bramlet, all of Waco, Mrs. Lois TIFORD and Mrs. Estelle WALTON of California.

Wed, 6 June 1917 (3-3) The wife of Julius MARX, 69, found him dead in bed at home, 1125 Austin St. A physician believed heart failure was the cause. His funeral was to be tomorrow morning from home, with burial in Hebrew Rest Cemetery. He was born in Rogover, Germany, and came to Waco 48 years ago. He was successful in the mercantile business. Survivors: wife, brother Simon Marx of Shreveport, Louisiana, brother Isadore Marx of Fort Worth, sister Mrs. A. BEAR of Tyler, and sister Mrs. Rachael NEUMEGEN of Fort Worth.

Wed, 6 June 1917 (5-4) Roy JONES, 17, was killed at Palestine, Texas, when he jumped into a lake, hit his head on the bottom, and broke his neck. He was head of the Juvenile Civic League. Wed, 6 June 1917 (6-4) Adrian GREEN, colored, was shot and killed last night on the Cicero GRAVES place, 6 ½ miles south of Waco on the Marlin Road. A cousin named HICKS and his wife, Emma Hicks, identified his body. Police investigated and arrested a suspect.

Wed, 6 June 1917 (6-4) Mack McCOOL, 28, a tenant farmer 15 miles south of Paris, left the field, where he was working with his employer, went into the barn, and hanged himself because he had registered for conscription the day before and was worried about having to serve in the army. He left a wife and two children.

Thurs, 7 June 1917 (1-4) Oney A. COX, a wood hauler, was killed on 6 June near Houston when a boiler on the property of Atlantic and Gulf Petroleum Co., 50 feet away from the road, exploded and crushed him. Other men nearby were slightly injured.

Sat, 9 June 1917 (1-1) The body of Lloyd KEET, age 14 months, was found in a well on the CRENSHAW farm near Springfield, Missouri. He was the son of J. Holland Keet, a wealthy banker. Suspects, in jail, said a deserted house on the Crenshaw farm was their headquarters in their plan to kidnap a wealthy jeweler.

A report on Friday, 8 June, p. 4, col. 6, said Bracchi's age was about 48 and he was in Marlin to take a program of mineral baths for his health.

Sat, 9 June 1917 (6-7) E. B. SWINNEY, a lineman for Texas Electric Co., was killed today between Elm Mott and Waco while working on a pole to repair trolley lines. He lived at Woodbury, eight miles west of Hillsboro. He was survived by his wife and parents, Mr. and Mrs. G. B. Swinney of Woodbury.

Sun, 10 June 1917 (1-6) George RECK, 9, son of Mrs. Minnie Reck, drowned in a stream seven miles northwest of Mexia on 9 June.

Sun, 10 June 1917 (1-7) On 9 June at Bartlett, Will JANKE accidentally ran over and killed his son, age 2, while backing the car out of the garage.

Mon, 11 June 1917 (5-1) Joseph E. McCULLOUGH died at he wheel of a steamer he was steering up the river on an excursion near St. Louis, Missouri. He was 72 and had been a steamboat pilot for 47 years on the Mississippi, Ohio, and Illinois Rivers. He had been an associate of Mark TWAIN.

Mon, 11 June 1917 (7-1) Miss Mamie COPELAND, 22, died today after a collision between the automobile in which she was riding and a Katy train, 20 miles north of San Antonio. The brakes of the automobile failed.

Mon, 11 June 1917 (7-1) Mrs. Charles TURNER, 22, drowned today in a San Antonio river. Survivors were her husband and two young children.

Mon, 11 June 1917 (7-7) J. W. RAMSEY, a saloonkeeper, was killed when his car skidded on the Weatherford road, seven miles west of Fort Worth.

Meek and Cleve Meek, both serving in the coast artillery, and G. A. Meek of Waco.

Wed, 22 August 1917 (12-1) Pincus LYONS, age past 80, died suddenly in New York, New York, yesterday and his funeral was there today. He lived in Waco about 40 years and moved to New York 10 years ago. In Waco, he was a member of the Lessing, Lyons, Solomon & Rosenthal wholesale dry goods firm. Survivors were his son, Wm. C. Lyons of New York, and his (Pincus') brother, Isaac Lyons of Waco.

Fri, 24 August 1917 (7-1) Mrs. Ada JENKINS, age about 30, died suddenly this morning at home, 719 North 11<sup>th</sup> St. Funeral arrangements were pending. She was active in Columbus Street Baptist Church. Survivors: her husband, who was Deputy Sheriff Lee Jenkins, one son and one daughter, mother Mrs. Sudie SIMPSON of Waco, sisters Mrs. J. W. YEAGER and Mrs. Bethel BROWN, both of Waco, sister Mrs. G. H. GRIFFIN of Robinson, sister Mrs. Walton SMITH of Wichita Falls, and three brothers named Wilborn, Freeman, and Clay Simpson. Fri, 24 August 1917 (12-3) L. P. BAIN, 24, died yesterday in an automobile wreck near Round Rock. He worked for the Southwestern Company and lived at 1007 North 15<sup>th</sup> St. in Waco. His funeral and burial were to be in his old home town of Mexia. Survivors: his wife, parents Mr. and Mrs. J. L. Bain, brothers Jim and Tolbert Bain, and sister Miss Ina Bain, all of Mexia, aunt Mrs. Myrta MOORE of Waco, and uncle Frank BURKHALTER, who was a newspaper man, formerly of Waco and now with the Houston Chronicle in Houston, Texas.

Sat, 25 August 1917 (4-3) Leroy WILLIAMS, 25, died by gunshot in a bar at Fourth and Commerce Streets in Fort Worth on 24 August. Bill DEARING surrendered and was freed on \$2,500 bond. Williams was survived by his wife, one child, and parents in Weatherford. Sat, 25 August 1917 (5-2) J. L. GARRETT, formerly a lawyer in Waco, died recently in Colorado Springs, Colorado. DUNKEN, deceased, applied to the county court in Waco to order sale of property at North 15<sup>th</sup> and McKenzie in Waco to satisfy a purchase money lien.

Sat, 25 August 1917 (6-1) V. M. PHILLIPS, 24, died after being hit by a train today on Jackson St. between South 10<sup>th</sup> and South 11<sup>th</sup>. He lived at 714 South 4<sup>th</sup> St. and worked at Geyser Ice Co. Funeral arrangements were pending. Survivors: wife, father J. H. Phillips of Waco, sister Mrs. A. H. SHEPPARD of Bakersfield, California, sister Mrs. B. BANKS of Kingsland, Texas, and brothers J. L. Phillips and Charles Phillips of Waco.

Sat, 25 August 1917 (6-2) The funeral of Mrs. Ada JENKINS was today from home, 719 North 11<sup>th</sup> St., and burial was in Oakwood Cemetery. Another sister, Mrs. Lee WEBB of Downsville, was added to the list of survivors.


Sun, 26 August 1917 (1-5) The body of Frank CRIM, age about 55, was found hanging in his barn in southwest McKinney on 25 August.

#### Kivett and Lambdin Feud in Waco in 1897

Abstracted from the <u>Hillsboro (Texas) Reporter</u> of 4 August 1897 Newspaper report submitted by Roy C. Bessire

In Waco, McLennan County, Texas on 29 July 1897, Ben F. Kivett, a house and sign painter, and his brother, Will W. Kivett, a bricklayer, both young men, rushed into the broker and commission office of C. E. TRICE & Co.in the Pacific Hotel and attacked William McK. Lambdin, a Western Union Telegraph operator. Lambdin defended himself with a double barrel shotgun. His first shot passed through the screen door of the broker's office, killed Ben Kivett, and ended up in the woodwork of the dining room of the hotel where customers were dining. The second shot wounded Will Kivett and lodged in the dining room door. Will rushed at Lambdin and shot at his head, but Lambdin pushed the revolver out of the way. Lambdin put down the shotgun, drew his pistol, and took one fatal shot at Will. Lambdin's wounds were a scraped finger, from holding the muzzle of Will's revolver to avoid being shot, and inflammation of the eyes from powder burns. Lambdin was arrested. He was freed shortly. While recuperating from his wounds, he was at his father's residence on Austin Avenue, visiting his many friends who came to congratulate him upon his narrow escape from death.

The animosity began three years ago when Sam JONES, a well known Methodist preacher, was conducting a revival in Waco. The disagreement was a matter of common gossip in Waco, although the details were not known to the public. It was patched up, then broke out again, then was resolved again, and there was said to be a recent final settlement, as the Kivett brothers intended to leave Waco. Instead, they broke the truce. Before they attacked, they told some friends that they knew Lambdin was a trained marksman and, by double teaming, they hoped to take his life at the expense of, they hoped, only one of theirs.

Among the survivors were the widow and children of Ben Kivett, of DeLeon, and the surviving brother, Walter R. Kivett, a business man of Waco. Will Kivett was a bachelor. Walter had tried, unsuccessfully, to be a peacemaker.

The bodies were kept on ice and were viewed by the public through a plate of glass in a chapel for an hour or two before their funeral, then they were taken to Oakwood Cemetery in two hearses and buried in the same grave.
