## LETTER OF TRANSMITTAL

WAR DEPARTMENT,

*Washington, December 6, 1929.*

The SPEAKER OF THE HOUSE OF REPRESENTATIVES.

SIR: Pursuant to the directions contained in section 3 of the act of Congress approved March 2, 1929, entitled "An act to enable the mothers and widows of the deceased soldiers, sailors, and marines of the American forces now interred in the cemeteries of Europe to make a pilgrimage to these cemeteries," an investigation was made for the purpose of determining (1) the total number of mothers and widows entitled to make the pilgrimages, (2) the number of such mothers and widows who desire to make the pilgrimages, (3) the number who desire to make the pilgrimages during the calendar year 1930, and (4) the probable cost of the pilgrimages to be made.

In making this investigation an effort was made to locate all of the mothers and widows who are entitled to the benefits of the act and to ascertain their wishes. Letters were written to the relative or person who authorized the burial in the cemeteries of Europe of each deceased soldier, sailor, and marine now interred in Europe, requesting information as to the name and address of the mother or widow if there be such. Approximately 40 per cent of these letters were returned by the post-office officials, due to the fact that they could not be delivered. All of these cases were then referred to the Veterans' Bureau and the names of the persons who are drawing the adjusted compensation or insurance were obtained and letters written to them. In addition to the efforts of the War Department to locate all the beneficiaries of the act, chapters and posts of veteran associations and other patriotic societies, as well as many individuals and the press, have been active in disseminating information regarding the pilgrimages, so that it seems reasonable to believe that the matter has been brought to the attention of all persons who are entitled to the benefits of the act.

Replies have not yet been received to all letters sent out, and in many cases the replies indicate that the mothers and widows who are entitled to make the pilgrimages are uncertain as to whether they desire to make the pilgrimage and as to the time when they desire to make it. This will necessarily result in changes being made in the results of the investigation as submitted in this report.

On November 15, 1929, the investigation showed the following results:

- (1) Total number of mothers and widows entitled to make the pilgrimages, 11,440.
- (2) Number of such mothers and widows who desire to make the pilgrimages, 6,730.
- (3) Number of such mothers and widows who desire to make the pilgrimages during the calendar year 1930, 5,323.
- (4) Probable cost of the pilgrimages to be made, \$5,653,200.

In arriving at the probable cost of the pilgrimages to be made, consideration was given to the fact that the pilgrimages are to be made at the expense of the United States under the conditions set forth in section 2 of the act. The result reported above is the estimate of the probable cost of all pilgrimages, regardless of the year in which they are made. It is based on an estimate that 6,730 women will make the pilgrimages, at an estimated cost of 1840 each. An estimate of the funds required for the conduct of the pilgrimages during the fiscal years 1930 and 1931 has been prepared and will be submitted through the Director of the Bureau of the Budget to Congress.

For the convenience of the Congress, a list as of November 15, 1929, showing the names and addresses of the mothers and widows who are entitled to make the pilgrimages is inclosed herewith. This list is classified to show those who definitely desire, or do not desire, to make the pilgrimage, those who desire to make it in 1930, those who desire to make it at some later time, and those who have not definitely decided whether or not they desire to make the pilgrimage. For easy reference the names are arranged on the list by States and counties.

A copy of this report has been furnished the President of the Senate.

In the column headed "Later," "Yes" indicates those who have expressed the desire to make the pilgrimage in the calendar years 1931, 1932, or 1933, as well as those who have expressed a desire to make the pilgrimage but have not specified the year; "No" indicates those who have stated they do not care to make the pilgrimage; and (\*) "Unknown" indicates those who, although eligible, have not stated whether they desire to make the pilgrimage or not.

# Records Lost In Virginia Cos.

The compiler of this article writes the following: "I have been taking *The Genealogical Helper* since 1962 have found much useful information of benefit to my research efforts. When I made a recent research trip into the southern states, I came across some data furnished by the clerks of the 140 Virginia courts of record in reply to a questionnaire of 1 April 1929 regarding fire safety and vault safety in these locations. It was entitled 'Virginia Local Public Records: Housing Conditions in the Offices of the Clerks of County and City Courts of Record, 1929' I have extracted from that report the records in these county locations which were reported as being lost, stolen or destroyed, and have enclosed the information with this letter. I obtained this report from the Virginia State Archives at Richmond, Virginia, and believe it would be a valuable document to your readers who are interested in Virginia records."

The counties are listed first followed by the records which were reported lost, stolen or destroyed.

Amherst: Court Order Books covering Revolutionary period were destroyed or stolen during the Civil War.

Appomattox: A fire in 1892 destroyed all records except old land tax books which were outside the courthouse being bound at the time.

Bath: Some of the early marriage records are missing and probably lost during the Civil War.

Buckingham: All records were destroyed in a fire in 1869.

Caroline: Most records prior to 1836 were destroyed during the Civil War.

Charles City: Record losses occurred during the war and due to theft: 3 Deed Books, several Order Books, marriage bonds, and other valuable papers (not itemized).

Chesterfield: One Marriage Register and loose court papers lost during the Civil War.

Clarke: Leaves cut out of several books during the war and some papers lost.

Craig: Records up to 1865 were practically destroyed by vandalism of Federal soldiers. Deed Book A and the marriage record were totally destroyed.

Culpeper: Some books and papers lost during the Civil War (not itemized).

Dinwiddie: Records prior to 1833 were destroyed in 1864 by war.

Elizabeth City: Nearly all records prior to the Civil War were either destroyed or removed by vandals during the war period when citizens evacuated Hampton.

Fairfax: A good many old records were destroyed during the Civil War (not itemized).

Gloucester: All records lost during Civil War at Richmond, where they had been taken for safekeeping.

Greene: Deed Book No. 1 was taken during the Civil War.

Hanover: All records were lost at Richmond during the Civil War, where they had been taken for safekeeping.

Henrico: All of the Circuit Court records were destroyed in 1865. Many other records were destroyed during Arnold's raid in the Revolution.

Isle of Wight: Some records were lost during the Revolution.

James City: All records were lost at Richmond during the Civil War, where they had been taken for safekeeping.

King and Queen: All records were lost during fires in 1828 and in 1865.

King George: One Will Book, Marriage Register, and Order Book were taken away during the Civil War.

King William: All records lost in fire in 1885 except parts of 17 deed books.

Lee: Fire in 1863 caused loss of one old marriage book.

Louisa: One Order Book lost at Richmond during the Civil War.

Matthews: All records lost at Richmond during the Civil War, where they had been taken for safekeeping.

Mecklenburg: A few records were lost at New London where they had been taken during the Revolutionary War.

Middlesex: Some deed books and court orders were lost during the 1700\*s.

Nansemond: All records were lost during fires in 1734 and 1866.

New Kent: All records were destroyed in 1865, allegedly by Confederate soldiers.

Northumberland: Some records were destroyed by fire in 1710.

Nottoway: Most records were destroyed in 1865 by the Federal Army.

Prince Edward: Marriage records (1754-1776) are missing from unknown causes.

Prince George: A record book (not identified) was destroyed during the Civil War.

Prince William: Sixteen deed books are missing and many pages are out of some others: five will books are missing and pages are out of some others; many other records are either lost, destroyed or stolen.

Rockingham: Deed and Will books were destroyed during the Civil War while being transported to protect them from the enemy.

Russell: All files and one marriage register were destroyed by fire about 1872.

Stafford: Many books were lost during the Civil War.

Surry: One Deed Book was lost during the Civil War that for period 1834-1839: Court order books from 1719-1740 are missing.

Warwick: All records destroyed during the Civil War.

Washington: Minute books from 1787-1819 were destroyed by fire in 1864 along with all files stored in file cases.

Westmoreland: One order book for the period of 10 years before the Revolution (1776) was destroyed or lost.
